1.0 Sports Concerns:

1.1 Boys Soccer Head to Head Goal Differential

The following criteria are used to break ties for teams with identical power ratings:

If teams have identical power ratings, the following criteria will be used to break the tie:

- a. The team with the most league/division wins will be the higher seeded team. If still tied:
- b. The team with the fewest league/division losses will be the higher seeded team. If still tied:
- c. The team with the higher winning percentage of games scheduled will be the higher seeded team.

 Determined by total league/division wins divided by total league/division games scheduled. If still tied:
- d. If teams are in the same league/division, use head-to-head results. If still tied:
- e. A toss of a coin will determine the higher seeded team.

The Boys Soccer Committee is requesting head to head goal differential be added to the criteria used to break ties for teams with identical power ratings. The request would only impact the teams tied, when playing against each other.

Motion to not approve Gary Neunder as assigner of Group #5 for any contests in the sports of Baseball and Softball directly or indirectly that involve schools represented by the Agreement approved between the Western New York Sports Officials and the member schools of Section VI effective immediately.

As a result, it was decided and agreed upon by the representatives of the involved Section VI Leagues and the Monsignor Martin Athletic Association to conduct the assignment of Baseball and Softball officials in an auto-assign format for the entire spring regular season. The release of assignments is expected in early March.
