The "School of Distinction" award is the highest award handed out in the Scholar-Athlete program and is in its fourth year of existence. NYSPHSAA announced that three Section VI schools have achieved the status of Scholar-Athlete "School of Distinction" for 2005-06: Albion, Clarence, and Williamsville East. They earned the award by having 100% of their varsity sports teams earn above a 90.0% grade point average. Albion sponsors 17 interscholastic varsity sports, while Clarence and Williamsville East both sponsor 29. Walter Eaton, NYSPHSAA Assistant Director, presented the awards to representatives from the three schools at the Section VI Athletic Council meeting, Wed. Sept. 20 at Erie 1 **BOCES** Education Campus in West Seneca. The purpose of the "School of Distinction" award is to unite varsity coaches in challenging their teams to achieve a statewide honor in addition to the already established Scholar-Athlete Team Award which was initiated in 1991-1992 school vear.

STRUCTURE & POLICY REVIEW COMMITTEE

The Ad Hoc Committee will be meeting on October 5th to review all aspects of the NYSPHSAA. Please contact your representatives prior to their next meeting which is scheduled for November 29, 2006 with any suggestions you may have so that we may provide the very best opportunities for our student athletes.

EXECUTIVE COMMITTEE -

October 30, 2006

The following items were approved:

2007-2008 DUES INCREASE - The NYSPHSAA dues will be increased by \$50 per school district (\$750.00) and 5 cents per student (80 cents).

Wrestling - The use of the Communicable Skin Disease Form for the 2006-2007 season. In addition, wrestlers with oral braces are required to wear a mouth guard covering the braces. Approved for the 2007-2008 season: 22 Points for the individual wrestler and multiple entries in tournaments.

BASKETBALL CHAMPIONSHIPS 2008

The dates for the NYSPHSAA Girls and Boys Basketball Tournament will be March 14-16, 2008.

GIRLS LACROSSE - A waiver for the 2007 season to permit the wearing of uniforms that do not meet the new numbering requirement. Be advised that for the 2008 season uniforms will be required to have 6" numbers on the front and 8" numbers on the back and centrally on the uniform.

CROSS COUNTRY - A variation in classification numbers for two years, beginning in the 2007-2008 school year. AA 1083 and above, A 712-1082, B 468-711,C 290-467 and D 289 and below.

TRANSFER LANGUAGE - "Students who transfer from any school may enroll in the public school district of their residence or private school within that district's boundaries shall be exempt from the Transfer Rule. Such a transfer without penalty will only be permitted once in a high school career. (change in italics) Under Exemptions of the Transfer Rule - "A student of a military employee who is transferred to an active

military base may enroll in the non-public school closest to their residence and maintain eligibility if the student enrolls in a nonpublic school immediately following the change in residence."

CONFERENCE –

Eligibility and Standards

Once again the NYSPHSAA and NYSAAA are partnering to organize a two-day conference scheduled for November 27-28, 2006 at the Holiday Inn – Turf, Albany. The NYSAAA will be offering NIAAA Leadership Training Courses on November 27th. On November 28th the NYSPHSAA will conduct a seminar on rules, regulations and eligibility designed for athletic administrators and sports coordinators. A more detailed brochure will be mailed this month.

FUTURE RULE CHANGES

Boys Lacrosse - In 2008 all jerseys shall be of a single, solid color with specific trim specifications (NFHS rule 1-9-1). **Wrestling** - A wrestler caught cheating on the hydration test will be an ineligible wrestler for the remainder of the season.

Coaching Certification Courses on line - an asynchronous web-based program. Go to www.cortland.edu/physed for registration information.

STATE WEBSITE

The Association has now completed its transition away from iHigh to host all of its sports information. All NYSPHSAA championship schedules, results, records, and news will now be hosted on nysphsaa.org and we will no longer be using iHigh's website services. Each year, the New York State Public High School Athletic Association recognizes individuals for their outstanding contribution to high school athletics in the categories of administrator, coach, athlete, official and contributor, by inducting them into the NYSPHSAA Hall of Fame. All nominations must receive the endorsement of the Section and be received by the NYSPHSAA by December 15th.

We've seen successful high school athletic careers lead to successful collegiate and professional careers......we've witnessed coaches amass won-loss records which seem insurmountable by today's competitions. The 2007 honorees selected will be inducted into the NYSPHSAA Hall of Fame at the annual meeting in August of 2007.

Section VI loses a Veteran and **Good Friend**

George R. Gardner, a long-time Section VI Veteran and Annual Veteran's Golf-outing Chairman, passed away October 4, 2006.

Mr. George Gardner served the Maryvale School District from 1951 to 1982 where he was the first to coach varsity football, basketball, and baseball. George was also the first male physical education teacher and the first director of athletics.



Additionally, he served the district as vice principal of the high school.

Along with Dr. Samuel Bennett, Mr. Gardner planned and designed the track, football stadium, soccer fields, baseball diamonds, and the three-hole golf course. He also worked with the school architect in planning the indoor physical education facilities in the primary and high school building.

George was indeed a "Maryvale Man," and expressed great satisfaction in laying the ground work for Maryvale's fine athletic program. In fact, he and his students were responsible for choosing the Maryvale maroon and white school colors as well as coming up with the name "Flyers". As a result of his many contributions towards the fine Maryvale Tradition, Mr. Gardner was inducted into the Maryvale Athletic Wall of Fame in 1997.

The New York State Education department invited Mr. Gardner to serve on physical education and recreational panels. He was also invited to serve on a similar panel in Washington, DC.

The sports world has indeed lost a true pioneer in the world of high school sports. The many athletes that have been touched by him, thank him. May he rest in peace. George is also pictured in the Veterans Dinner photo above (back row far right).



Transportation Policy Reminder

The following recommendations of the Transportation Committee were approved by the Section VI Athletic Council in May 2006 as a two-year experiment:

TRANSPORTATION POLICY*

Team Sports:

- Schools will make their own arrangements for transportation for their athletes involved in state competition in <u>team</u> <u>sports.</u>
- 2. Section VI will be financially responsible for transportation costs as follows:
- \$3.50 per mile on the grid. \$1.00 of this amount is the state reimbursement to the section for bus costs and \$2.50 is the portion the Section will finance.
- Bus layover: A flat fee of \$350.00 per night per additional game played. This amount will be applied towards the total cost related to a required bus layover. This fee will not be paid unless the additional night stay is required for additional competitions for the state. championship. The fee will be adjusted if the required layover is on Long Island.
- Districts will be reimbursed for transportation costs incurred by the district as per the formula in item 2.

Individual sports:

- Section VI will make the arrangements for transportation for all athletes involved in state competition in <u>individual</u> <u>sports.</u>
- 2. Section VI will be financially responsible for transportation costs as follows:
- \$3.50 per mile on the grid. \$1.00 of this amount is the state reimbursement to the section for bus costs and \$2.50 is the portion the Section will finance.
- Bus trip requiring more than one night stay: A flat fee of \$350.00 will be paid for by the Section if the trip requires more than one night. This amount will be applied towards the total bus cost. The fee will be adjusted if the trip is to Long Island.
- 3. The Section will back-bill the schools for the following:
- The difference between total transportation costs and the amount the Section will finance (as per the formula in item 2).
- The costs of meals for the athletes (as it has in the past).
- The amount to be back-billed will be calculated per athlete competing for each district.

LODGING

Section VI will remain financially responsible for lodging at state competitions as per the established policy.

MEALS

Districts will remain financially responsible for all meals at state competitions as per the established policy*

Annual Classification of Schools: BEDS Reporting

As per NYSPHSAA Executive Committee action in January 2003, the Section VI office is collecting the BEDS numbers from each member school. They will be reviewed for accuracy and filed electronically by the Section office with the state association. Each Athletic Director has been requested to submit to the Section VI office, a copy of the actual BEDS Building Report Form (page 3) that was sent to SED. This information will be used by NYSPHSSA to calculate the classification of member schools for athletic purposes. It will also be used by the Section VI Football Committee for class projections.

Also note that because, for athletic classification purposes, we must count ALL students in ALL buildings housing grades 9-11 and ungraded, an *Addendum for Enrollment Numbers* must be completed for each adjustment made to a school building's reported enrollment numbers. Please review the memo recently distributed by the Section office and submit the Classification Addendum if you have a shared services situation.

Centralized Payment of Sports Officials

The program launched by Erie I BOCES in cooperation with Section VI for centralized payment of sports officials by Erie I BOCES in September 2005 has moved into its second year of operation. Officials for girls soccer, boys soccer, field hockey and cross country receive one paycheck from Erie I BOCES for all contests/meets worked in participating districts

within a monthly pay period. The web-based software approved by the Section to facilitate this program is League Minder. The program will continue for payment of boys and girls basketball officials in the winter and then boys and girls lacrosse and track officials in the spring.

Though the program has operated successfully, it is not meeting the needs of all Section VI member schools. For the winter season, the ECIC is using TheArbiter to assign officials. The Section is currently investigating TheArbiter as the program to handle the Central Management of Officials. During this time of transition, all winter officials are requested to not only register on-line with LeagueMinder as required by a Section Athletic Council decision in May 2005, but also to register with TheArbiter and **keep their availabilities up-to-date in both**. This will assist with the assigning of all officials that are shared by multiple leagues.

Section VI extends its gratitude to all sports officials and to the participating districts for their cooperation with this program for Central Management of Sports officials. It was developed not only to ensure payment of officials in a timely, efficient and cost effective manner but also to maintain compliance of sports officials with SAVE legislation across the Section.

Sportsmanship:

Winter sports are upon us!! Boys and Girls Basketball are reminded that they will be paid for all games worked at the participating districts* by Erie 1 BOCES (through LeagueMinder) as part of the Central Payment of Officials program for 2006-07. (see article on page 5). Indoor Track Officials will be paid for all meets in this manner as well. This requires each official to go online to the Section 6 website to register with League Minder AND submit to the Section office a W9 form. Complete instructions are on the website.

Go to www.section6.wnyric.org.......click on *Officials*.....scan down to Registration with League Minder. Any official without a computer or email address can call the Section office: Cindy 821-7365 or Pauline 821-7581 and be registered over the phone. Thank you for your prompt cooperation with this program adopted to ensure payment of officials in a timely, efficient and

cost effective manner and to protect social security numbers from identity theft.

Also Note:

Since LeagueMinder is currently not meeting the needs for all Section VI member school as was anticipated, the ECIC is using TheArbiter for assigning officials. For this time of transition, we request that all boys and girls basketball officials also register with TheArbiter and keep their availability up-to-date in EACH system.
