being duly sworn, depose and say:

- 1) I am seeking to provide service as an interscholastic sports official with member schools of Section VI of the New York State Public High School Athletic Association, Inc. (Section VI).

- 2) I understand and agree that my service is subject to a fingerprint supported criminal history background check by the State Education Department (SED). As a condition of my commencing service with the Section VI member schools, Section VI must first receive notification from the Commissioner of Education that I have been “cleared” for service based upon the results of my criminal history background check.

- 3) I acknowledge that Erie 1 BOCES is assisting Section VI with this background check by serving as the entity that will receive notice of whether clearance is granted or denied by SED. I further acknowledge that Erie 1 BOCES will also be notified of any subsequent criminal history information, such as subsequent arrests. I understand that Erie 1 BOCES will take no action on this information other than to forward any and all notices it receives to Section VI.

- 4) I understand that if Section VI receives notice (through Erie 1 BOCES) that clearance has been DENIED, I will not commence service with the Section VI member schools as a sports official. I further understand that, even if clearance is GRANTED, but Section VI receives notice (through Erie 1 BOCES) of a subsequent criminal arrest or conviction, my service with Section VI member schools may be terminated at that time. * I acknowledge that Erie 1 BOCES will have no role in any such determination made.

- 5) I consent to Erie 1 BOCES receiving and forwarding to Section VI any information it may receive from SED pertaining to my criminal history background check, including but not limited to notices of granting or denial of clearance for service and subsequent arrest information. I agree to indemnify and hold Erie 1 BOCES and Section VI harmless from and against any and all losses, damages, liabilities, expenses (including attorneys fees), costs, claims or causes of action it may sustain as a result of (including but not limited to) Erie 1 BOCES’ receipt and further disclosure of clearance information.
