1.7 Girls Volleyball Web-site Request

The chair for girls volleyball has expressed interest in the creation of a girls volleyball web-site. Note: \$500 is the cap for web-site allocation per sport. A web-master to develop and maintain uniform web-sites for all sports involved was researched. It was concluded, however, that the cost was too great to retain this service and the Section should remain with its current procedure.

- 2.0 Sectional Championship Venues
 - 2.1 Wrestling

The University at Buffalo has expressed interest in hosting the Section VI wrestling large and small school sectional finals. Sunday, February 10th, 2013 would be an option, as to not interfere with basketball. UB has assured affordability. Section VI is awaiting a formal written proposal from UB.

- 2.2 NCCC Proposal:
 - a) Sunshine Park (West Seneca) has been secured as the site for softball sectionals.
 - Responsible parties will be contacted to explore the option of NCCC as the site for baseball sectionals.
- 3.0 Old Business:
 - 3.1 BOCES Payment of Officials-Buffalo Public Schools Pilot Program:
 - Section VI is reviewing a possible pilot/partnership with the Buffalo public schools; assisting them with the process of payment for sports officials. T. Slade to meet with the Buffalo public schools business official regarding the matter. Updates will be provided as available.
 - 3.2 Corporate Sponsorship:
 - a) Amount received: 2011-2012 \$19,000
 - b) Toth Sporting Goods has agreed to donate \$350 to Section VI for the September 19th, 2012 Athletic Council luncheon. Toth will attend the athletic council meeting for a brief presentation.
 - c) Spaulding Additional proposal of \$15,000 for football, baseball, & volleyball.
 - This proposal would take effect for the 2013-2014 school year. Ultimately, this allows the Section to continue to enhance the Dedicated Fund for State Competition.

3.3 Walkie Talkies

 - A review of form X submissions has revealed a significantly reduced number of submissions.

- 4.0 New Business
 - 4.1 2012-2013 Awards Bid won by Trophies Trophies in the amount of \$18,076.75
 - The bidding process has significantly reduced costs
 - Proven cost savings when compared to previous purchases, the amount of product acquired has increased while costs have decreased (by approx. \$5000).
 - 4.2 The 2012-2013 transportation bid was won by Grand Tours (\$14,066) and Bedore Tours Inc. (\$13,775) totaling \$27,841.00.
 - 4.3 The athletic trainers RFP for 2012-2013 is \$20,000 (slight increase from previous year).
 - 4.4 The 2013-2014 budget will be available for review at the October 25th finance committee meeting.
 4.5 Purchase of New Computer:
 - A quote was reviewed and approved for the purchase of a new computer for the Section VI office.
 - 4.6 Ithaca is the current site for the girls swim states. As a result, transportation costs will increase.
