# 1.0 Sports Concerns:

1.1 Football Scheduling

The following items were approved at the April 7, 2016 Section VI Athletic Council meeting:

- 2.1 The athletic council voted in support (21-5) of the combined schools committee to deny the merger of the Maple Grove (Bemus Point) and Chautauqua Lake School Districts for JV and Varsity football in the C Classification for 2016.
- 2.2 The athletic council voted in support (22-4) of the combined schools committee to deny the merger of Bennett, MEC, East, and Olmsted for JV and Varsity football in the B Classification for 2016.

The Chautauqua Lake and Maple Grove (Bemus Point) Schools Districts have filed an appeal with the NYSPHSAA. The tentative appeal hearing is scheduled for Monday, April 25, 2016.

Buffalo Public Schools has expressed their intent to appeal to the NYSPHSAA, but no formal appeal has been submitted at this time.

During the April 7<sup>th</sup>, 2016 Section VI Athletic Council meeting, it was stated that based on the athletic council's decision, and regardless of possible appeals to the NYSPHSAA, the football scheduling process will move forward. A preliminary schedule is in place, but cannot be released until the outcome of the aforementioned appeal(s).

#### 1.2 Boys Volleyball Class B

The Boys Volleyball Committee, as part of their 2016 pre-season report, is proposing to split Division 2 into 2 separate divisions of 10 teams each, based on classification numbers. The D2A sectional champion will play the D2B sectional champion to see who moves on to the Regional Championship. This proposal is now irrelevant due to the approval of the splitting of classifications policy at the April 7, Section VI Athletic Council meeting.
