Report on changes in Policy or Practice that were implemented

The coaches continue to appreciate the NEW sportsmanship policy re: 3 yellow cards starting back to zero for sectional play thru the state final tournament game. Our section accumulated 256 Yellows and 33 Reds. We rank #1 in NYS cards per contest ([Section VI is rated 4th out of the 11 Sections in the least amount of yellow/red cards issued during the regular season](#)). The coaches continue to like the neutral sites for Semi's and Finals and the new SELECT ROYAL ball used for the semis and finals.

Problems encountered/ concerns

1. We realized there was a conflict with girls sectional dates the morning of the seeding mtg. C Durr and I discussed and moved the AA and B boys to avoid conflicts.
2. An idea that was discussed to sit down with Timm Slade and Chris Durr to discuss sectional dates for next year to avoid conflicts.
3. Need to come up with a clear process to report Y/R cards. The website helps but not sure coaches are in 100% compliance.
4. Need to discuss consequences for schools/coaches who don't input info on the website. They input W-L-T but not individual stats.
5. A couple of Select soccer balls did not accept air so we were short 2 balls to pass along to the winners....were wondering if we could get 2-3 extra to have just in case this occurs?
6. A few administrators from E-Ville, N Collins, P Valley and W Valley inquired if ALL 4 games (2 boys and 2 girls) could be played at Dunkirk because they had mutual opponents. J Graczyk at Pioneer graciously agreed to give up the 2 boys Semi and was promised to host ALL 4 games next year.
