Having the hotel and meals paid for by the Section VI office seemed to go over well with coaches and players again.

Some of the CCAA parents suggested that the Section VI qualifiers take a Coach bus to the State Tournament so that they feel more like a team.

Problems encountered/ concerns

Sectionals – Tournament ran smoothly – Viewing of the courts continues to be an issue for a few parents who had players on courts that were further away. It was suggested to me by a parent that we once again reconsider the Miller Tennis Center because of their viewing and convenience of having food and space available.

States - As noted in the last 2 year's reports, a few parents again complained about the lack of viewing and not having all of the courts available at Tri-City. There was talk about next year's tournament possibly being pushed back a week due to Halloween being on Saturday (Day 1 of the tournament). As the contract is up with Tri-City, the State is now taking bids on a location for next year.
