1.3 Modified Soccer - Two 30-Minute Halves

At the July 2019, the NYSPHSAA approved going from four 15-minute quarters to two 40-minutes halves to start with the 2020 fall season. Section VI will pilot two 30-minute halves for the 2019 season, sectionwide. Section VI will negotiate a memorandum of agreement with officials regarding the rate of pay.

## 6.1 Unified "Scholar Athlete"

Unified Basketball and Unified Bowling were added to the NYSPHSAA Scholar-Athlete Program effective the 2019-2020 school year. As an official high school program of NYSPHSAA, the Unified teams should be recognized in the Scholar-Athlete program if they meet the same criteria as other interscholastic programs in the school.

#### 6.2 Section VI Winter Coaches Meeting

## 6.3 Girls Bowling Chairman Vacancy

# 6.4 Website Fee

Currently, Section VI absorbs the cost of its sports website fees. In order to stay solvent and continue in the manner of financially supporting state championships, a website fee will be proposed at the September 5, 2019 Finance Committee meeting. Implementation will be requested for the 20-21 school year.

#### 6.6 Boys Lacrosse

Concern was presented regarding the title of the Boys Lacrosse "All Section VI Team". A request was made to ask the Boys Lacrosse Committee to remove "Section VI" from the title. Independent schools' student-athletes cannot be named to the All Section VI Team. Therefore, the question of how a school with an independent schedule can win a Section Title, but its student-athletes be excluded from selection to the "All Section VI Team" was raised.

#### 6.7 Charter Schools

Health Sciences and Tapestry, have applied for league placement for the 20-21 school year. If denied, Section VI will be required to place them in a league.
