1. All Coaches in Section VI will continue to be required to maintain accurate match results online on the given website.
2. We would like to hold our Section 6 tournament in the Northtowns on October 20<sup>th</sup> and 21<sup>st</sup>. The Village Glen and the Miller Tennis Center are both interested in hosting the event and are currently putting together bids. Tentative start times are 12PM on Friday and 3PM on Saturday.
3. I would like to discuss the possibility of playing regular scoring on day 1 of the sectional tournament with the league chairpersons so that our format matches the State Tournament.
4. The State tournament will be held October 28<sup>th</sup> – October 30<sup>th</sup> in Latham, NY. I have already secured a block of 10 rooms at the Century House, Latham for 2 nights beginning Oct. 27<sup>th</sup> and check out on October 29<sup>th</sup>. This is the same location as in 2015. A free full breakfast will be included in the \$94/night rate.
5. The transportation/meal/hotel policy worked out very well and I would again recommend continuing with this policy for next year.
6. The State committee seeding meeting at the State Tournament will be held on Friday October 27<sup>th</sup>.
7. Predetermined match start times will be used for the state tournament.
