## VI. Frank Marotta / - (NYS Officials)

- a. Presentation of officials for 2017 NYS Tournament.  
Chairmen were emailed the list of officials that were chosen for the tournament just prior to the conference call. Frank Marotta presented the list to the committee.  
Mike Debarbieri-6 and Bill Kays-3 were observers from the NYSWC at the selection meeting. **Motion to accept slate of officials approved unanimously.**

Any head coach at the state tournament can complete and turned in to their sectional Chairmen who will in turn submit to Frank Marotta for input for next season. If a coach would like to attach a video of the incident when they submit the evaluation form they may do so. Forms will be available at the head table.

## VII. TrackWrestling Reporting Updates:

- a. The document: TrackWrestling-DataEntry-16 was emailed for state distribution. It contained detailed instructions on how to use the TrackWrestling site for setting up your team. **A follow-up document that will include sections for entering results and printing out post-season forms will be sent prior to the start of post-season.**

## VIII. Handbook Committee Report: (Marty Sherman / Jeff Cuiilty-9, Frank Marotta)

As situations not currently addressed in the handbook arise throughout the season they are being collected and written up for inclusion in next year's handbook. Please forward any items for consideration to Marty Sherman or Jeff Cuiilty as they come up.

### **For Discussion for additions to Handbook for 2017-18:**

- a. **Round robin Individual Tournament:** If there are only 2 wrestlers entered at a weight class they allowed to wrestle best 2 out of 3 and record all matches wrestled in Track.
- b. **Wrestling Forfeitures:**

Note: Beginning with the 2013-14 Season: A forfeit will no longer be counted in the count of tournament matches wrestled in a day. In an individually bracketed tournament, a wrestler can compete in a 6<sup>th</sup> bout in a day if one of the previous bouts was a forfeit.

If the forfeit was received in a dual meet tournament and an exhibition bout is set up as the 6<sup>th</sup> bout of the day, **then no additional points will be charged to wrestlers who compete in exhibition matches**

In a round robin tournament if a wrestler has 1 forfeit, they could wrestle a 6<sup>th</sup> bout. Is it assumed that if they have 2 forfeits, they can wrestle 2 additional matches? 3 forfeits = 3 additional matches?

**Recording results: You are only allowed to record 5 matches in a day as wins/losses? The wins by forfeit are the matches that should be recorded in Track and the total matches should not exceed 5. The additional matches (which could have been at one weight above the weigh-in weight class) should not be recorded in Track as Varsity matches for either participant. They could be entered as JV or Exhibition but they cannot appear on the Varsity record.**

- c. Wrestling Forfeitures effect on points in a Dual Meet Tournament: Even though it states above that “**no additional points will be charged to wrestlers who compete in exhibition matches**”. This refers to wrestlers already competing in the tournament. **If an “extra wrestler” is weighed in on a dual meet roster and they participate in just one exhibition match, they are charged 2 points and charged for a tournament.**
- d. Multi Team Meets: Even though, currently the Mutli Team meets are listed under the Dual Meet section of the handbook and not the tournament section: - **“A Multi Team meet does not count as a tournament.”** will be added to the handbook for clarification. In addition since these are a form of a dual meet, **an honor weigh-in can be done when they occur on a school day.**
- e. Weight allowances could prohibit a wrestler from being able to go up one weight class from the weigh-in weight: Example: Due to the growth allowance and back to back matches, a weight class is at +4 (145+4=149). If a wrestler is certified at a weight (148) in between the Growth Allowance weight (145+2=147) and the weight class that day due to the additional pounds (149) and they actually weigh 148.5, (which is less than the weight class that day 149), they are actually weighing in at the 147 wt class, (which is a weight they are not certified to wrestle at). Therefore, they must go up one weight to 152+4=159. They cannot move up to 160+4=164 as that would be going up to weight classes from where they weighed in at. If they were to wrestle at either 145+4=149, or if they were to wrestle up two weight classes at 160+4=164, they would be considered ineligible. **Discussion for spring meeting: If back to back tournaments (which basically can only take place over Christmas break) are disallowed that might eliminate the situation above. Yet after Christmas, a team could possibly have a dual meet on a Wednesday (+2) and a Thursday (+3), and then enter a 2-day dual meet tournament on Friday and Saturday, which would present the same problem as the dual meet tournament would be at +4 both days.**

- g. As per Sept 2014 “Premier” wrestlers from CHSAA, PSAL and D2-Sections 7,8,or 10 can apply for At-Large berths and will be identified as follows:  
 1-They placed 2<sup>nd</sup> in their Section for the current season.  
 2-They had 5 or less total losses on their final record (including post-season)  
 3-They had 25 or more wins than losses on their final record (including post-season)

## 2017 Tournament formula for “At Large” Qualifiers (Jeff Culty)-continued

- h. **Chairmen will receive their Sectional At-Large Reporting forms for At-Large qualifiers within the next few weeks.**

Reminder: In the possible event where **the #3 place-winner from a Section earns more points than the #2** place-winner from the same Section, the following procedure will apply:

- 1- If the **#3 wrestler, did not lose to the #2 wrestler at the Sectional Tournament**, no changes are needed and #3 earns the “At Large” ahead of #2.(unless they met during the season where Item #3 below will then apply)
- 2- If the **#3 wrestler, lost to the #2 wrestler at the Sectional Tournament**, they will not be able to go ahead of #2 (even though they have more points than #2) unless #2 “carries #3 along with them: In this situation, if #2 happens to already have enough points to be one of the four “At Large’s” (as does #3) then they both can go. If #2 did not accumulate enough points to be one of the four “At Large’s”, then #3 will be removed from consideration (even though they have enough points). The next highest point earner will take the spot of the #3 wrestler just removed.
- 3- If #2 and #3 met at the Sectional tournament, then Item 2 above applies. But **if #2 did not face #3 at the Sectional tournament, but #2 did have a head to head advantage over #3 (from matches during the season)**, than this head to head advantage blocks #3 from going ahead of #2 for an At-Large berth, (even though #3 may have had more points than #2).

To help track the data needed for Tie-breaker #3- The following columns appear on the Sectional At-Large reporting form:

**ANSWER Y/N: DID #2 BEAT #3 AT SECTIONALS?**

**and:**

**ANSWER Y/N: DOES #2 HAVE H2H ADV OVER #3 FROM IN-SEASON?**

**The person in charge of completing the Sections At-Large report form will need to get this info from the coaches of all the Sectional runner ups before submitting their forms.**

- i. **NYS Points and Weight Tracking Form-16-17 spreadsheet** was distributed previously and is **re-attached**. Some sections mandate that this form is completed and turned in prior to post-season seeding meetings to verify that no wrestler exceeded the 20 point limit and as proof that all wrestlers entered have met the 50% rule.

## **XI. Future Events: State Dual Meet Championship, Independent Schools, Regionals:** **State Dual Meet Tournament-**

**The NYS State Dual Meet Tournament was approved by the Executive Committee in October 2016 for implementation in 2017-18 season.** This tournament will become a state sponsored tournament to determine an official NYS team dual meet champion. This would be considered a post-season event, so that it would not count for points or weigh-in's. Individual wins and losses will count on individual records and for seeding.

Date for the tournament:

NYS Week #30 is the week selected to run the tournament. (With Snow date of Sunday).

Number of Divisions for the Tournament:

A separate bracket will be run for D1 and D2

Number of teams:

Each Division will be of a 12-team event with 4 pools of 3 teams (with each team being guaranteed two duals in their pools), with the pool champs advancing to a Championship Semifinal & Final (possible 2 more duals)

Number of days for the tournament:  
The tournament will a one-day event.

Selection of the 12 Teams:

The Federation teams will not be included in the tournament. Each Section has the right to determine their team representative in whatever manner they deem acceptable. (Most will run Sectional Dual meet tournaments, while some will just select a team in each division to represent them). Sections do not have to enter a team if they choose not to.

2-At-Large entries in D1 and 1-At-Large Entry in D2. Additional At-Large entries could be possible if a Section does not want to send a representative.

Division One: One entry per section: Sections 1,2,3,4,5,6,8,9,10,11, and 2 At-Large entries

Division Two: One entry per section: Sections 1,2,3,4,5,6,7,8,9,10,11, and 1 At-Large entry

Deadline for entry:

The Saturday of Week #29 is the last day that a Section can enter a team into the tournament. At-Large's will be selected and seeding will be done the Sunday of Week #30.

The criteria for selecting At-Large teams:

**As the NYSWC has the ability to use the criteria (below) as a trial run this year and apply it to teams who placed 2<sup>nd</sup> at their Sectional dual meet tournaments to see if the criteria will yield the desired results.**

**Once Sections who host dual meet tournaments have completed their tournament, Chairmen should complete the NYS Dual Meet At-Large Entry Form (attached) and submit to Jeff Cuiilty-S9. Once calculated the NYSWC can finalize criteria at the Spring meeting.**

-Proposed point system for ranking At-Large teams

-Teams enter the roster they used in the Sectional Dual Meet tournament.

-The wrestler listed at each weight is assigned a point value based on the following from the prior season:

6 points: Returning State Place winner (Top 8)

5 points: Returning Section Place winner (Top 3)

4 points: Returning Section Place winner (4th, 5th, or 6th)

1 point: Wrestler competed in their Sectional tournament but did not place and had a 20+ win season

0 points: Wrestler did not compete in their Sectional tournament

-Teams with the highest point values (as determined from the above criteria) will be the first ones selected if At-Large entries are needed.

Site for the tournament:

- One of main criteria should be to find a site that will draw highest attendance.
- A College Fieldhouse is preferred as they can get chairs on the floor in between the mats (for teams competing) vs an ice rink which cannot.

**NYSWC and NYSPHAA office both recommend SRC Arena.**  
**Bid still needs final approval.**

Officials for the tournament:

The host Section and neighboring Sections should supply the officials.

Mat assistants to be used for Semi's and Finals only.

30 Dual meets total will be wrestled.

**CAC will have the final say on rate of pay**

Cost of running the tournament:

NYSPHSAA will only reimburse attending schools for mileage.

Sections need to be aware that if their section earns an At-Large berth it is possible to have 4 teams from the same section competing (possibly two teams from D1 and two teams from D2). If a section or a school feels that they do not have the funding to send a representative or additional teams who may have earned At-Large bids, they should inform the NYSWC so that their teams are not included in the selection process

Once the number of officials are determined, the cost per dual meet can be calculated. CAC takes an average of what the 11 Sections would pay their officials for this type of event.



Admission fees would be set by NYSPHSAA based on facility fee.

Corporate sponsorships will help but can't be include in proposed budget.

Once facility rental/cleaning fees, security fees, officials fees, entry fees and spectator fees are known, an analysis can be done to determine how many "fannies are needed in the seats" for the event to breakeven. NYSWC and NYSPHSAA will then need to determine if that is a realistic number so as to assure the event does not lose money

**Seeding:**

Eight schools in each Division will be seeded with- possible random draw of the non-seeded schools into each pool. (see tournament format and seeding code -last page)

Criteria for seeding still needs to be developed. Criteria to be considered might be: number of returning states and sectional place winners, number of dual meet wins over high winning % teams.

**Tie Breaking Criteria within pools (Ex: all 3 teams in Pool go 1-1):**

Still needs to be developed.

**Individual Eligibility:**

As per Executive Committee: A team and each individual participant must compete in at least six contests to be eligible for their sectional dual meet tournament. Teams or wrestlers who were not eligible for the sectional dual meet tournament cannot wrestle in the state dual meet tournament. If because of the date a section runs their dual meet tournament, a team or individual won't have the required six contests, then that section has to make a request to lower their number of required contests to Executive Committee prior to the October meeting.

Teams and Individuals from Sections who select a team for the tournament that do not host a dual meet tournament, must have six contests completed by Week #30. Waivers from Sectional Athletic councils for medical reasons for individuals will be accepted.

**Will there be a maximum number of participants allowed per team?**

**Independent Schools (AIS)-**

**Short term:** As per fall meeting: Procedures for allowing Independent Schools to join the NYS tournament for 2017-18 would be that a Pigtail will be added to each weight class in the D2 tournament on Friday night. The pigtail could be randomly assigned to non-seeded wrestlers. The loser would still have the chance to wrestle back. This will add 15 additional matches to the winner's bracket and 15 matches to the loser's bracket in D2 on the Friday night of the State tournament. which would add approximately 45 minutes to the ending time. As the D1 tournament should finish first (as they have 30 less bouts), the 4 mats from the D1 tournament would also open up and D2 could use all 8 mats to finish their tournament. This should help reduce the extra 45 minutes needed for D2.

Marty Sherman-Discussion on Friday start times for 2017-18 tournament when Independents join D2. Ending times for both D1 and D2 need to be noted for this year's tournament.

### **Long Term:**

#### **From Fall 2016 meeting:**

Would there be enough interest in a Federation Tournament to follow the NYS Championships? For Example:

The NYS tournament would be held without including the PSAL, CHSAA or Independents. One possibility would be that additional At-Large berths could be awarded to fill the spots taken by PSAL and CHSAA who are no longer in the tournament. A NYS Champ would still be crowned for both D1 and D2. The awards ceremony would no longer need to award separate NYS and Federation medals and place winners would no longer have to be removed from the podium.

The following week, a possible 8 man bracket could be created using place winners from both the D1 and D2 NYS Championships from the week prior, along with place winners from the PSAL, CHSAA and Independent School Championships. These wrestlers could then wrestle to determine the Federation Champion at each weight class. Under this system the "true" NYS champion would be crowned. In addition team scoring might be kept for: NYS-D1, NYS-D2, PSAL, CHSAA, and Independents to determine a team champion.

#### **For future discussion:**

- Who would actually be responsible for organizing and running the event?
- What role would the NYSWC have?
- The facility for this event would have to be determined.
- Would it draw enough interest to be housed at a venue like the Times Union Center?
- Would participating schools be willing to fund an additional week of wrestling for their champs (transportation, motel, meals, etc.)?
- Would the four groups participating: NYS, PSAL, CHSAA and Independents be able to split the expenses of facility rental and running the event, as well as the gate collected evenly at 25% each?

### **Regional Committee:**

NYSWC prioritized the State Dual Meet Championship as we did not want to have two proposals to NYS running simultaneously. Regional concept is on hold until the State Dual Meet Tournament is up and running. If there is still interest at that time, the committee will re-visit it.

- d. Attire of coaches for finals-Recommendation is to not wear shorts, hats etc . Chairmen are asked to impress upon coaches to wear at least: long pants and school or section shirt if they don't want to wear a full suit or shirt and tie.
- e. Dress code for Top 6 place winners; No Hats, in uniform, etc. Chairmen will need to get this info to competitors prior to start of the tournament.
- f. Sectional uniforms are still optional (but were worn by all sections last year). Medal round can wrestle in school uniforms.
- g. Weigh-in Procedures:  
Beginning weigh-in's will run for an hour and a half from their starting time. This year's start time will be 7:30. Each Section will have their own scale: Division 1 (odd years) will weigh in followed by Division 2 (even years). Official will note the starting time each section steps on the scale. Chairmen coverage is needed for each scale.
- h. Awards ceremony was successful at the end of the finals and will continue this year. The medals will now be put around the necks of the wrestlers as they get on the award stand vs having them already around their neck when they step onto the podium.  
**All awards will again be given at the conclusion of wrestling.**
- i. NYSWC will now post updated brackets in hallways after each round. Updated brackets need to be sent directly to the printer so brackets can be printed. Printer email needs to be supplied to Jeff Howard.
- j. Catering: Lunch both days for Chairmen with passes.
- k. **Track Wrestling Live Scoring at State Tournament can be run by Jeff Howard at no cost. Laptops at each table would need to be supplied. Times Union center has ability to broadcast the names/sections/mat #'s of matches currently being wrestler as well as on-deck matches on the main scoreboard above the mats.**
- l. **Request by officials to Jeff Howard that lists can be generated that shows: the Section as well as the name of the wrestlers be generated for both the semi's and medal rounds.**
- m. Hall of Fame ceremony will be shortened.
- n. **Hotel report is on forms page. Code of Conducts are no longer the responsibility of the Sectional Chairmen.**
