Attendee introductions were made and NYSPHSAA staff welcomed.

1. Section 3 will host the tournament through 2020; therefore, bids will open in 2019 for the 2021 tournament. **(I)**
2. 2018 Championship -OnCenter event schedule as follows: Saturday- 8AM Small School Teams, 5PM Section Composite Teams, Sunday 9AM Large School Teams. Logistics were discussed & lanes were drawn for each session. Ticketing issues were discussed. 3. A proposal for a change in the substitution rule was introduced and motioned for approval by **Hugo McGroty**, second **Ed Ventry**. Proposal was distributed through email prior to meeting, original proposal was rejected **(Boys 4-6-1) (Girls 4-4-2) Eileen Kilcullen** made a motion to modify proposal allowing one sub per game, second: **Bryan Landini**. Proposal Approved for two year trial **(Boys 7-3-1)( Girls 6-2-3) (D/A)**
4. A proposal for a change in numbers of contests from team to individual to be in line with other individual sports was introduced by **Steve Luciana & Bari Suman**. **Motion Steve Luciana, Second Ed Ventry. Approved (Boys 8-0-3) Girls (7-0-4). (D/A)**
