4.3 6 Class Sports (Appendix B)

The information for the 6 classifications is posted on the Section VI website. It was noted that Section VI was not in favor of the 6-classification proposal, but it was approved at the state level and will take effect in the 2023-2024 school year.

M. DiFilippo reported that he has received numerous questions and concerns about the BEDS numbers. One of the more overwhelming concerns is how the numbers are calculated. The 2023-2024 numbers are the 2020-2021 9th and 10th and average of 9th and 10th graders. Another concern our section is facing is boys teams in one class and girls teams in another.

There is also confusion over what it means to be a variation or non-variation sport. Variation sports have the opportunity for the state sport committee to decide their cut-off numbers. Non-variation sports are given their class cut-off numbers based on the agreed upon formula.

Variation sports include: Girls Volleyball, Football, Cheer, Cross Country, Field Hockey, Ice Hockey, Boys Lacrosse, Girls Lacrosse, Boys Volleyball

Non-Variation sports include: Boys Basketball, Girls Basketball, Boys Soccer, Girls Soccer, Baseball, Softball, Wrestling, Track & Field, Bowling

The sports where 6 classification will be implemented starting with the 23-24 school year include: Boys Basketball, Girls Basketball, Boys Soccer, Girls Volleyball, Baseball, and Softball.

Appendix B does not reflect the new and forthcoming individual sport numbers. The state office is working on the calculations for the individual sport numbers, which currently are based on BEDS numbers (600+ falling into Division I and 0-599 falling into Division II). The new breakdown will be based on the number of teams in a sport, statewide. The top 40% of the total number of teams will comprise Division 1. The bottom 60% of the total number of teams will comprise Division II.

As a result of the new formula for individual sports, the NYSPHSAA Wrestling Committee is proposing to change from a non-variation sport to a variation sport. Their proposal is scheduled to be an action item at the February 2023 NYSPHSAA Executive Committee meeting.

M. DiFilippo shared with the council that he will be available to attend league meetings to explain the format of the classifications as well as answer any questions.

6.3.2 2023-2024 Section VI Proposed Budget (Appendix D)

The 21-22 audit was conducted by the Bonadio Group. At completion, the Section was determined to be approximately \$42,000 in the black. The 22-23 and 23-24 school years are projections.

The 23-24 proposed budget was presented to the Finance Committee for review. Council members were asked to review the proposed budget with their respective leagues. The 23-24 proposed budget will be an action item at the January 18, 2023 Athletic Council meeting.

The annual audit, Quickbooks, and legal fees are combined within one line item on the budget. Considering the increase in legal fees over the past few years, concern was expressed about the budgeted/projected amounts for 22-23 and 23-24. D. Scholla, M. DiFilippo, and S. Penhollow were asked to re-examine the current proposed amount and adjust the 23-24 projection, if appropriate.

 This proposal came from the softball committee. The 12-run mercy rule is already utilized in regional and state play. Some Section VI leagues employ this rule during the regular season. The Softball Committee would like this rule implemented for sectional play. The Sectional Intersectional Committee is in support of this proposal. This proposal will be an action item at the January 2013 athletic council meeting.

 - It was noted that even though not utilizing headgear in the sport of Girls Lacrosse continues to be a concern, the NFHS and the sections are not in favor of mandating its use.

The 50 % rule, which was scheduled to be voted on, was instead, tabled at the last Modified Committee meeting. The committee felt further discussion was needed at the section level. The 50% rule prohibits modified athletes from being able to move up to the JV or varsity level after the completion of half of the season. Some programs were interested in eliminating the 50% rule. Their rationale involves the opportunity to pull modified players up to JV (at any time) to fill spots exited by JV players who were moved up to varsity. By doing this, all 3 levels can be kept intact. Programs in opposition of eliminating the 50% rule believe in holding to the APP process, appropriately placing an athlete based on capability, and not using a roster filling process. The Section VI Modified Committee plans to discuss this further with the leagues in preparation for a possible vote at the March 2023 NYSPHSAA Modified Committee meeting. Council members were asked to discuss this item at the league level so their designated modified representative is provided direction on how to vote.

The following items will be action items at the January 18, 2023 Athletic Council meeting to provide M. Fallacaro-Dougherty and J. Roth direction for the February 2023 NYSPHSAA Executive Committee Meeting (Appendix G):

- Consider removing the NYSPHSAA note under mixed competition (Handbook Committee)
- Consider amending guidelines for combined practices for 11-man football
 This proposal was presented by Section VI Football Committee. They are seeking to change from a 7 V 7 to a 9 V 9 live drill.
- 2023-2024 Boys Wrestling Weight Classes
 This proposal seeks to use NFHS 12 weight classes plus the addition of 101lb weight class. The Section VI Wrestling Committee is in favor of this proposal.
- Boys Wrestling Division Cut-Off Numbers This proposal seeks to change Wrestling from a non-variation sport to a variation sport beginning with the 23-24 season. Variation sports decide their cut-off numbers. Non-variation sports are given their cut-off numbers. Beginning with the 23-24 school year, non-variation sports will be calculated so 40% are placed in Division I and 60% in Division II. Currently, wrestling cut-off numbers follow 600 and above in Division I and 599 and below in Division II. The Section VI Wrestling Committee wishes to remain even between divisions.
- Girls Flag Football
 Girls Flag Football needs to create high school sports standards. It is the recommendation of
 NYSPHSAA to use the current Girls Lacrosse standards for Flag Football. The Section VI Girls Flag
 Football Committee is scheduled to meet this evening. It is anticipated this item will be discussed.
- Girls Flag Football NFHS/NYSPHSAA Playing Rules
 This proposal seeks to set the same rules that were used during the pilot. However, a running clock is recommended in place of the previously used stop clock.
- Girls Flag Football Establish a State Championship in 2024
 It was noted that if this proposal is approved, the championship would be scheduled during week 48 of the 2024 calendar.

9.1 NYSPHSAA (T. Nelson & R. Zayas)

- NYSPHSAA is releasing a new RFP for their ball adoption agreement. Companies other than Spalding
 may be interested in submitting a bid. There is potential for having different vendors across sports. The
 amount of potential revenue is drastically reduced when using a segmented model. Revenue, however, is
 not the only consideration. Quality is also a significant factor. The Sections receive 75% and NYSPHSAA
 receives 25% of the ball adoption agreement.
- NYSPHSAA is preparing for the next few weeks of state championships
- Per the NYSPHSAA Constitution, if a section cannot place a member school within a league, it then becomes the responsibility of the NYSPHSAA Executive Committee to decide placement. Section VI notified NYSPHSAA it is unable to decide placement for Health Sciences, Tapestry, and Global Concepts. The NYSPHSAA Executive Committee convened on October 19, 2022 to discuss placement and is in the process of creating a sub-committee to examine all the options of placement. The sub-committee will then make a recommendation to be acted on by the NYSPHSAA Executive Committee at their February 2023 meeting. Section VI will not have representation on the sub-committee.
- The state office was made aware that the State Education Department has schedule their
 NYS history regents exam on the same date as the 2023 NYSPHSAA Boys Tennis Championships.
 NYSPHSAA has held firm that state championship dates do not move. NYSPSHAA is working with the
 NYSED and the championship venue to see if there is any flexibility.
- R. Zayas made council members aware that there are a significant number of fake social media accounts promoting streaming of post season games and links associated with state championships.

Council members were asked to make sure there is a clear understanding of the transfer rule with their respective leagues. The prescribed penalty for use of an ineligible player should also be discussed and feedback collected by league heads. The league heads will, in turn, discuss the feedback at their next scheduled meeting. After examination of that feedback, a recommendation is expected to be presented at the January 2023 Athletic Council meeting.

Status Updates:

- 1. **NYSPHSAA Jewelry Rule** NYSPHSAA has removed the NYSPHSAA Jewelry Rule and will follow the sport specific rule as it relates to Jewelry. Beads are now allowed to be worn in any sport if they are secured to the head and do not pose any increased risk to any student athlete. Religious Headwear is allowed in any sport if it secured.
- 2. **Anyone Can Save a Life** Schools are encouraged to utilize the Anyone Can Save a Life program in their interscholastic program. Team should develop an EAP in case of an emergency medical situation
- 3. **BIANYS Update** Aimee Brunell provided an update on the updates to the Concussion Management Law with the NYS Legislators. She also provided an update on a grant that BIANYS is working on with the NYSATA and an opportunity for NYSPHSAA member schools to take advantage of a Concussion Outreach Program and Education (COPE). If schools want more information, please feel free to reach out to Aimee.
- 4. **Tornado Policy** NYSPHSAA did approve a Tornado Policy for regular and post season play. The policy can be found in the NYSPHSAA Handbook and on the NYSPHSAA website. The NYSPHSAA staff will include it in the coordinator manual as well.

Items Discussion/ Action Taken:

1. Girls Lacrosse Headgear – Todd Nelson informed the Safety Committee that the NFHS and USA Lacrosse is not inclined to mandate the use of headgear for girls' lacrosse. They will continue to monitor the situation and request further studies. Liz Parry and Jeremy Thode represented the NYSPHSAA Girls Lacrosse Committee. They expressed that the committee was unanimous that they did not want to recommend mandating head gear for girl's lacrosse. The Girls Lacrosse Committee feels the rules allow for teams and players to wear headgear if they want to and the evidence for NYS does not support the need to mandate the use of headgear. They commented that during the past 2022 Lacrosse Championship not one player chose to wear the headgear. A vast majority of the NYSPHSAA Safety Committee echoes the sentiments of the Lacrosse Committee. The Certified Athletic Trainers reported that they did not see an increase amount of head injuries in their areas and appreciated the fact that the rules did allow players to wear the headgear if they chose to do so. Aimee Brunell reported that BIANYS would support following the science and the results of the studies that have been conducted. Overall, based on the studies that have been conducted and the few amounts of head injuries in NYS neither the Girls Lacrosse Committee nor the NYSPHSAA Safety Committee are recommending the mandating of headgear for Girls Lacrosse at this time. If the national governing bodies decide to make a



- change in the rules regarding headgear in girls lacrosse, then NYSPHSAA would respect and follow the rules.
- 2. Possession Clock for Boys and Girls Lacrosse NYSPHSAA requested the NFHS discuss the possibility of instituting a rule for a possession clock in both boys and girls lacrosse. There is not a desire from NFHS to implement such a rule at this time. The NFHS has suggested that NYSPHSAA request a pilot program to the NFHS to allow for a possession clock for the 2024 season. NYSPHSAA Boys and Girls Lacrosse Committees will work in putting a request into the NFHS. Both committees feel that this will help minimize risk to student athletes, especially in the girl's lacrosse game.
- 3. Lightning Policy The Safety Committee has discussed updating the Lightning policy to include the use of technology for several years. They examined the use of spheric maps from Earth Networks but that application was too cumbersome for users to use. Earth Networks presented a new product they have developed called spheric connect. They will provide free trial periods for anyone on the Safety Committee that would like to try the app. Spheric Connects seems to be more user friendly and warnings are based on the location of someone cell phone. Schools would need multiple licenses to give to multiple individuals during the season. There is a cost per license. Jim Rose and Jarett Rhoads have also been looking into a free app called My Lighting Tracker. This app seems to be very user friendly and there is no cost to use the app. Jim and Jarrett are still working on determining the reliability of the app. They will be contacting the company to see more information on the reliability. This topic will be on the agenda for the Spring meeting and a possible recommendation to go to the Executive Committee.
- 4. **Modified Recommendation** The Safety Committee does not have any concerns with the modified recommendation to recommend the use of mouth guards by modified goalies instead of requiring the use of mouth guards for modified goalies. Jim and Todd presented a discussion item regarding the possibility of adding 6th graders to be eligible for interscholastic sports. This regulation would have to be changed by SED but the modified committee did have an initial discussion and wanted the input form the Safety Committee. Most of the committee did express concern over including 6th graders in the interscholastic program. Their concerns revolved around maturity levels of the 6th graders and the time that interscholastic sports have as compared to youth sports. They also expressed the concern that another level of teams would add more responsibility for the athletic departments. Proposal

The NYSPHSAA Football Committee is seeking approval of an amendment to the Combined Practice guidelines for 11-man football.

Effective Start Date

August 19, 2023

Rationale

In 2019 the NYSPHSAA Football State Committee established guidelines for interschool practices. Five items make up the framework of these guidelines. Items d) and e) are being proposed to be revised.

CURRENT GUIDELINES:

- a) Coaches are to instruct their own players.
- b) "Full Live" contact is permitted but not required.
- c) Athletes/Teams may not participate in a combined practice unless they previously completed five (5) days of practice.
- d) While working on team situational aspects, drills may not exceed seven (7) players from either team. This will allow for teams to conduct a 7 v 7 period for skill positions or it may be designed to focus on an inside run package to emphasize offensive/defensive line play.
- e) Schools using more than seven (7) players in a team drill will be in violation of this rule.

PROPOSED CHANGES:

- d) While working on team situational aspects, drills may not exceed a maximum of nine (9) players from either team. This will allow for teams to conduct a 9 v 9 period for skill positions or it may be designed to focus on an inside run package to emphasize offensive/defensive line play.
- ** 8-Man Football teams will only be allowed a maximum of seven (7) players from either team.
- e) 11-Man teams using more than nine (9) players in a team drill will be in violation of this rule. 8-Man teams using more than seven (7) players in a team drill will be in violation of this rule.

The rationale for the request centers on allowing teams to work on inside run play with a full line. Currently, with the 7 v7 rule in place, a team that uses a tight end with two running backs can't run full line drills. They would need to use 5 linemen plus the tight end and quarterback and they are already at the maximum of 7 without counting the running backs. As a result, teams are forced to go half line and not incorporate any backside linemen. Most teams utilize pulling lineman from the back side when

executing inside run play. If the rule is modified to read a maximum of 9 players, teams could use 5 linemen, a tight end, and 2 running backs to get a true evaluation and a more productive drill.

When the state committee established these guidelines, the 7 v 7 rule was put in for two reasons:

- 1. There needed to be a clear distinction that these drills were not actually scrimmages with 11 on 11 so the decision was made to max out at 7 v 7 so it would be clear to all, it was not an 11 on 11 full team scrimmage. We believe modifying this rule will still accomplishes that same premise while allowing for a more productive teaching period for athletes. Anyone viewing this period will still note the offense has no wide receivers and the defense has no defensive backs. It will still be evident to all that this is not an 11 on 11 situation.
- 2. If more than 7 v 7 was permitted, 8-Man teams would have a full line-up thus making it a scrimmage. With that, we would only be asking for this modification be implemented for 11-Man football.

It should also be noted the original decision to max at 7 v 7 had nothing to do with safety. As mentioned, it was simply put in so there was a distinction between the combined practice and a scrimmage. This change would still honor that premise.

The NYSPHSAA Staff and Girls Flag Football Committee is seeking to conduct a state championship starting in spring 2024.

Effective Start Date:

Week #48 in Spring 2024

Rationale:

Due to Girls Flag Football meeting the criteria of six sections with four or more programs, a state championship may be established per the NYSPHSAA Championship Philosophy.

Proposal Originated:

The NYSPHSAA Girls Flag Football Committee met for the first time on September 14, 2022.

Budget Impact:

There will be travel expenses for schools to send a flag football team to a state championship in addition to NYSPHSAA incurring expenses to rent a venue, pay for officials and awards, travel, and also pay for other associated state tournament expenses. Additionally, schools/sections/NYSPHSAA will generate revenue from admissions at local games, Section tournaments and the State Tournament to help offset budgets.

Other

Each section will send a representative to a Regional competition (see proposed regions below) for the right to advance to the State Semifinals/Finals. The NYSPHSAA Sportsmanship Committee is recommending adding the following NYSPHSAA Sportsmanship Spectator Regulations to the Handbook.

"Any negative, inappropriate, derogatory comments or actions that brings direct attention to a supervisor or school administrator by a spectator or group of spectators are required to be addressed by the host school, Sectional or NYSPHSAA representative in the following non-sequential order depending on the comments or behavior:

- First warning Directing the spectator or group of spectators to refrain from any negative comments or actions.
- Second warning A personal discussion with the spectators or group of spectators on the above NYSPHSAA expectations and reminding the spectators or group of spectators of the next step, removal of the game or event, will be utilized if the behavior continues.
- Removal from the contest The spectator or group of spectators will be directed to leave the
 facility for the remainder of the game or event. If spectators or group of spectators refuse to
 leave the game or event, play will be stopped until they vacate the premise.

Penalty for being removed from a game or event: Any spectator removed from a game or event will have a minimum penalty of completing the NFHS Parent Credential course or a one game suspension before they are allowed to attend any interscholastic event, home or away. Once the course is completed the spectator will provide a certificate of completion to the athletic department office. Schools are required to communicate with the offending spectator on the NYSPHSAA Sportsmanship Spectator Expectations.

 Depending on the severity of the behavior/comments or future disqualifications by the offending spectator NYSPHSAA and the Section may get directly involved in the situation.

Note: A school may take any or all these actions during or after an interscholastic contest.

NYSPHSAA Boys & Girls Winter Track & Field Committee Meeting Tuesday, August 30, 2022 @ 1:00 pm via Zoom

- Coordinators Kristin Frazer and Dave Hennessey welcomed everyone into the meeting at 1:01 pm. Dave also noted it is different without Oscar on the call and welcomed Kristin to her new role as Boys State Coordinator.
- 2. Kristin asked if anyone is missing on the directory to please let Kristin and Dave know of updates for contact information. They would like to keep an updated contact list.

3. NYSPHSAA Staff Reports:

Joe Altieri:

- a. Welcomed Kristin as the new Boys State Coordinator. Also thanked Neil DeRaiche and Bob Wallen for serving on the interview committee; was first time having an appointment committee and set the bar high for all future committees.
- b. NYSPHSAA Strategic Plan will be posted on the NYSPHSAA website soon. He noted the 4 initiatives NYSPHSAA would be focused on the next 5 years (growth in participation, officials recruitment/retention, financial stability, DEI)
- a. Nominations for the NYSPHSAA Hall of Fame submissions required to be online by January 29, 2023.
- b. Indoor Track State Meet bid goes through 2023 for Ocean Breeze hosting. The RFP will be going out soon for 2024-2026. There will be a 30-60 day window for Sections and/or facilities to submit a bid. Goal is to release the RFP in September after the committee determines a good day to meet in November or December via Zoom. NYSPHSAA will send the bids to the Committee a day or two before the meeting so they can review in advance. Kristin will send out a poll to the committee to determine a meeting date and time. In January, the CAC would discuss the bids then in February, the Executive Committee will vote.
- c. Congratulated Lou, Lauren and the committee on an outstanding 2022 meet.

Chris Watson:

- a. The state meet is pretty standard every year from an operations standpoint. He will work with Kristin and Dave on ordering athlete/coach badges.
- b. He announced, at this time there are no NYSPHSAA policies on COVID restrictions.
- c. There was a ton of signage that helped with the entry process. It was the best year so far with entry procedures and we will continue that process.

Robert Zayas:

a. We are now abiding by NFHS rules regarding jewelry. We no longer have a prohibition against jewelry. This information has been communicated with Officials Organizations.

Joe DeGuzman:

- a. MF Athletic has renewed their sponsorship for 3 more years.
- b. He introduced Kyle Brazeil from MileSplit who had a brief report.

Mile Split: He explained the big change last year was the rolling deadline for relay names which seemed to work well. No other changes to the platform, but rejecting athletes will be an easier process. He also wanted the committee to know that the Outdoor Committee is looking to have their entries be more coach driven and entered.

Joe Altieri on behalf of Todd Nelson and Chris Joyce (absent with notice):

- a. Due to a positive response and experience, state tournaments will once again have a digital event program. CP Sportswear will continue to provide apparel.
- b. Digital ticketing will also continue for 2023. The procedure went well in 2022.

Joe Altieri on behalf of Kristin Jadin (on maternity leave)

a. He noted she will return from maternity leave in late September and will be back to working on Championship Operations Packets. Ffeedback is always welcome.

4. Ocean Breeze Update - Lauren Primerano/Lou Vasquez

a. The track is being re-surfaced by the end of October with the newest Mondo surface installed. Ocean Breeze will be getting a second scoreboard; it is not certain of when it will be installed. Joe asked about entry procedures due to COVID,etc? Lauren explained that NYC has lifted all COVID protocols and OBAC is back to pre-COVID procedures. Kristin asked if Coaches and Spectators would need to be vaccinated? Lauren said there is not a mandate for that currently.

5. Committee Business:

- a. Dave reiterated that the Jewelry rule has been eliminated.
- b. Standards Dave noted we have not revised them lately. Last year we did not change the standards due to COVID. Dave has a document with prior years results that we can utilize to update standards. He suggested we may need to look into two separate standards for Flat and Banked Tracks. Bob Wallen (2) made a motion to retain the current standards. Mike White (9) seconded. The motion passed unanimously to maintain the current standards and review them next year.Dave will send out the standards soon. Chris Watson asked to have them sent to him as well so he can post on the NYSPHSAA website.
- c. State Meet Recap: Kristin reviewed the document that was compiled at last year's championship meet titled Reflections 2022. Some items to note:
 - 1. Coaches gate pass list will be due by Wednesday.
 - 2. Seeding meetings will be together and will be done event by event. This will eliminate any Coordinator who is both genders from having to run back and forth and miss any information.
 - 3. As in 2022 for LJ/TJ, the Girls will be jumping towards the finish line. There was discussion regarding Boards being put down and tape on the floor. OBAC staff have been trained to pick up tape each day. Lauren will do her best to let them know to leave the tape on Friday.

- 4. Conversions for Boys was changed at the 3/6/20 State Meeting to allow conversions for the Boys for the Mile and 2 Mile. Kyle offered to send a link to the conversion calculator from MileSplit. It also has a conversion for Flat to Banked tracks.
- 5. Lauren approved the use of a new Multi-Purpose Room for our meeting to avoid the commotion of set up and arrival.
- 6. Random seeding for the 1,000 m and up was voted on unanimously at the 10/21/19 State Meeting at the NYSPHSAA Offices.
- 7. Separate Committee and Media areas. Keep Committee where we have been and have the Media set up on the other platform near the PV (has outlets for power).
- 8. Girls will be competing first for 2023 followed by Boys (except the 55H Final)
- 9. Hospitality Room: Lou offered this and noted its up to NYSPHSAA if they want to provide refreshments in a room for that use. Lauren mentioned there was a mess left around the track under officials chairs and asked the State to encourage officials to take a 15-minute break to eat in the room instead of out of the track in view of the public. Bob Headwell explained that the Officials try to eat while Field events are warming up so they don't delay the meet and leave events unmanned. Joe stated we don't want delays in our event so he asked Bob to ensure Officials clean up after themselves.
- 10. High Jump let Ocean Breeze staff set up. Plan on starting around 12:00 for 2023.
- 11. Lower Height Pole Vault Pit will start around 1:00 pm
- 12. Discussion regarding coaches wanting to choose PV pit for their athletes. Coordinators should ask at their Qualifier Meet what height Pole Vaulters would like to start at. Kyle will try to have a spot on the form for starting height.
- 13. Entry to Ocean Breeze. Chris Watson asked that any Section that will be handing out packets/bibs/credentials on Saturday morning to provide Coaches or themselves to handle that task. He also requested radios for communication and noted NYSPHSAA will bring empty boxes and/or envelopes for Sections and the distribution.
- 14. A request was made to have a line for athletes in addition to coaches.
- 15. Awards: Mike White stated last year the help was fantastic. We will again have a sign up sheet at our Friday meeting for Sections to sign up for times to assist with awards. It was emphasized the importance of corralling athletes to the awards area and keeping them away from the runways.
- 16. Requests/Proposals/Questions/Concerns:
 - a) Dave explained that after much discussion a number of years ago it was decided to bring back 12 athletes to the final of the 300 m and 8 for the 4X4 and 4X2 due to it being proportional to the field.
 - b) Mike White (9) made a motion to continue to bring back 12 athletes to the 300 m Final but move to a 3 heat Final. Times 9-12 would be in Heat 1; Times 5-8 would be in Heat 2; and times 1-4 would be in Heat 3. Bob Wallen (2) seconded. Much discussion took place regarding running in lane 1, keeping 2 heats BUT changing who ran in certain lanes. After discussion a vote took place on the motion. The vote was 13 for the motion and 2 against. The motion passed.
 - c) Regarding the athlete in the 1,00m run, Bob Headwell explained it was done to allow an athlete an opportunity to compete.
 - d) Regarding the High Jump athlete, Dave explained that the bar was never lowered; it was held up from being raised.

e) Discussion took place about waiting for athletes and looking for athletes as well as time excused from an event. Bob Headwell explained it is a Games Committee decision to determine the amount of time to be excused from an event.

- e. Dave Hennessey made a motion to rename the Weight Throw in honor of the late Oscar Jensen who contributed over 50 years to the sport. Bob Wallen (2) seconded. The committee unanimously voted in favor of this recommendation. Joe explained that NYSPHSAA has never named any state championship event after anyone before and its a big ask but will bring it back to NYSPHSAA and get back to the committee. It was asked if medals could be engraved with Oscar's name. Chris Watson indicated probably not with tje medals having one design for all sports.

- a. Update on: Classification-Ad hoc committee that looked at classification numbers. What was the result of the February2022 vote for 40% of the schools be in D1 and 60% be in D2 for the 2023-24 school year. This would cause approximately 36 schools to move from D1 to D2. (see data below: Old Business)
 - Motion #1: Brad Hamer-Section 3- Wrestling will become a "variation sport" for 2023-24 with current cutoff numbers of 600+ for D1 and 599 and below for D2 (to best keep approximately the same number of schools in each Division).

 Passed: Unanimously
- b. State Tournament Program Changes-All programs will be free of charge and digital in 2022-23. A QR code will be available at the tournament for spectators to click on. Data for programs needs to be received by the Monday prior to the tournaments. Updated brackets for Day 2 and prior to finals will be available as well as a finalized bracket when concluded for those that request.
- c. InBody scale certifications: The InBody120 automatically starts booting when it is turned on. While booting, it performs a self-weight calibration. This happens every time the unit is turned on. To get the scale certified you must contact your County Bureau of Weight and Measures (as you would for a regular scale).
- d. (NWCA-Track Wrestling): Status of In-Body training: Todd will schedule a meeting with all
 consultants and Track in mid-October for an update on using the equipment.
 NYS website has a 45- minute video available for InBody Training.
- e. An updated download link and documentation **will be sent** in mid-October **to the assessors** that have the InBody units with the Lookin Body 120 software that integrates with Track.

- f. Inbody Laser Height measuring devices are available for \$149. Link is: https://inbodyusa.com/products/push-stadiometer/ NYSWC recommends all sections use this device for measuring height so that all heights throughout the state are calculated consistently.
- g. Current Assessors Handbook on NYSPHSAA will be updated on website.
- h. Current approved Assessor List is for 2022-23 will be updated on website.
- i. Current skin form should read: "For use during 2022-23Season" and will be updated on website.

- Updated: Form01-NYS-ParentAwarenessForm for wt certifications will be updated on website.
- k. As our current 2-year pilot has now expired, the committee has decided to extend it thru 2022-23. Executive committee will officially vote on this in October.
- I. For the 2023-24 season, NYSWC needs to determine if NYS wants to follow the NFHS 12 weight class proposal (and add an additional 13th weight class at the start). At the 8/8/22 Conference Call, Jeff Cuilty-S9 has provided an estimate of how many wrestlers could be at each of the new weight classes based on 2021-22 actual participation. After discussion: Committee has decided to go with either the 12-weight class proposal (with the addition of a 101 pound weight class, or the 13-weight class proposal. NYS would have a total of 13 weight classes either way.

Motion #2: Mike DeBarbari-S6: For the 2023-24 season NYS will adopt the following 12+1 weight classes:

101 108 116 124 131 138 145 152 160 **170 190** 215 285

In Favor: Sections: 1,4,5,6,9,10,11

Opposed: Sections: 2,3,7,8

Minimum weights for 7th and 8th graders based on new weight classes will be determined at the spring meeting.

NYS will not be adopting the NWCA 13 weight class option:

m. Discussion of implementation of the NWCA 1.5% weight loss plan:

• Mark Byers-(PA Wrestling Chairman)-Input on 1.5% system that PA has used for past 4 seasons. Their weight certs begin 6 weeks prior to first competition up until the Monday prior to the first competition. No certs are allowed after January 15. They allow a one-time appeal using hydrostatic weighing. All weigh-ins are required to be entered (even if the wrestler did not wrestle that day). It is possible to make a weight class on the scale but not be allowed to wrestle at the weight they weighed in at as their decent plan did not allow them to be that low. It is possible to have never wrestled at the weight class they will enter for post-season. PA used the Growth allowance but not the honor weigh In procedure. Weigh In form codes are: EWC-Eligible Wt class EWW-Eligible Wrestling Weight

<u>The 50% printout</u>: Track now has the ability to print a 50% report showing a team roster and for each wrestler how many weigh-ins they had, what weights they were at, and what their allowed 50% rule weight class would be for post-season. If NYS were to take advantage of this report, the current spreadsheet we use each year to track 50% weigh-ins would no longer be needed. In addition, this would be a great transition for coaches (should NYS move to the 1.5% method in 2023-24) as each coach would have to get in the habit of entering all weigh-ins and printing weigh in sheets from Track for the 2022-23 season.

(Even though the full 1.5% weight loss plan would not be in effect for 2022-23): NYSWC feels the following items would need to be followed for 2022-23

- Do what the majority of states (29) are now requiring. Each team shall record the actual weights of their wrestlers into Track for each contest. (Once the weight is entered it cannot be changed). This would normally be done at the conclusion of the dual meet as an additional step just prior to recording the dual meet result into Track.
- Track will generate a weigh-in sheet for each dual meet contest showing the MWW and the Eligible Weight Class for that contest for each wrester. Each coach logs the weights onto the weigh-in sheet and then enters those weights into Track ASAP after the contest has

concluded. Tournaments can still use the NYS weigh-in form but coaches will need to enter the actual weights of their wrestlers when they go to enter each wrestlers results.

- Open Weigh Ins can be allowed: This is an option to be set by each state.
 With the Zero Open weigh in option: a coach is blocked from printing the weigh in sheet for the next contest, until the weights from the previous contest are entered.
 -NYS would select the: 1 Open weigh in option: It would work as follows. Example: a team has a contest on Tuesday, Thursday, and Saturday this week. The weigh-ins for a Tuesday contest do not have to be entered to print the weigh in sheets for the Thursday contest, but the Saturday weigh in sheet will be blocked until the Tuesday weight-in is entered. So only One outstanding weigh in is allowed to not be entered when a state selects the 1 Open Weigh in option. NYS will need to decide what option we will use.
- If a wrester is on a weigh-in sheet they cannot be removed, but an option: DNP- Did not participate can be selected.
- The majority of states do give a +2 pound growth allowance after Christmas. NYS will continue to do this. The system is programmed to take into account the +2 pound growth allowance or and any +1 additional pounds for back to back matches etc.
- The NWCA 1.5 full system looks at the weight vs the certified weight for each contest. If wrestler weighs in more that certified weight it will re-calculate the 1.5 percent weight loss plan so as not to allow the wrestler to lose too much weight too rapidly. Even though the full 1.5 weight loss system would not be implemented in 2022-23, each individual wrestler could be given access to their own weight loss plan. Coaches can be given access to each opponent's rosters as well.

Motion #3 Izzy Martinez-S6-For 2023-24: NYSPHSAA will implement the NWCA 1.5% method of weight loss for the <u>2023-24</u> season and the 50% rule will be eliminated but the Growth allowance will remain in effect.

<u>In Favor:</u> Sections: 2,3,5,6,7,8,9,10,11

Opposed: Sections: 4
Abstain: Section 1

Motion #4; Matt DeVincenzo-S11-For 2023-24: As NYSPHSAA will be implementing the NWCA 1.5% method of weight loss for the 2023-24 season the Honor weigh-in system should be eliminated.

<u>Discussion:</u> There is concern that the "Honor" system is being abused in some sections. In many districts, administrators are not performing the honor weigh-ins.

In Favor: Sections: 2,3,5,6,7,8,9,10,11

Opposed: Sections: 1
Abstain: Section 4

Motion #5; Jeff Cuilty-S9-For 2022-23: Coaches will be required to use Track wrestling weigh-in sheets for entering all weigh-in's for duals and tournaments. The 1.5% method will be available for wrestlers and coaches to view its data, but it will not be implemented in 2022-23. The 50% rule will remain in effect and the new Track 50% printout will be used for determining post-season weight class eligibility. The Growth allowance and the Honor -weigh-in procedure will remain in effect for 2022-23 In Favor: Sections: unanimously approved

Opposed: None

This proposal will guide NYS gradually towards the full 1.5% system implementation in 2023-24.

Chairmen need to reach out to their Executive Directors immediately to inform them this will be an Action item for October and require a vote for implementation this season.

V. Kristen Jayden / Chris Joyce / Joe DeGuzman / Chris Watson -

- a. Kristen: Regional-State Tournament Awards will be same as in 2021-22.
- b. Kristen: Championship Operations Packet will be followed and communicated to all attendees at each championship event.
- c. Chris Joyce: Wrestling sport page needs the updated forms-Marty & Jeff will send. Digital Ticketing for all events will be done in advance via GoFan for Dual Meet Championships and Ticketmaster for the MVP Arena. Walkup tickets (without Ticketmaster fees) will available at the door for the MVP arena only.
- d. Joe DeGuzman: Marketing-Sponsorship Updates: NYSPHSAA is working on a contract for the mat sponsor. One bid has been received so far.
- e. Chris Watson: Records and State Tournament History-send Chris any updates needed as it will be used for the digital program.

VI. Frank Marotta - (NYS Officials)

- a. Recommendation that Chairmen submit official's evaluations from their Sectional offices to the officials screening committee. If they were compiled: Chairmen would need to submit the 2021-22 ratings for the season just completed for evaluation of the 2022-23 tournament officials.
- b. Screening the officials for the 2023 State Tournaments:
 - The chapter must communicate with the Chairman by Nov.15 and provide the names of officials who are eligible to referee at the State Tournaments and the Chairman should notify the chapter by Nov. 22 indicating if he cannot support their nominee (so the screening committee will have time to replace that person). A Chairman can just state that "he does not feel the State Committee would approve that official's credentials"

 The chapter deadline for submitting the blue or green forms to the Chairmen and to Frank is Dec.1. The number of nominees per chapter has been increased so we have more officials to screen as we anticipate using 32 officials at the 2023 States. The NYSWOA Screening Committee will meet on Dec.18 and as usual we welcome a couple of members of this committee to attend and observe. Let Frank know if you wish to attend. Screening Committee recommendations for the State Duals will be sent immediately to Marty so that he can clear them with the Sectional Chairmen and the recommendations for the February tournament will be submitted at the January State Wrestling Committee meeting.
- c. Update on: Nominations for the Upstate Chapter of the Nation Wrestling Hall of Fame-Nominations for the September 2023 ceremony should be submitted by: 12/1.
 Special congratulations to NYSWC members: Chris Bourne and Randy Morrison who are being inducted this year on 9/25
- d. NYSWOA Rules Interpretation meeting will be in Syracuse on October 8, 2022

VIII. <u>Handbook Committee Report:</u> (Marty Sherman / Jeff Cuilty-9, Frank Marotta, Rick Armstrong-4, Jamie Block-S1)

The following items to be included int the Wrestling Handbook came up during the 2021-22 season and were reviewed at the Spring 2022 meeting. When NYSPHSAA publishes: The "2022-23 Program of Wrestling" guidebook: (Items in red are the additions to the 2022-23 Handbook). The new publication will be mailed to all Athletic Directors and coaches.

WEIGH - IN PROCEDURES

No sweatpants are allowed. Underwear only is not allowed. Weighing in naked in not allowed. If a wrestler is found to have weighed-in without following the approved weigh-in clothing as listed above, the weigh in shall be declared an illegal weigh-in.

Penalty shall be that the wrestler(s) involved would be ineligible participants.

HONOR WEIGH-INs; If needed:

Procedure for schools unable to do honor weigh-in's due to Covid (ex: remote learning): Team A is on remote learning and cannot do honor weigh-in's, Team B is not remote and can do honor weigh-in's. So as to not penalize Team A, no honor weigh-in will be allowed and both schools must do the matside weigh-in without the +3 allowance. Team A must inform Team B within 24 hours of the match that they are remote and that no honor weigh-in's will be allowed

ADDITIONAL POUNDS

In the case of a tournament: A tournament director grants all the teams in the tournament an extra pound because one of the individuals from a team entered is wrestling a dual the day before the tournament. The dual the day before the tournament is cancelled (bad weather, etc), or the team that enabled the other teams to get the extra pound is told by their administration that they are no longer allowed to attend. All teams in the tournament still get the extra pound. NFHS-Rule 4-5-5. So long as all the teams were given the 48 hours' notice of the extra pound, the extra pound cannot be taken away.

The maximum allowance to be granted is 2 lbs. (not including the growth allowance). A third consecutive day of completion would grant this 2 lb allowance to the schools involved. A fourth and fifth consecutive day would require the 2 lb allowance to carryover. The allowance would never go to 3 lbs over (not including the growth allowance).

WRESTLING FORFEITURES

Should a wrestler compete in a 6th tournament bout illegally, the match result will be forfeited, if it was a placement match, the eligible wrestler will earn the place and team scoring will be adjusted accordingly. The team points and results of the previous 5 bouts that were legally wrestled are not affected.

ADDITIONAL HANDBOOK ITEMS FOR DISCUSSION: (Please review prior to meeting)

In a multi meet format athletes from same school cannot wrestle each other.

As coaches create all the matches for the multi-meet, why would a match between two wrestlers from the same team be needed?

If round-robin pools are being used, the teammates could wrestle the other wrestler(s) in the pool, but why would the "extra" match between the teammates be needed to be contested?

If bouts between teammates are allowed to be set up in a multi-meet, this could incentivize people to wrestle teammates at end of year to boost a W/L record for seeding or to attempt to gain an extra event for 50% rule, which we would not want to happen.

This will be included in the new handbook

2 teams do honor weigh-in in the morning.

Both teams do matside weigh-in and set matchups.

The Ref doesn't show, and the match cannot be rescheduled.

This will count as a weigh-in.

What if the returning Section champ needed one more weigh in and this happened to them in the last dual of the season?

Our current handbook addresses:

Teams that do not show up for a dual meet:

Situation 1: Meet is not wrestled and no weigh in occurs:

Situation 2: Meet is not wrestled (not due to school closing) and honor weigh in occurs:

Situation 3: Meet is not wrestled (<u>due to</u> school closing), and honor weigh in occurs

This situation is not like the Situations currently listed because **both teams weighed in twice**. Therefore, if the situation is that the referee did not show due to no fault of either school, then maybe the weigh should count.

If the weigh in counts should all wrestlers be charged 1 point?

As a wrestler can weigh in for a dual meet tournament or dual meet and have the weigh in count without being charged a point.

Should this be treated like when someone weighs in but doesn't wrestle?

When both teams complete the morning honor weigh in and the matside weigh in and a ref does not show and the match cannot be rescheduled, then the Weigh in counts but no points are charged.

This will be included in the new handbook

- c. The number of qualifiers shown below for each Section in each Division for the upcoming season were calculated based on Champs places earned in 2018-19, 2019-20, and 2021-22. As the 2020-21 season was not contested due to Covid, the Power Points below are based on the previous 3 contested seasons using the approved 1st=16, 2nd=12, 3rd=9, 4th=7, 5th=5, 6th=3, 7th=2, and 8th=1 point system. At the conclusion if the 2022-23 tournament, Jeff Cuilty-S9 will re-do the calculation using a system where: 1st=8, 2nd=7, 3rd=6, 4th=5, 5th=4, 6th=3, 7th=2, and 8th=1 point. After the data for the 2022-23 season is received the committee needs to determine if they want to make a change for 2023-24 or 2024-25.

The decision comes down to how we want to reward sections with qualifiers:

1-Do we want the top placers to get the most weight or

2-Do we want multiple lower placers to get the most weight.

The # schools shown are based on BEDS #'s for 2023 as of 8/1/23, (these numbers will be updated once the actual # of schools competing this year are entered into Track. However, the # of schools are only listed for information purposes and has nothing to do with the Power Points calculation).

Teams looking to practice on Friday will either need to practice in the morning prior to the start of the girl's tournament or contact Brad to obtain a site at a local high school. Girls who wrestle in the Girls tournament may also participate in the boy's event on Saturday. There will be no extra pound for the boy's event.

Call to Order by Chair Greg Ransom at 10:04 am. Greg welcomed the group including new member Josh Harrica replacing Carl Normandin. He thanked John Rathbun (retiring in December) for his service on CAC and welcomed Kathy Hoyt who will fill the Executive Director rep position. On behalf of the office, Assistant Director Joe Altieri expressed appreciation for John's service and noted, other than Eileen and Greg, John is the longest tenured CAC member having started in 2012.

President Bartlett welcomed the committee. Dr. Zayas welcomed the committee and was grateful there was no discussion of COVID related items. The office finished its 11 athletic director workshops last week and is excited for a great start to the school year.

Greg reminded the committee we are a recommending body and will vote after coordinators present and leave the call. He also stated the committee should be viewing proposals globally, not representing their section.

<u>ACTION ITEMS</u> (These items will be presented for a vote at the <u>October 19th Executive Committee Meeting</u>):

Softball - Two-Day Tournament in 2023 – Coordinator Dr. Jim Wright explained the proposal. Deb asked if the hotel was prepared for the extra day of the tournament. Joe responded the hotel was a concern of the staff and that we currently have a contract for 20 rooms Thursday and 130 rooms for Friday. We would need the hotel to provide at least 100 more rooms for Thursday and don't know if they are available at this time. Robert emphasized he has concerns about a change of this magnitude this late. Josh asked if there were any financial concerns with the facility. Jim indicated no, it is free of charge both days due to the bid. Eileen noted the outstanding venue and great job that Jim did with the 2022 tournament. Mike had a concern the calendar is too close to implement in 2023. He suggested an amendment. Deb wanted to see the tournament go to two days in 2023 if the hotel is available Thursday night. If not, then go to 2024. Mark noted we need lodging and can't have issues with schools finding rooms. Greg reported there are always issues at championships with hotels and accommodating schools. Eileen stated despite the short notice COVID has taught us how to be prudent and swift on taking action on what's best for student-athletes and we should implement in 2023 if the hotel is available. Mark agreed. Mike felt a two-day tournament needed to be implemented but knows there's financial impact. He asked Joe about two athletes to a room vs four to a room and what schools are doing now. Joe stated, by spring, schools were 3-4 athletes to a room and anticipated the same for fall championships.

MOTION by Deb to support the proposal. SECOND by Mark. Mike motioned to make an amendment to the motion to implement in 2024. SECOND by Josh. After discussion, both were willing to withdraw their amendment for a new

motion. MOTION by Adam that the two-day championship be approved for implementation in 2023 if venue/hotel needs can be secured by October 18, 2022. SECOND by Mike. Carried 9-0

Prior to the next proposal, Joe clarified who the CAC voting members are and that Adam was representing both CAC and is the newest officer (2^{nd} Vice President). He stated today we had nine CAC voting members. He subsequently emailed Role of the CAC and an updated CAC directory.

Game Day Cheer – Form a State Tournament in 2023 – Assistant Director Todd Nelson explained the proposal. He additionally explained the host venue would be Veterans Memorial Arena in Binghamton which agreed, during the bid process in 2020, to host in 2023 whether it was an invitational or a state tournament. No questions or concerns were raised. **MOTION by Jamie to support the proposal. SECOND by Josh. CARRIED 9-0.**

Wrestling – Addition of Officials to Individual Tournament – This was voted 10-0 at the previous CAC meeting in the case it was brought to the floor at the July Central Committee meeting. Today, Assistant Director Todd Nelson noted it was the responsibility of the CAC to decide on officials matters like this proposal and asked for any additional concerns. None at this time so the vote will stand as is.

MOTION by Mike to support the proposal for approval by the CAC with revisions to be made in the Officials Fees & Policies document. SECOND by Susan. CARRIED 10-0. (June 22, 2022)

Boys Soccer – Increase Allowable Yellow Cards for Postseason – Coordinator Mike Andrew explained the proposal. Adam asked what the rules currently are for girls soccer. Mike stated it's the same (three cards) as boys. Kathy asked how many sections have eight postseason games before they qualify for the Final Four. Mike reported Class A in Section 1 could reach eight games and some Class C's and D's around the state can reach seven games. Julie felt the proposal was condoning poor behavior. Mike agreed and felt that wasn't the logic of the proposal. Adam clarified hand balls could be yellow cards. Mike confirmed they can be. Other members brought forward scenarios where non-sportsmanship issues could be yellow cards. Deb stated athletes should be aware of their behavior and providing them more yellow cards allows for them to show less sportsmanship.

Girls Flag Football – Form a State Tournament in Spring 2024 – Assistant Directors Joe Altieri and Todd Nelson explained the proposal. No questions or concerns were raised.

Non-Variation Sports Timeline (Jen Simmons Rule) — Assistant Director Todd Nelson explained the proposal. The approval is typically in May however the proposal offers sports to recommend their numbers when they feel its most appropriate which may not be May. Todd asked Greg if the proposal should come to the CAC or the Handbook Committee or both. Todd felt the proposal should come from the CAC or Handbook since they are responsible for language in the NYSPHSAA Handbook. Josh asked if we can bring it to the February Executive Committee meeting for discussion. Todd stated yes and Robert can put it on the handbook committee meeting agenda and we'll also add it to the next CAC meeting agenda. Greg also suggested it go on Executive Directors meeting agenda. Kathy, as the Executive Director rep, will add it to the agenda for October.

Digital Participation Certificates at Regional/State Tournaments – Assistant Director Joe Altieri explained this is not a proposal yet but Girls Basketball State Committee unanimously agreed to recommending digital instead of paper certificates at Regional and State Tournament games. He stated it came up a couple years ago and didn't go anywhere and that this change would have to be for all sports or none so there is consistency. More information forthcoming on this topic.

Girls Wrestling Update – Assistant Director Todd Nelson reported Girls Wrestling qualifies as an emerging sport and will propose a number of items in the coming months including weight classes, sport standards and rules. This includes an invitational event in January 2023, the night before the boys dual meet championship in Syracuse. He noted a current issue is participation in the event. NYSPHSAA would like to limit the invitational to our member schools only, not include the Federation which participated in other girls wrestling competitions. Dr. Zayas stated we are in favor of only our member schools for numerous reasons including time constraints with the venue, unknown registrations and not having the opportunity to address logistics for the first event.

FOR REVIEW/INPUT/CHAMPIONSHIP SITE SELECTIONS:

Cross Country Site Selection 2024-26 – Joe explained the two bids from Letchworth State Park and Queensbury High School. He indicated both staff and state committee agreed on splitting the venues for the three-year bid. CAC expressed no concerns with the staff and committee recommending 2024 and 2026 at Queensbury and 2025 at Letchworth.
