#### Penhollow/MacSwan

The section is looking at a multi-tiered approached regarding the Recruitment and Recruitment of officials. It's too early to determine if the travel pay is beneficial.

With this proposal reimbursement will be given to only those schools that have breached the \$1500 threshold. Each Section VI school will be assessed \$125 in each fiscal year and reconciliation/reimbursement will be conducted in the following fiscal year after the data is compiled and finalized in the summer after the spring season. The \$125 is not static and the Finance Committee will review this annually as the number of schools that breach the \$1500 will vacillate. The Finance Committee would also review this process in its entirety each year, and if it's not working make changes.

With this proposal approved, each school will be assessed \$125 this 23-24 year (via the Section VI coordination fee coser). After the 23-24 completes and mileage is compiled, reconciliation will be made with the 24-25 dues.

The rationale is not to eliminate sectional championships, but rather balance classifications. The current policy is to split classes at 18 or more schools. In the sports of Girls Basketball, Softball, Baseball, and Girls Soccer there are typically a large number of schools that opt out. Over the past 2 years, there were 3 times classifications dropped below 18. Most importantly is to address the unbalanced classifications. For example, in 22-23 Girls Basketball, there were 9 Class B schools that opted out. One Class of B there was 12 schools. 16 in another. The concern of the coaches is that some schools must play more games than the other to reach the final.

#### APPENDIX E

## PROPOSAL 2 OFFICIALS MILEAGE COSTS

Of the 95 section VI high schools, 13 schools paid over \$1500 for the 22-23 school year for travel fees. Those districts paid in total, an extra \$11,425 combined.

It is suggested that the "cost of doing business" for every school district be set at \$1500. Meaning that all high schools would be required to pay up to \$1500 annually in travel fees for their individual district. (This does not include an initial \$125 fee)

Each high school would be responsible to pay \$125 annually into a "mileage fund" to the section. This would generate from the 95 schools: \$11,875. (To be paid at the start of a school year along with their section VI dues)

The districts that paid over the \$1500, would be reimbursed from the section for any fees incurred during the school year above and beyond the \$1500 threshold.

The "reimbursement" will likely be applied as a reduction to the section dues that affect those high schools, in the next fiscal school year.

#### APPENDIX F

Wrestling Proposals (Implementation 2024-2025)

- 1. Leagues / Coaches would like to have the opportunity to enter up to 15 wrestlers into the postseason with a maximum of two entries per weight class (both entries must have 6 separate contests on 6 separate dates with a better than .500 record). Most of the Sections across the state allow for more than 13 entries into the postseason.
- 2. Open Sectional event (with a 2 year pause on the Class tournaments). See the attached proposal at the end of this report.

Interest in hosting a post season tournament has been expressed by Albion (Class B) and Clarence (Class AA or Sectionals). **Perhaps Buffalo State University** would be an option for an Open Sectional?

## 2 YEAR PROPOSAL FOR PAUSING THE CLASS TOURNAMENTS IN SECTION 6 FOR WRESTLING

#### Rationale:

- 1. We have had several teams combine in Section 6 to create fewer programs. In 2022-23 we had only 19 Division 1 programs / teams (10 merged to form 5). We had 30 Division 2 programs (16 merged to form 5 programs).
- 2. Most teams cannot field an entire roster of 13 starters from week to week (several forfeits).
- 3. NYSPHSAA currently holds a "Dual State Team Championships". Each Section holds a true Championship team event that sends our best D1 and D2 teams to that "Dual State Team Championships. The Class tournaments, as they currently exist, do not accurately identify our best teams. A team can win the Class tournaments with 6 wrestlers (out of 13 weight classes).
- 4. By pausing our Class tournaments, teams will have a weekend off prior to an "Open" Individual State qualifier event (Sectionals). It is also one fewer weigh-in that needs to occur. In most cases, wrestlers would face the same athletes two weeks in a row for the Class and Sectional championships. By pausing our class tournaments (with the current low participation numbers; logistically, we now would only need to acquire facilities for the Sectional Championships. That in turn, would allow us to allocate our resources to provide a better championship experience for the athletes and coaches in an open sectional format. As part of this proposal to pause the Class tournaments temporarily; we shall revisit reinstating the Class tournaments for the 2025-2026 season based on our leagues' preferences.
- 5. If we do hold an open sectional for wrestling, the tournament can be scored; in which case we can still identify our Class level champion teams. Those teams (1st, and 2nd place in each class) will be recognized with the corresponding Sectional plaque award.

#### Proposed new individual qualifying procedures for Section 6 Wrestling:

2 weeks prior to the NYSPHSAA Individual State Wrestling tournament, Section 6 will hold its Individual Wrestling Championships (2 tournaments – D1 and D2). Schools may enter up to 15 wrestlers total with a maximum of 2 per weight class. If there are 2 entries in any weight class, **both** entries must have a minimum of 6 varsity contests (on 6 separate dates) with a better than .500 win-loss record. All matches (Public, Private, Catholic, Federation) will count towards a wrestler's record. The tournament will be standard double elimination. If there are more than

32 wrestlers entered in a weight class, the school whose "second entry" has the worst win-loss percentage" will be forced to move to another weight class or withdraw from the tournament. Additional tiebreaking criteria will be established in the event that there is more than one second entry with identical records (to resolve which wrestler has to leave the weight class with more than 32 entries).

The tournaments will be held over 2 days. In most cases, they will be Friday-Saturday events. Saturday-Sunday will also be considered based on the availability of the host sites. An ideal site would have the space for putting down 5-6 mats. A typical schedule will resemble the following:

#### **Friday**

10:00 am – 11:00 am Weigh-ins

12:00 noon Wrestling begins (32-man bracket)

A tentative schedule would be to wrestle 2 rounds forward in the championship bracket and 3 rounds back in the consolation bracket. This will allow for an early Friday departure. Wrestlers should not be competing in the later hours of the evening.

#### Saturday

7:30 - 8:30 am Weigh ins

9:00 Wrestling starts with the Quarterfinal round of 8

11:00 - Semi finals

2:00 – Consolation Finals (5<sup>th</sup>-6<sup>th</sup> place matches)

3:00 p.m. Finals (1st/2nd; 3rd/4th bouts run at the same time)

#### **Status Updates:**

- 1. Concussion Management Update BIANYS continues to work with the legislators to update the NYS Concussion Management Law. They are working with SED on language to identify who can clear a student back to participation, the current law states only a physician can clear.
- 2. Anyone Can Save a Life Starting with the 2024-2025 school year all teams will be required to complete the Any One Can Save a Life Program on submit the EAP to the athletic office. They will also be required to hold one drill prior to 50% of the season being completed. The current website (<a href="www.anyonecansavealife.org">www.anyonecansavealife.org</a>) is being updated and the current videos will be active in the month of October.
- 3. NYS School Health Cetner has updated information on the SED guidance for concussion management released this summer and the new CDC Youth Concussion course. The updated health history form is also available with the revisions to the Dominic Murray information.

#### Items Discussion/ Action Taken:

- SportGait Joel Meyer from SportGait gave a presentation on SportGait. SportGait offers new
  testing to help athletic trainers and doctors to evaluate individuals for concussion symptoms.
  These new tests go much deeper than the current Impact tests that many of our schools are
  using. Please see the attached document provided by Joel. If schools are interested in finding
  out more, they can contact Joel directly.
- 2. Thunder and Lighting Policy Members of the Safety Committee were asked to use the My Lighting Tracker to see how effective the app was in detecting lighting. Jarret Rhoades has actively used this app for the past 6 months as well as Jim Rose from Section 1. The app seems to be very reliable based on the data points used to detect lighting within a certain distance from the location of the user. Once lighting is detected then the user would have to monitor when the last lighting strike was through the app. The following motion was made by Tim Mullins and seconded by Mike Andrew.
  - i. The NYSPHSAA Safety Committee is recommending adding to the Thunder and Lighting Policy the use of the My Lighting Tracker app. Schools would be able to use the My Lightning Tracker app to detect lighting within 15 miles of the location of the game pr practice. If lighting was detected the current language would be followed and the practice or game would be suspended for 30 minutes until the last lighting strike was outside of the 15-mile range. Schools would choose to either use the current language of seeing lighting or hearing thunder or use the My Lighting App. The committee approved 9-0.



3. Modified Recommendations – The Safety Committee discussed two recommendations by the modified committee (removing the language in the NYSPHSAA Handbook regarding the one hand check in Boys Lacrosse and prohibiting metal cleats in the sport of softball). The Safety Committee did not have any concerns with either of these recommendations.

#### **Future Items/Meeting:**

- 1. Section 8 brought up a concern regarding the reliability of WeatherBug for the Heat Index Policy. The Section is asking if NOA may be a more reliable source. Section 8 will investigate further and report back to the Committee at the Spring meeting.

The NYSPHSAA Safety Committee is recommending adding to the NYSPHSAA Thunder and Lightning Policy the use of "My Lighting Tracker App". Schools would have to suspend or cancel any practice or game if the My Lighting App detected lighting within 15 miles of the location of the event. The event could not be resumed until 30 minutes had passed from the last lighting strike within the 15-mile radius. Schools would still be able to use the current system of seeing lightning and hearing thunder.

#### **Effective Start Date:**

Spring 2024

#### Rationale:

The current language requires schools that see lighting or hear thunder to suspend a game or practice for minimum of 30 minutes from the last time lighting was seen or thunder was heard. In many parts of the state lighting can be seen from a great distance away. The NCAA uses the range of 10 miles to suspend a contest or practice. The Safety Committee feels that a radius of 15 miles is appropriate for interscholastic sports. The committee is confident that the data points used by the app are reliable.

#### Proposal:

The NYSPHSAA Boys Volleyball Committee is seeking approval to revise the state tournament format to include all sections in the state tournament and increase the length of competition to two days.

#### **Effective Start Date:**

Fall 2025 Season

#### Rationale:

Our aim is to provide a state tournament that showcases the highest quality in the state of New York while also growing the sport and base across the state. Each section would have a representative showcasing their champion on the state tournament stage.

- All 7 sections would participate with a rotating at-large bid that will equally rotate around each section
  until all sections are included. This would include two representatives for the Division 1 and Division 2
  pools that would fall in accordance with the rotating bid. This will also allow us to have two four-team
  pools for round robin tournament play totaling 16 teams in the tournament.
- The at-large representative will be placed in an opposing pool from their section.
- Sections will be spaced out appropriately over a seven-year plan to take into account each rotation of the at-large bid.
- This proposal will also eliminate the need for a regional tournament and save sections on expenses and the need to find facilities. All sections will conduct their sectional contests and as the bid rotates to each section the sectional runner up will become the candidate for the respective at-large bid.
- This proposal will also be in these phases during the bid process and will need to take into account a three-court facility that can house the needs of the new format.
- This proposal will put the two divisions into a morning and afternoon wave for pool play.
- The second day of the tournament will go into semifinal play with a 3 out of 5 standard system of play.
- The final phase of the tournament on the second day will be the final results of the top two pool play winners advancing to a semifinal game and onto the finals.

The Boys and Girls Indoor Committees are seeking approval to add a second division for the  $4 \times 200$ ,  $4 \times 400$  and  $4 \times 800$  relays at the State Championships. This proposal does not apply to the Intersectional Relay.

#### **Effective Start Date:**

Winter 2024-25

#### Rationale:

Our committee discussed the difficulty of schools that would be considered Division 2 by enrollment numbers (under 600 students) to have a relay team qualify for the State meet due to the Indoor Track and Field State Championships utilizing only one division. The Committee felt strongly that Track and Field is an individual sport and would like to remain one division for individual events, but felt that relay events requiring more individuals is more difficult with less student athletes to draw from. Our committee brought this idea back to their Sections and the response from the Sections was overwhelmingly in favor.

#### Proposal Originated:

Boys and Girls Indoor Track Committees at their June 14, 2023 meeting

#### **Budgetary Impact:**

Sections will have an increased cost including transportation, lodging and meals for additional athletes (6 additional relay teams-3 Girls, 3 Boys). NYSPHSAA may have additional facility rental costs depending on how much additional time is needed in the venue to conduct Division 2 relays. NYSPHSAA will also incur an additional cost for awards and champion t-shirts for the Division 2 relay winners.

#### Notes:

The Girls and Boys Committee voted in favor of this proposal at its August 29, 2023 meeting. The Girls Committee was in favor by a 7-1 vote and the Boys Committee was in favor by a 6-1 vote. Of note, both "No" votes were based on concerns of limited facilities in their respective Section.



    - Wrestlers competing in any Boy's events, or practicing with a boy must be approved via the Mixed Competition Guideline approval process  $\rightarrow$  135.4.

**Call to Order** by Assistant Director Joe Altieri who chaired the committee today in the announced absence of Chair Greg Ransom. Joe welcomed the committee, introduced new Director of Sports Information Lexi Swatt and Fall Intern Jeremy Martelle. He offered Dr. Zayas any updates. None at this time.

Joe reported he had a conversation with Greg Ransom and office staff about streamlining CAC meetings. There is nothing in the Constitution or Role of CAC that says we are required to have a "discussion" and "action" phase. Going forward, we'll simply list all items as proposals and discuss one time and vote then everything will go to Executive Committee twice. Softball Regional Rotation 2024-2028 - Coordinator Jim Wright explained the proposal and why there were revisions since June/July. He noted it was revised so 16 teams in each class can be accounted for and fill the brackets. It also addressed small school issues. Eileen expressed a concern about the philosophy of 2<sup>nd</sup> and 3<sup>rd</sup> place teams getting beat in Sectionals and going to Regionals. The proposal nearly had the same number of 2<sup>nd</sup> and 3<sup>rd</sup> place team as champions. Todd asked if this was an effort to try to achieve equity. Jim stated it was. Eileen opposed adding 49 teams to the regional postseason. Jim indicated it's a huge change but addresses equity with sub-regionals. Joe noted softball was charged with developing a six-class rotation and address equity over the last several months. Softball did so and nobody expressed concerns about the proposal at the Central Committee meeting. Todd asked if it falls within the championship philosophy of 5-8% of all participating teams. The proposal does not (its at 16%). Todd asked if the rotation can mimic Class AA regional rotation for Class AAA. Eileen noted with all the moving parts in six classes, we need to experience a year of that first. Joe offered to work with Jim immediately following the meeting on updating the proposal to mirror Class AA for 2024 only. He recognized many athletic council meetings have already occurred or are coming up quickly before the next Executive Committee meeting.

MOTION by Jamie to support the proposal. SECOND by Adam. DEFEATED 1-8. (Susan in favor)

**Boys/Girls Tennis Seed Team State Tournament -** Coordinator Quan Hyunh explained the proposal. No questions/concerns were raised.

MOTION by Jamie to support the proposal. SECOND by Kathy CARRIED. 10-0.

Boys Team Tennis Move to 2-3 Format for D2 - Coordinator Quan Hyunh explained the proposal. Kathy asked about formats for this year for girls tennis in November. Quan stated girls are 3/4 in D1 and 3/2 in D2 this fall. Deb asked why the 6-4 vote. Quan explained four sections were opposed to the emphasis on doubles. Some sections voted on quality of teams in their sections because they run formats that cater to strong singles players. Since the NYSPHSAA Individual Tennis Championships already caters to elite individuals, the move to 2/3 for D2 would cater to team play.

Indoor Track 2<sup>nd</sup> Division for Relays- Coordinators Kristin Frazer and Bob Wallen explained the proposal. Susan asked about the effective start date and the timeline for discussion/proposal at the next Executive Committee. Kristin noted they respect the timeline and process and seek implementation for 2024-25. MOTION by Adam to support the proposal. SECOND by Jamie. CARRIED 10-0.

### **Baseball Tiebreaker Proposal**

#### **Concern:**

The current tiebreaker rules are too general and don't take into account the various differences between sports. This leads to several seeds being determined by coin flip and not by the performance of the teams.

#### **Proposal:**

The baseball committee believes that the following tiebreaker rules are more appropriate to baseball and will reduce the need to determine seeding by coin flip.

- 1. Overall league winning percentage
- 2. Head to head results
- 3. Head to head run differential, not to exceed 10 runs in a given game
- 4. Results versus common opponent
- 5. Coin flip

#### **Rationale:**

To put in place a tiebreaker system that is more sport specific and takes into account aspects of the sport that have a direct impact on seeding.

#### **Baseball Championship Series Proposal**

#### **Concern:**

As a result of adding a sixth class (AAA), 2 problems exist in our current sectional tournament model:

- 1. Schools that compete in classes with 4 or fewer schools are spending a significant amount of time waiting between games.
- 2. A school could win a sectional championship only competing in one game.

#### **Proposal:**

Due to the addition of a sixth class (AAA) and redistribution of teams among the remaining classes, we propose a best of three championship series to determine a sectional champion in classes with 4 or fewer schools.

The structure of this championship series would be as follows:

- 1. Each team would compete in a play-in game during the pre-quarter round of sectionals. In this round the number 1 seed would play the 4 seed and the 2 seed would play the 3 seed. Games would be played at higher seeded schools.
  - a. If there are only 3 teams in the class, the number 1 seed would automatically move to the championship series and the 2 seed and 3 seed would compete in a play-in game.
  - b. If there are only 2 teams in the class, both teams would move to the championship series.
- 2. Game 1 of the championship series would be played at the higher seeded school during the quarter final round of sectional play.
- 3. Game 2 of the championship series would be played at the lower seeded school during the semi-final round of sectional play.
- 4. If necessary, the final game of the championship series would be played at a neutral site on our sectional championship day. The site would be determined by the baseball committee.

#### **Rationale:**

The committee believes that this proposal would create a competitive balance between the schools in small classes and thus produce the best possible Sectional Champion.

All suggestions were shared with the Executive Committee at two different meetings. The Executive Committee supported the following:

#### **SUMMARY OF RECOMMENDATIONS**

#Article 4: It is the expectation of all council members that they communicate action items and the results of said items, to their constituents.

#Article 4: All Section VI committees will be made up of one voting member from each league.

#Article 6: It is the expectation of the Athletic Council and Executive Committee that leagues MUST assign a female to the role of Girls Representative, unless there are extenuating circumstances. Those circumstances must be submitted annually to the Executive Director

#Article 6: For business to occur, four (4) of the five (5) Leagues must be represented by two or more of their four representatives.

#Article 8: Each league will have representation on the Executive Committee. If a league is not represented within the confines of the seven positions included in the Committee, that league will be asked to recommend to the members of the Executive Committee, a person to sit in an At-Large position. The At-Large representatives will have full voting privileges while serving on the Executive Committee. At-Large terms are for one year.

If at any point, a league does, through election or appointment, have a person join the Executive Committee, the At-Large position will be vacated immediately.

#The Past President sitting on the Executive Committee would become a full voting member on all action items. Currently the Past President sits in an ex-officio role and cannot make motions, second other motions or vote.

#### TIMEFRAME MOVING FORWARD

- 1) The revised Constitution will be an Action Item for the Council's November Meeting. Changes will be effective beginning with fiscal year 2024-25.
- 2) The standing committee will schedule sessions to begin reviewing the 2) Bylaws and 3) Policy Manual.
- 3) Goal is to present the first reading of the Bylaws at the January AC Meeting with a vote in March.
- 4) Goal is to present the first reading of the Policy Manual at the March AC Meeting with a vote in May.

#### Philosophy of Section VI

A united action by member schools in Section VI is necessary in order to have a successful athletic program.

While the athletic program in Section VI strives to exemplify the basic principles of the democracy in which we live by providing for each student-athlete an opportunity to progress to the limit of their capabilities and interests, it must also maintain a commitment to excellence.

We strive to provide student athletes with an environment that promotes wholesome growth and development, stressing our belief in the democratic way of life, encouraging mental and physical alertness and independent thinking. We try to impress the student-athletes with the idea that we expect them to do their best.

It is our philosophy that we should help prepare our student-athletes for life and attempt through athletics to provide an educational experience to assist them in becoming contributing members of society.

Utilizing this philosophy, it is the firm belief of Section VI that:

- 1. ALL students are important and meeting the needs of these students is the challenge to all within the educational community.
- 2. In meeting the needs of the many different public schools of our Section, we must provide interscholastic athletics and coordinated services that are controlled by schools, leagues and the Section.
- 3. Each school is expected to appreciate the fact that everyone cannot be totally satisfied on any given issue but that all schools through a viable system of representation can help to develop the pattern for sound educational policies for interscholastic athletics.
- 4. It is of primary importance to delegate authority in this complex program and it is this delegated leadership that helps to set the pattern for a "State Wide" program of athletics.

## **Mission Statement**

It shall be the purpose of Section VI to formulate, adopt, and implement policies that will enable the Section to administer and govern interscholastic athletics in a safe and appropriate manner in accordance with the New York State Education Department, the New York State Public High School Athletic Association and Section VI. Further, it is the Section's commitment to work collaboratively with all members and with a goal of inclusivity in all of the association's work.

# Core Values that guide the decisions made by Section VI

- \* Interscholastic activities programming is part of the wider educational program. Educational programs are created to develop the learner. Athletics provide opportunities for students to participate in activities that assist in their development socially, intellectually, and emotionally.
- \* All students are important and deserve competitions that are a result of coordinated services that are safe, fair and inclusive. The Section VI program of offerings should be broad-based, well planned and designed to honor excellence.
- \*The Section will be organized in a manner that ensures a viable and fair system of representation with the goal of making sound educationally-centered decisions. Policy development, assessment, evaluation and future revisions must include opportunity for input from all leagues. Each league must consider a diverse group of representatives when filling committee or otherwise leadership positions.

# **Goals and Objectives**

- \*To provide and promote safe and equitable participation opportunities.
- •To offer championship programming that encourages and reinforces broad-based opportunities.
- \*To foster positive working relationships with all community partners.
- Maintain the standards of eligibility of the NYSPHSAA and State Education Department in an effort to maintain ethically and educationally sound programming
- \*To protect the fairness of competitions and ensure that all member schools are competing under the same rules and regulations.
- Provide the means to settle disputed athletic contests or violation of policies amicably and authoritatively
- \*To work with all leagues in Section VI to foster continuous professional development and support for all athletic administrators.
- \*To offer consistency in services, direction and support to our athletic administrators and to the Executive Directors of each league.
- To conduct athletic championship tournaments that emulate and honor excellence
- Adapt rules to cover sports contests and to support the rule changes creating safer environments for all student-athletes
- Coordinate and work collaboratively with all officials' organizations to enrich our athletes experience and better service member schools.

# **CONSTITUTION**

# Article 1 - Name

- 1.1 The name of this organization will shall be Section VI of the New York State Public High School Athletic Association, Incorporated.
- 1.2 All Athletic Council and Executive Committee meetings will be conducted using Roberts Rules of Order.

## Article 2 - Purpose

- 2.1 The public high schools in Section VI will provide a central association through which schools will receive coordinated services, support and oversight cooperate with the following objectives:
- 2.1.1 2.1.4 To strengthen the educational goals of the public schools by developing fostering and promoting good sportsmanship and high ideals among contestants, and teams, coaches, schools and spectators.
- 2.1.2 2.1.1 To promote a sound athletic program for secondary students and make recommendations in the interest of the general welfare of Section VI athletes.
- 2.1.3 2.1.2 To recognize, strengthen and unify eligibility rules governing participation in inter-school athletics in each league of the Section.
- 2.1.4 2.1.3 To plan for and conduct all sectional athletic activities through its appointed leaders and governing body and arrange for, necessary, entrance to participation into intersectional and statewide competition.
- 2.1.5 To enforce the constitution, Bylaws, rules, regulations and game standards adopted by NYSPHSAA, Section VI, the State Education Department and the Leagues within the Section.

# Article 3 - Membership

- 3.1 In Section VI, a public high school (including Charter Schools) must be a member of Section VI in order to also be a member of the NYSPHSAA. New Schools that are not yet members must apply through the Section VI Office Athletic Council and will require support from the Athletic Council in the form of a vote of membership.
- 3.2 Non-public schools will select one (1) representative from the private schools and one (1) representative from the parochial schools to attend Athletic Council meetings as guests of Section VI.
- 3.3 3.2 Advisory Athletic Council Superintendents, High School and Middle School Principals, Athletic Directors of member schools are members of the Advisory Athletic Council of this Association. and The Council may be convened at the pleasure of the President. They Council members are eligible to serve on committees and can make recommendations to the Athletic Council on all matters pertaining to the conduct oversight and functioning of interscholastic athletics.
- 3.4 3.3 Member schools of the Section agree to abide by the eligibility rules adopted by the NYSPHSAA Central Committee and State Education Department.
- 3.5 3.4 Any school or school personnel/representative violating the constitution, Bylaws, amendments, rules, regulations and game standards of the Section may be barred from participation in any of the interschool athletic activities for up to a period of one year by the Athletic Council, or the Executive Committee, when the Athletic Council is not in session. Additional penalties may be determined by the Athletic Council as deemed appropriate which may include but are not limited to financial penalties and / or suspension.
- 3.5 Membership shall require that each school pay applicable dues to Section VI Athletics, NYSPHSAA, Inc.
- 3.6 Each League is the basis of the organization and represents its member schools.

## Article 4 - Membership Voting-Representation

- 4.1 4.2 When determined necessary by the Executive Committee or Athletic Council, member districts will may be called upon to vote by postcard ballot. Ballots will be sent to the Superintendent of Schools. Voting privileges will be based on membership from June 30-July 1 of the current year. Each district will have only one (1) vote on any single proposition. A simple majority of districts voting is required to pass a resolution.
- 4.2 4.3 Financial matters requiring local Board of Education approval must be submitted brought to a postcard ballot of all member districts schools. A majority vote of districts voting is required to pass a resolution.
- 4.3 4.1 Each member school in good standing must be a member of a league. Each league has four voting representatives on the Athletic Council; a Boys' Representative, Girls' Representative, Principals' Representative and Superintendents' Representative or designee.

The Buffalo Public School's may have the Assistant Superintendent for Athletics or their Superintendent of Schools serve in the position of Superintendent's Rep for their group of schools (league).

Each league will choose alternates for each position noted. The Section Office will be notified of these designations by July 1<sup>st</sup> of each school year and within fifteen (15) days of any change.

It is the expectation of all council members that they communicate action items and the results of said items, to their constituents.

4.4 Each sport committee All Section VI committees will be made up of have one voting member from each league. In addition, a Sports Chair (not co-chair) has a vote on their sport committee The Chair only votes in cases of ties. Assistant Chairs and Co-Chairs do not have any voting privileges.

The representation clause applies to all committees and is not limited to; sports, standing, adhoc and selection

4.5 BOCES Superintendent Representation: One Superintendent Representative from each BOCES located within the Section will be a member of the Athletic Council.

#### Article 5 – Athletic Council Officers and Duties

5.1 The Athletic Council of Section VI will elect a President and President-Elect. They will be elected at the Annual May Meeting and take office on July 1.

NOTE: The nominating committee will whenever possible endeavor to have nominations for the above offices from the respective leagues within the Section on a geographical rotation plan. Three regions — North, South and Central — The President and President—Elect should be from two of the three regions in sequential rotation if feasible; North, South and Central, in this order. Additionally, consideration should be given to a rotation between leagues in each region should be on an alternating term basis when possible.

North: Niagara Frontier League and Niagara Orleans League

South: Chautauqua Cattaraugus Athletic Association

Central: Buffalo Public Schools and Erie County Interscholastic Conference

# 5.1.1 PRESIDENT

- 5.1.1.1 Any member of a professional staff of a member school in good standing, who has served in some capacity on the Athletic Council or who has served as President or President-Elect prior to the election, may serve.
- 5.1.1.2 Term of office two (2) years.
- 5.1.1.3 Presides at all meetings and performs such duties as assigned to the Office of President, which will include providing oversight in developing and mailing of an agenda to the members of the Athletic Council at least one week in advance of the each meeting.
- 5.1.1.4 Has a voice and a vote on all issues and a vote.
- 5.1.1.5 Succeeds to the Presidency from the position of President-Elect.
- 5.1.1.6 In the event that the President-Elect is unable to serve as President, a special election of the Athletic Council will be held to elect a President.
- 5.1.1.7 Special Meetings The President may call special meetings of committees, committee chairs, the Executive Committee or the Athletic Council for the purpose of explaining and discussing amendments submitted to member schools or for the purpose of considering the policies and procedures of leagues, federations, the Section or the State Association.

#### 5.1.2 PRESIDENT-ELECT

- 5.1.2.1 Any member of a professional staff of a member school in good standing who is League endorsed and has served in some capacity at the Athletic Council level prior to their election may serve.
- 5.1.2.2 Term of office two (2) years.
- 5.1.2.3 Succeeds the President at the expiration of his the two-year term.
- 5.1.2.4 Presides at all meetings in the absence of the President.

NOTE: In the event that both President and President-Elect are absent, a member of the Central Committee, designated by the President, may serve as Chairperson.

5.1.2.5 Election Elected by voting members of the Athletic Council. Has a voice and a vote on all issues and a vote.

In the event that the position of President-Elect is vacated, a special election by the Athletic Council will be held.

- 5.1.3 Executive Director
- 5.1.3.1 This person will report to the Athletic Council Executive Committee of Section VI which is comprised of the following positions:
  - \*President
  - \*President Elect
  - \*Past President
  - \*Superintendent's Representative to the NYSPHSAA Central Committee
  - \*Principal's Representative to the NYSPHSAA Central Committee
  - \*Boy's Representative to the NYSPHSAA Central Committee
  - \*Girl's Representative to the NYSPHSAA Central Committee

The job description of the Executive Director and duties are listed in the Bylaws.

5.1.3.2 Maintains Has a voice on all issues but has no vote.

## Article 6 - Athletic Council

- 6.1 The governing body of the Section VI New York State Public High School Athletic Association will be the Athletic Council.
- 6.1.1 **LEAGUE** OFFICERS The officers of the Athletic Council from each league will be the same as those elected to office of this Association (Section VI).
  - 6.1.2 MEMBERS The Athletic Council will consist of:
    - 6.1.2.1 President
    - 6.1.2.2 President-Elect
    - 6.1.2.3 Past President
    - 6.1.2.4 Four (4) Central Committee Members
    - 6.1.2.5 League/BOCES Representatives (22)
- 6.1.2.5.1 Member Schools in Section VI will be represented on a League/BOCES basis as follows, subject to any change approved by the Athletic Council:
  - 6.1.2.4.1.1 Buffalo Public League
  - 6.1.2.4.1.2 Chautauqua Cattaraugus Athletic Association
  - 6.1.2.4.1.3 Erie County Interscholastic Conference
  - 6.1.2.4.1.4 Niagara Frontier League
  - 6.1.2.4.1.5 Niagara Orleans League
- 6.1.2.4.1.6 Superintendent Representative from each BOCES (4) (geographical purposes only).
- 6.1.2.4.2 New Schools Schools entering Section VI after September 1, 1976 will be assigned to an appropriate league by the Athletic Council at the first meeting following acceptance by the member schools.
- 6.1.2.4.3 Number of Representatives There will be four (4) representatives from each of the leagues selected by the member schools in each league.
  - 6.1.2.4.4 Election of League Representatives
- 6.1.2.4.4.1 Representatives will be elected to four (4) year terms and will include the following:
  - 6.1.2.4.4.1.1 Boys Rep of Athletics
  - 6.1.2.4.4.1.2 Girls Rep of Athletics
  - 6.1.2.4.4.1.3 Principals Rep
  - 6.1.2.4.4.1.4 Superintendent Rep
- 6.1.2.4.4.2 The Superintendent Rep and Girls Rep will be elected in the even years and the Boys Rep and Principals Rep will be elected in the odd years.
- 6.1.2.4.4.3 Superintendents Reps will be appointed by the District Superintendents' respective BOCES and serve a four-year term.
- 6.1.2.4.4.4 It is the expectation of the Athletic Council and Executive Committee that leagues MUST assign a female to the role of Girls Representative, unless there are extenuating circumstances. Those circumstances must be submitted annually to the Executive Director **EXECUTIVE COMMITTEE SUPPORTS**

- 6.1.2.4.5 Direct Access Each of the representatives will be a member of his/her respective group and therefore, would become ineligible to complete the terms of office if job status changes. (The Superintendent from Buffalo may be represented by the Director of Health, Physical Education and Athletics).
- 6.1.2.4.6 Alternates Each League/BOCES will submit to the Athletic Council President the name of an alternate for each representative who would function as the representative in the event the duly elected representative is unable to attend a meeting of the Athletic Council. This alternate will possess the same qualifications and voting rights as the representative.
- 6.1.3 Past President The immediate past-president of this Association will have full voting privileges.
  - 6.1.4 Duties The Section VI Athletic Council will:
    - 6.1.4.1 Supervise and formulate policies for sectional athletic activities.
    - 6.1.4.2 Review member infractions as brought forth by the appropriate committee
    - 6.1.4.3 Approve the annual budget submitted by the Finance Committee.
    - 6.1.4.4 Have the power to act upon all matters not covered in the Constitution and Bylaws
- 6.1.5 <u>Superintendent Advisory Council Meetings</u> Advisory Council meetings of only Superintendents and the Executive Committee may be held at called at any time by the President but should meet prior to the November meeting of the Athletic Council for the purpose of presenting recommendations and/or concerns for future consideration to the Athletic Council. No action can be taken or voted on at these Advisory Council Meetings.
  - 6.1.6 Quorum and Voting Procedures for the Athletic Council Meeting
- 6.1.6.1 Regular Business may be conducted with fifty (50) percent of the League/BOCES representatives present including Executive Committee and
- 6.1.6.2 For business to occur, four (4) of the five (5) Leagues must be represented by two or more of their four representatives.
  - 6.1.6.3 A simple majority vote is required for action.
- 6.1.7 Each member of the Athletic Council who has voting power will have only one vote on any proposition. Voting in absentia is not allowed.

# Article 7 - Section VI Sport Chairperson

7.1 The rotation and appointment of Sport Chairpersons will be as follows and will be the duty of the Executive Director to establish and maintain the rotation for the Athletic Council.

**For Fall:** Sport chairpersons in football, cross country (B&G), soccer (B&G), field hockey, gymnastics (B&G), volleyball (B&G), swimming (G) and tennis (G) are elected for a three year term.

**For Winter:** Sport chairpersons in basketball (B&G), bowling (B&G), (B&G) ice hockey, indoor track (B&G), rifle, swimming (B) and wrestling are elected for a three term.

**For Spring:** Sport chairpersons in baseball, softball, track (B&G), tennis (B), lacrosse (B&G), and golf (B&G) and girls flag football are elected for a three-year term.

- 7.2 The Sport Chairperson will be appointed to a three (3) year term by the Athletic Council from applicants. The President Elect on the Athletic Council serves as Nominations Chair and will convene interviews for Sports Chair positions. One-third of the Sport Chairpersons will be appointed annually according to the following rotation:
- 1. Fall Sport Chairpersons
- 2. Winter Sport Chairpersons
- 3. Spring Sport Chairpersons
- 7.3 Any member in good standing, active or retired, of the professional staff of a member school may serve as a Sport Chairperson.
- 7.4 There will be one Sport Chairperson for each sport (Boys and Girls) and committees may have an assistant Chairperson approved by the Athletic Council.
- 7.5 Each Sports Committee will have a representative from each participating league.
- 7.6 The representative members on each sport committee will be appointed by each league and have only one vote per league. Other non-voting members may be selected by the Sport Chairperson.

Federated sport representative members that are appointed by their division, league or school will have only one vote. The Sport Chairs of Federated Sports that have divisions will verify that among division representatives each participating league is represented.

The Sport Chair may only vote when the vote is tied. A Sport Chair who also represents a league can serve in both capacities but will have only one vote.

7.7 Each Sport Chairperson and his representatives are responsible for the organization of their sport and will report to the Executive Director and be subject to review by the Athletic Council. The Chairperson must follow the approved sport rules, rules of the Commissioner of Education and the NYSPHSAA.

- 7.8 Each sport chairperson will organize and conduct a sectional post-season tournament and enforce the policies and the rules governing each sport as authorized by the Athletic Council. All such rules will be incorporated in the Bylaws of Section VI. Any sport changes must be approved by the Athletic Council.
- 7.9 Each sport chairperson will prepare a written report of their sport and forward a copy to the Executive Director and State Sport Chairperson of that particular sport not later than twenty (20) days following Section VI playoffs.
- 7.10 Each sport chairperson will report to the Athletic Council at designated meeting(s). The Sport Chairperson may request placement on the agenda via the Sectional-Intersectional Committee.
- 7.11 Each sport chairperson will prepare a sports policy booklet which will be updated annually. These policies will be submitted to the Executive Director and Sectional Intersectional Committee for review and forwarded to the Athletic Council for approval.
- 7.12 The Athletic Council will fill an unexpired term of a sport chairperson.
- 7.13 Participation in intersectional and statewide contests must be approved by the Athletic Council.
- 7.14 The sport chairperson will be the official sectional representative of their sport and will make decisions relative to the sport in the best interests of the Section, subject to review by the Athletic Council.
- 7.15 Each sport chairperson will prepare and present a budget for the following year to the Finance Committee. The Finance Committee will distribute the proposed budget to the Athletic Council at the November meeting with a vote on the proposed budget for the following year to be held at the January meeting.
- 7.16 Each sport chairperson will develop a description and time line of their duties which will be given to a subsequent chairperson of that sport. A retiring chairperson will be expected to act in an ex-officio capacity for one year.
- 7.17 The Sport Chairperson will be responsible for securing appropriate and safe venues for sectional competition which are prepared according to the sport rule book. Sports Chairs must do everything they can in the planning stage to help ensure the environment is safe and the facility is appropriate. They will be expected to contact the Executive Director if concerns are warranted.
- 7.18 Each sport chairperson will have a games committee for each sectional contest. This committee is authorized to act as a protest committee. Protest procedures must be written and followed.

## **Article 8 Executive Committee**

- 8.1 The Executive Committee will consist of the President, President-Elect, the four (4) Central Committee Members, the Executive Director and BOCES representative Past President??? will be ex-officio and have no vote. The officers and Central Committee members are authorized to vote on all matters of the Athletic Council.
- 8.2 The Executive Committee will have general management of Section affairs during the interval between meetings of the Athletic Council. It will have the jurisdiction in all matters not covered by the Constitution or Bylaws, appeals, protests and questions of eligibility when the Athletic Council is not in session.
- 8.3 A majority of the committee constitutes a quorum
- 8.4 The Executive Committee will meet 11 times each year and at special meetings that may be called by the President or requested by a majority of member districts.
- 8.5 Each league will have representation on the Executive Committee. If a league is not represented within the confines of the seven positions included in the Committee, that league will be asked to recommend to the members of the Executive Committee, a person to sit in an At-Large position. The At-Large representatives will have full voting privileges while serving on the Executive Committee. At-Large terms are for one year.

If at any point, a league does, through election or appointment, have a person join the Executive Committee, the At-Large position will be vacated immediately.

# <u>Article 9 - Central Committee Representatives</u>

- 9.1 The Central Committee representatives will be elected by the Athletic Council for fouryear terms and will include a Superintendent, Secondary School Principal, Boys Rep of Athletics and Girls Rep of Athletics.
- 9.2 The Central Committee Members will have a voice on all issues at the Athletic Council meetings and voting privileges. (9/21/77)
- 9.3 Per N.Y.S.P.H.S.A.A. Handbook Note: persons retiring from active public education employment, currently serving on the NYSPHSAA Central and/or Executive Committee, will be permitted to continue for the duration of their tenure and also be permitted to serve in that capacity for one more term if elected by the Athletic Council.

# Article 10 - Amendment Procedure

- 10.1 The <u>Constitution</u> may be amended by a two-thirds (2/3) vote of the member districts voting.
- 10.2 Process
- 10.2.1 An amendment must be in writing to the Executive Director by January 1. A copy will be provided for each Athletic Council member.
- 10.2.2 An amendment must be approved by a two-thirds (2/3) vote of the Athletic Council members voting after it has been laid on the table been presented to the Athletic Council and considered for at least one Council meeting and each league has the opportunity to discuss. following its introduction to the Athletic Council.
- 10.2.3 The Executive Director after an approval of an amendment by the Athletic Council, must notify all member districts of the proposed amendment.
- 10.2.4 Each member district will submit a vote on a signed ballot. The ballot will be distributed by the Executive Director. A voting district must return the ballot within thirty (30) days from the date of mailing. In rare cases and due to circumstances the Executive Director may shorten the voting response time.
- 10.2.5 Approved amendments will take effect at the indicated effective date.
- 10.3 The <u>Bylaws</u> may be amended by a two-thirds (2/3) vote of the Athletic Council members voting.
- 10.4 Process
- 10.4.1 An amendment to the ByLaws must be in writing to the Executive Director by January 1.
- 10.4.2 An amendment must be approved by a two-thirds (2/3) vote of the Athletic Council members voting after it has been laid on the table been presented to the Athletic Council and considered for at least one Council meeting and each league has the opportunity to discuss, following its introduction to the Athletic Council.
- 10.4.3 The Executive Director, after an approval of an amendment by the Athletic Council, must notify all schools of the amendment.
- 10.4.4 Approved amendments will take effect at the indicated effective date.

# Article 11 - Grievance/Appeal Procedure

11.1 <u>PURPOSE</u> - The purpose of these procedures is to provide a means for systematic and prompt resolution of differences and to assure equitable and proper treatment of grievants in accordance with the term of this Grievance/Appeal Procedure. Every effort to resolve the grievance/appeal should be made at the earliest possible stage.

# 11.2 <u>DEFINITIONS</u>

- 11.2.1 State Association -The New York State Public High School Athletic Association
- 11.2.2 Athletic Council The Section VI Athletic Council
- 11.2.3 Central Committee members Four members elected by the Athletic Council consisting of a Superintendent, Principal, Girls Rep of Athletics and Boys Rep of Athletics.
- 11.2.4 Days Calendar days
- 11.2.5 Executive Committee The Executive Committee will consist of the President, President-Elect and the four (4) Central Committee Members. The Executive Director will be ex-officio.
- 11.2.6 League A group of schools who join together for the purpose of administering athletic competition and other educational activities within their respective league.
- 11.2.7 Federation A group of member schools that join together for the purpose of administering athletic competition and other related educational activities outside the jurisdiction of a league.

Jurisdiction and governance of all federated interscholastic athletic activities will be the direct and sole responsibility of Section VI.

A federated interscholastic sport may include, for competition purposes, non-member schools, but their status remains as non-member schools of the Section.

Non-member schools planning to participate must seek and be granted written approval by their respective State Organizations.

- 11.2.8 Section Section VI
- 11.2.9 State Executive Committee Twenty-two members of the Central Committee, ex-officio members and the officers of the State Association.
- 11.2.10 Grievance An undesirable competitive situation or an appeal of decision at any stage of the Grievance Procedure.
- 11.2.11 State Central Committee The legislative body of the State Association which consists of four members elected by the Athletic Council of each Section, including a Superintendent, Principal, Girls Rep of Athletics, Boys Rep of Athletics and elected officers and ex-officio members.

# 11.3 GRIEVANCE/APPEAL FORMS

# 11.4 <u>STAGE 1:</u>

If the opinion of school administration personnel (Superintendent, Principal, and Athletic Director) is that an undesirable competitive situation exists, a grievance may be presented for review to the league involved. Cases of eligibility and differences between schools may be referred to the League President. The League President will be guided by the Constitution, Bylaws, rules, regulations and sport standards of the league, Section and State Association.

- 11.4.1 In the case where a school does not belong to a league, it may present its grievance for review and decision to the Section President.
- 11.4.2 In the case where a grievance involves a sectional activity, it may be taken directly to Stage 2.

# **SPECIAL NOTE:**

Any and all questions and/or protests as to game/meet rules or to the conduct of the game/meet, will be heard and decided by the game/meet committee established by the Section. Their decision will be final.

## 11.5 STAGE 2:

If the grievance is not satisfactorily resolved at Stage 1, an appeal may be made within fourteen (14) days (after receipt of Stage 1 decision) to the Section Appeals Committee which will review the evidence, hear arguments and have the power to affirm, reverse or modify the decision of the League or Section President or Executive Director.

- 11.5.1 All such appeals must be submitted in writing and signed by the Superintendent, Principal and Athletic Director and must be submitted to the Section Executive Committee via the Executive Director.
- 11.5.2 All such appeals must be accompanied by a certified or school district check, in the amount of \$300. This check will be returned to the school district only if the original decision is overturned.

### 11.6 <u>STAGE 3</u>:

If the grievance is not satisfactorily resolved at Stage 2, a further appeal may be made within fourteen (14) days (after receipt of Stage 2 decision) to the Athletic Council which may hear arguments and has the power to affirm, reverse or modify the decision of the Appeals Committee.

- 11.6.1 This stage must be submitted in writing and signed by the Superintendent, Principal and Athletic Director and sent to the Athletic Council via the Executive Director.
- 11.6.2 All such appeals must be accompanied by a certified or school district check, in the amount of \$300. This check will be returned to the school district only if the original decision is overturned.

# 11.7 <u>STAGE 4</u>:

If the grievance is not satisfactorily resolved at Stage 3, a final appeal may be made to the Appeal Panel of the NYSPHSAA in accordance with the provisions of the State Handbook under Appeal Procedures.

- 11.8 Executive Committee/ Athletic Council Appeal Panel Format
- 1. Introduction / Review Format

Reminder: The Appeal Panel will not reverse or modify decision unless it finds that:

- a) The decision is contrary to the evidence presented.
- b) The facts presented constitute a violation of the Association's Constitution, standards or rules, Regulations of the Commissioner of Education.
- c) A procedural error affected the reliability of the information that was utilized to support the finding.
- 2. Oral Presentations \*
- a) Appellant (15 minutes)
- b) Respondent (15 minutes)
- Questions by Panel
- 4. <u>Closing Oral Summations</u> (5 Minutes)
- 5. <u>Deliberation by Panel</u>

A written decision will be rendered within five school days of the hearing.

- \*Oral presentations will only be heard from the designated Appellant/ Respondent representatives. Oral and written presentations will be limited to that presenting during the initial appeal.
- 11.9 Any school or league which institutes an unsuccessful legal action or appeal to the courts or the Commissioner of Education to overturn, stay or enjoin any decision, ruling or rule or rules of the Section or the NYSPHSAA will be liable for costs and attorney's fees incurred by the Section in defending against such action. Further, should the Section be forced to initiate legal action to collect the aforementioned costs and attorney's fees, the member school or league shall be additionally liable for the Section's reasonable cost and attorney's fees resulting from the collection action.

## Article 12 - Classification

- 12.1 Starting with the school year 1979-80, member schools will follow New York State Public High School Athletic Association attendance reporting method procedure to determine their classification for sectional competition.
- 12.2 Classifications for post-seasonal competition will be established by the NYSPHSAA
- 12.3 Schools must compete within their sectional classification numbers for all sports. except Ice Hockey. In the sport of Ice Hockey, teams may move up from the small school division to the large school division. The Ice Hockey exemption will be re-evaluated annually-
- 12.4 No school may be a member of more than one State Athletic Association.
- 12.5 Enrollment figures distributed by the NYSPHSAA will be used for State Classification each year.
- 12.6 Classification will be based on enrollment procedures established by the NYSPHSAA.
- 12.7 Sections may have more than one local classification division per state classification dependent on number of schools but for state competition purposes must submit one team per state classification.
