9.1 NYSPHSAA (T. Nelson & R. Zayas)

- This weekend is the 3rd weekend of state championships, NYSPHSAA's goal is to be provide a great atmosphere and make the experience memorable for those involved.
- At the last NYSPHSAA meeting, the Championship Philosophy Committee was charged with reviewing the awards system. This will be a discussion item at the January 2025 NYSPHSAA meeting.
- 9.1.1 Schools Without Boundaries Report (M. Fallacaro-Dougherty) Appendix F The Schools Without Boundaries Committee is tasked with seeking resolution for placement of private school/charter schools. NYSPHSAA is concerned that taking certain actions could negatively impact the association via lawsuit or legislative action.

NYSPHSAA provided the Schools Without Boundaries Committee data to begin discussions. As of 2016, private/charter schools were winning less than 10% in all sports and just a little over 10% in the 6 class sports and football.

Last school year, the private schools won 4 out of the 6 state girls basketball championships, which is believed to have precipitated this discussion.

9.1.2 DEI Committee Report (A. Lloyd) Appendix J

The NYSPHSAA DEI Committee is comprised of representatives from each section and members of NYSPHAAA. They have convened 4 times since February 2024. The next meeting is scheduled for December 2024.

11.1 Girls Basketball Semi-finals

Last year, East Aurora brought up a concern involving equitability specific to boys and girls basketball semifinals venues. M. DiFilippo, K. Schon, D. Lilleck, and M. Donahue met with East Aurora representatives to hear their concerns. Buffalo State, which traditionally hosts boys basketball semifinals, is not able to accommodate girls basketball semifinals this school year. Therefore, Maryvale, Ken-Ton, Lancaster, and a couple local colleges/universities have been looked at as an alternative was the recommendation. But knowing a resolution is still needed, M. DiFilippo and K. Schon, in collaboration with the basketball chair people, are working on a recommendation for 25-26 with action from the athletic council before the end of this 24-25 school year.

12.1 3-Region Concept (Appendix H)

Members were asked to review the data on this item in the corresponding appendix, discuss with their respective leagues, and provide feedback to M. DiFilippo. In the past, all state sport committees have recommended state rotations. One of the issues presented is each sport is different. The 3-region concept, would provide a set standard and eliminate the need for approving each sport committees' recommendation every time they have a change. Approval of this concept would continue to group Section 6 with Section 5, but would give other sections a consistent partner too. There are concerns within the proposal relating to weekday travel, facilities, inequities, but the committee is moving toward a solution for all.



Proposal:

Consider approval to add language to the current rules identifying a minimum belt length.

Specifically, the rules shall read: Flag length is 14 inch minimum from the bottom of the belt (including the clip) to the bottom of the flag as a measuring point

Effective Start Date:

Spring 2025

Rationale:

There is currently no requirement relative to belt length in the rule book. Last year, it was added that all belts must be a pop belt and have at least two flags, specifically stating: Flag belt - Each player must wear "pop" flag belts at the waistline with two flags.

Based on feedback from several sections, there is a need for a minimum length to be instituted to ensure consistency and fairness in play and disallow teams any advantage by wearing a belt that is shorter than their opponents in length.

Proposal Originated:

Sectional concern brought to the NYSPHSAA Flag Football Committee and continued discussion amongst the Flag Football committee relative to belts.

Budgetary Impact:

None- by adding a minimum length that is consistent with the flags that schools have received from the NFL & Flag 60, we do not anticipate any budgetary impact on schools needing to purchase new belts.

3. NYSPHSAA Reports

Joe Altieri, Assistant Director

- a. Thanked Cortland, Section III, Machell Phelps, Jen, Marisa and everyone helping with the inaugural state tournament in June.
- b. On behalf of Dr. Robert Zayas, he noted Robert has been meeting with the State Education Dept and has been told SED is removing the mixed competition amendments from its proposal. He clarified APP guidance and regulations have not changed.
- c. NFHS Implicit Bias Course Required for new committee members; link will be sent to committee.
- d. State Tournament Update He asked for feedback on hotels (divisions were separated; breakfast included at Holiday Inn Express; donated by CRSC at Hometown Studios). No concerns or feedback,.

Todd Nelson, Assistant Director

a. Flag Football meets the Championship Philosophy for three classes for 2025. Classification #'s for three classes will be voted on at the October Executive Committee meeting. The CAC requested the committee discuss their concern about the top of C and bottom of C. The proposed breakdown is:

The committee did not have concern and felt the distribution was fair.

b. Rule Discussions – Concern about 1 yard buffer zone for defense, looking at 7 yard zone. NFHS has formed a Flag Football Rules committee. Todd serves on that committee. The plan is to have a rule book by Fall 2025. One more season with NYSPHSAA rules and default to tackle rules if there is no rule that is applicable.

Kristen Jadin, Assistant Director

 a. Indicated Spalding is committed to flag football in 2025 and balls will be required for use in sectional and regional play. Sections will receive a supply of balls for postseason. Jen/Marisa will notify Kristen of where regional balls should go. The model of the Spalding ball is referenced as the youth model. Kristen indicated there is no issue with stock but encouraged the group to put their orders in now. Championship Philosophy Committee Report Date: October 1, 2024 at 2pm

Status Updates/Items Discussion/Action Taken:

- 1. Welcome Dr. Zayas welcomed the committee and thanked them for joining.
- Championship Awards Draft Proposal Dr. Zayas presented the proposal. Kristen clarified that some sports will be losing awards they currently have now. A motion to approve the proposal as is – John Mankowich. Joe Mercado – second. Unanimous support. Motion passes. Mark D. – Asked to include how sports are impacted in the proposal.
- 3. Regional Rotations Dr. Zayas asked Sections to share which proposal they want to continue to explore. NYSPHSAA has been addressing this for several years. Listened to membership concerns and thus created guiding principles. Similar past concerns continue to be presented. Three ideas were presented at the last meeting. The goal today is to determine which direction the membership would like to continue to explore. This is NOT a definitive vote.
 - Section I In favor of exploring 3-Region Concept most equitable and consistent.
 - Section 2- Mark expressed this is his first meeting and just in talking to a few people and Section 2 Executive Director, if Section had to choose one or the other, the 3-Region concept would be the choice to examine.
 - Section III Section III's first choice is the 16-Team Bracket. However, they are okay with exploring the 3-Region concept as a backup plan.
 - Section IV Mike met with the Section IV Executive Committee today. Not prepared to pick one or the other. Both are good options to explore.
 - Section V Support exploring the 3-Region concept.
 - Section VI Mark shared Section VI is adamantly against at-larges and believes NYSPHSAA should stay with guiding principles. Not interested in the other two options.
 - Section VII Supports 3-Region Concept for exploration.
 - Section VIII Supports 3-Region Concept for exploration. Asks when exploring this option to limit the number of at-large teams and make sure it rotates.
 - Section IX 3-Region Concept is preferable for exploration.
 - Section X In favor of sticking with guiding principles if needed, can explore 3-Region.
 - Section XI 3-Region Concept is preferable for exploration.

Dr. Zayas informed that NYSPHSAA staff will begin developing templates for the 3-Region concept including scenarios where Sections do not participate in certain classes. These templates will be reviewed and discussed for potential future adoption. Mark W. suggested limiting at-large teams wherever possible, but Scott disagreed, pointing out that many sports already include at-large teams. Dr. Zayas noted that if the consensus is to limit at-large teams, regions without representation could be paired with other regions in the same situation, with at-large bids rotating among Sections with four or more schools. He added that a timeline would need to be established, and if a consistent geographic partner is not available, an at-large solution would be considered.



Section VI raised concerns about travel for at-large teams, which Dr. Zayas acknowledged, emphasizing the need to creatively address the issue. Scott mentioned that the 3-Region Concept still does not resolve the issue of midweek travel and believes that any solution involving midweek travel should be avoided. He suggested creative alternatives, and Dr. Zayas agreed, noting that most cases involve contiguous Sections and that efforts would continue to address outliers.

NYSPHSAA staff will continue to refine the concept and present the templates to the 11 Sections for further feedback. Tim commended the discussion and Robert's efforts, while Adam agreed that the feedback provided valuable insights for the staff. Deb pointed out the different philosophies across Sections, acknowledging the staff's understanding of these differences.

Dr. Zayas concluded by stating that if any changes were made, they wouldn't be implemented until Fall 2026, with M. Andrew from Section IV agreeing that a start before 2026 would not be desired. All concurred.

The awards proposal will be presented to the Executive Committee on October 24th while the regional rotations discussion resulted in the committee directing the staff to look into details and templates for a three-region concept for possible implementation in the 2026-27 school year. Robert also reported there is a lot of information circulating on social media related to transgender student participation. Robert continues to advise schools to place students on teams that most appropriately aligns with the student's gender identity in accordance with NYS Anti-Discrimination laws. President Mullins thanked Greg and the CAC for their work. He also thanked Deb and Adam for their service and welcomed Dave and Jen to the committee.

Greg asked for a motion to approve the minutes of the July 3, 2024 "special" CAC meeting. **MOTION by Josh. SECOND by Jamie. CARRIED 8-0.**

PROPOSALS

(These items will be presented as discussion or action at the next Executive Committee Mtg) Following proposal presentations by Sport Coordinators, Greg announced Sport Coordinators may depart the call so the CAC can discuss and vote on proposals.

OUTDOOR TRACK – Super & At-Large Standards – Girls Outdoor Track Coordinator Tom Wells explained the proposal. Greg confirmed the state committee will meet following the 2025 meet to examine the number of qualifying athletes. Eileen complimented the state committee on the proposal having recently spoken to area track coaches about various track proposals.

MOTION by Mike A. to support the proposal. SECOND by Jamie. CARRIED 8-0.

BOYS TENNIS – At-Large Rotation – On behalf of coordinator Quan Huynh, Joe A. explained the proposal. No questions/concerns were raised.

MOTION by Jamie to support the proposal. SECOND by Mike A. CARRIED 8-0.

BOYS TENNIS – Regional Rotations Using Guiding Principles – On behalf of coordinator Quan Huynh, Joe A. explained the proposal.

DURING CAC-ONLY DISCUSSION: Jen asked if it was a concern with the committee that Section I, VIII and IX (considered to be the strongest tennis sections) are playing each other in sub-regionals and regional finals. Joe noted the committee had a concern but didn't have a solution for it since guiding principles had to be followed and equity established with everyone playing in sub-regionals. It was also recognized those three sections only play twice in the entire rotation. Mike asked why girls and boys have different regional rotations. Joe stated there wasn't a good reason. They worked on their rotation over six months apart separately.

MOTION by Dave to support the proposal. SECOND by Jen. CARRIED 8-0.

CAC SUB-COMMITTEE – Regional Dates/Nights Rest Rule – Greg explained the meeting of the subcommittee (Greg, Sue, Deb, Mark, Joe) and the proposed language to address this (concern from Section 1 at Central Committee meeting). Mike A suggested the regional final be Friday or Saturday (language states just Saturday). Greg wanted to present this to executive directors on October 23rd to get feedback then when CAC meets in January, formalize the proposal for presentation at the February 5th Executive Committee meeting.

FOR REVIEW/INPUT/CHAMPIONSHIP SITE SELECTIONS:

Cross Country Site Change 2025 – Joe A. explained Section V withdrew their bid to host in 2025 due to not feeling Letchworth State Park can put a quality product out with the necessary amenities. Queensbury, who originally bid on the event for 2024 thru 2026, is prepared to host in 2025. **CAC expressed no concerns with the recommendation.**

Girls Volleyball Site Selection 2025-27 – Joe A. explained the lone bid submitted by Cool Insuring Arena in Glens Falls. He indicated both staff and state committee agreed on the bid as the recommendation. **CAC expressed no concerns with the recommendation.**

Outdoor Track 2026-28 – Joe A. explained no bids were submitted for this event and a re-bid is out and due November 26th. During and following the track committee meeting in September it was learned that numerous high school, college and public venues were interested but did not want to commit to three years or did not want to close school on a Friday in June. They did not realize prior to the bid, those were not requirements in the bid.

CAC expressed no concerns with the recommendation.

Girls/Boys Wrestling 2026-28 – Joe A. explained there was one bid submitted by MVP Arena (Albany) and it was significantly higher in cost than the current expenses at MVP. Both the staff and girls/boys committees agreed to not recommend the bid and go to a re-bid due December 20th. **CAC expressed no concerns with the recommendation.**

INFORMATIONAL:

8-MAN FOOTBALL REGIONAL CHAMPIONSHIP – Joe A. reported the NYSPHSAA Officers approved a proposal from the football committee on September 11th to hold the 8-man regional championship on Saturday, December 7th at the home site of the east region. He noted the state committee has since requested Section IV host the game so it's at a central location. Robert gave background on the proposal and said they need to provide financial information and details if they are interested in Section IV hosting the game.

CLASSIFICATION – FLAG FOOTBALL – Todd Nelson explained the state committee discussed the classification breakdown for a second time (as directed by CAC) and he indicated there was no movement to change the recommendation for classification cut-offs. He reported one executive director had a concern that may come up at a later time.

2024-29 Championship Dates & Sites – Joe A. noted the updated championship documents in the packet noting the championship recommendations above.

2. NYSPHSAA Staff Reports

- c. Stated the Championship Philosophy Committee met last week and discussed awards and regional rotations. A proposal for revising awards given out at state tournaments will be presented for discussion at the October 24th Executive Committee meeting. Later in the meeting, Kristen Jadin discussed details of the impact it will have on bowling.

a. Reported on Championship Philosophy Committee proposal on awards where section champions may no longer receive awards at state tournaments and medals/plaque distribution will change. Kristen asked for feedback from the committee which would be shared with the Executive Committee.

A discussion about this ensued with some in favor of keeping section awards and others not. Joe clarified section standings/winners can still be announced and recognized at state tournaments similar to wrestling; they just wouldn't get awards. Mike requested the committee vote in favor or opposed to the new proposal. The vote was 5 opposed, 3 in favor (Sections 1, 4, 9 not present)

3. Committee Business

- a. Mike O'Connell shared the four proposals and schedule approved for the 2025 state tournament:
 - 1. Schedule:
 - Friday, March 14 D1 Bowling
 - Saturday, March 15 Composites bowling (Expanded format- sched noted below)
 - Sunday, Marh 16 D2 Bowling
 - 2. Increase school division format to six players using traditional composite division format (Bowl 6 drop lowest) using 2 pairs of lanes w/ 6 on a pair.
 - 3. Allow bowlers to compete in composite and team states
 - 4. Split composite into two divisions
 - D1 will bowl at 8am (boys and girls)
 - D2 will bowl 2nd squad--- Potential Time Change: Typically a 2pm start; however, Mike stated we might have to adjust to re-oil. TBD based on discussion with Dan (Championship Venue Management)
 - Mike showed a lane usage chart-- Lane utilization is much tighter, will not have as many dark pairs, but will be spread out more. Friday/Sunday will finish quicker, but Saturday will take longer.
 - Estimated head count for each squad is 680. Fire code is 857 but there likely won't be enough seats. Joe/Mike to discuss with Dan (Championship Venue Management)
 - Participation Survey All sections participating in the school team event plan to field a team in the corresponding composite team event.
 - 5. Permit Use of At Large Rotation 2025 to fill pacer teams Mike requested ideas from the committee to consider for the actual rotation. There was a concern about who would start first and many were unaware of costs associated with sending an at-large team so Mike offered Section III start the rotation. A local team would not incur travel expenses and the committee can see how the first year of the new format plays out.

MOTION by Eileen to have Section IIII start the rotation for 2025 and develop a full rotation to discuss at a later time starting with the 2026 tournament. SECOND by Bill N. Carried 4-3 (1 abstention).

4. Section Concerns – No concerns by any section.

5. Next Meeting dates

- a. Joe encouraged bowling to back up a couple weeks to ensure proposals can be in place for the state tournament. The committee agreed to move their meeting to a September date.

Schools Without Boundaries Committee Meeting Report Date: October 16, 2024 at 9:30am

Status Updates/Items Discussion/Action Taken:

- 1. Welcome and Introductions Adam welcomed everyone attending in person and expressed gratitude for their time and participation in the meeting.
- 2. NYSPHSAA Membership Concerns Historical Overview Dr. Zayas provided a historical perspective on membership concerns, specifically questioning how private or charter schools can win the New York State Public High School Athletic Association (NYSPHSAA) championships. Supporting information was provided in the meeting packet, emphasizing that this topic has been longstanding. Many athletic associations across the country face similar challenges. This issue gained prominence when 4 out of 6 non-public schools won the 2024 Girls Basketball Championships.
 - a. In 2016, the Oversight Committee was created to address concerns from sections about the placement of non-public schools. If a section raises an issue about a non-public school's placement, the Oversight Committee reviews the case and can request the section to reconsider.
 - b. The concept of creating a 12th Section was also previously discussed, but a vote of 14-8 indicated little interest. The Oversight Committee has only met once in the last eight years.
 - c. Pat asked for a list of 71 non-public schools, and Joe S. requested a list of charter schools from the last 5-10 years.
 - d. Marisa questioned whether other sections, besides Section VI, have historically allowed non-public schools to join. Section VI is the only one.
 - e. Dr. Zayas cautioned that prohibiting public schools from competing in state championships in any way could lead to potential legal and legislative challenges.
 - f. Marc emphasized the distinction between charter and non-public schools and suggested they should not be grouped together.
 - g. Adam inquired about how many sections have mechanisms for moving schools up in classification. Several sections have such systems in place. Buddy mentioned that Section III also considers a "success component" in its decisions. Discussion followed.
- 3. Classification Policy Todd presented the current classification policy, explaining that sections classify schools based on what they deem appropriate, though the criteria are not standardized across sections. NYSPHSAA has a policy in place, but the majority of championships with nonpublic schools in the finals, are still being won by nonpublic teams in lower classifications. Todd also reviewed the Championship Breakdown included in the packet. Dr. Zayas noted that similar data had been presented in 2016 for the 2008-2016 time period.



- a. Marisa inquired whether it would be possible to track private schools that have reached regional championships. Todd – it is possible, but will take some work. Section VI raised concerns that Section V nonpublic schools are taking opportunities away from Section VI schools by representing their region in state championships.
- b. Chris C. questioned how a school with 69 BEDS number can consistently compete in higher classifications and maintain competitiveness. He mentioned schools with a BEDS of 71 playing in AA often struggle, but some schools are doing things to remain competitive that comparable public schools do not.
- c. Greg asked how recruiting for non-public schools could be controlled, noting that sections have the authority to sanction or censure schools.
- d. Joe S. highlighted the issue of losing students to non-public schools due to recruiting and asked what can be done about it. The question of whether transfers were made for athletic advantage is part of the transfer paperwork process in other states. Dr. Zayas mentioned previous discussions about undue influence in recruiting students and added that athletic directors are often reluctant to address this issue directly on the transfer paperwork.
- e. Buddy pointed out that non-public schools do not have feeder programs like public schools do.
- f. Dr. Sugar stressed the challenge of policing ethics, noting that both public and private schools sometimes disregard them. He emphasized that without self-reporting, schools are unlikely to face consequences, as there is no investigative body to enforce the rules. Renee clarified that a section can conduct its own investigations.
 - i. Adam acknowledged that the first line of defense is at the section level and asked what role NYSPHSAA can play in this.
 - ii. Dr. Zayas shared that NYSPHSAA has received information leading to a school being declared ineligible. He added that the association can receive tips but does not have the manpower to conduct investigations on a regular basis. Adam suggested schools hire a private investigator, but Dr. Irving noted that in Section V, BOCES provides investigative services, though it is costly. Dr. Zayas stated that if the membership wants NYSPHSAA to hire investigators, dues would need to be raised. However, in states where investigators are employed, it tends to create more issues than it resolves. Todd emphasized that the focus should be on accountability, with sections and the state holding schools responsible for their actions.
- g. Chris C. shared that schools operate with different business models and philosophies, which complicates the issue. Alphonse added that schools need to act ethically, though parental influence is a complicating factor. Further discussion followed, with Chris C. expressing concern that the burden of proving violations is too high.
- 4. NYSPHSAA Transfer Rule Dr. Zayas addressed the history of the NYSPHSAA Transfer rule. Shared that concerns regarding the number of transfers existed when he arrived in New York, noting a perception that the transfer rule disproportionately benefits non-public schools. In December 2015, an Article 78 proceeding challenged the rule, but the judge ruled that the transfer rule has a rational basis. Dr. Zayas provided an overview of the changes to the transfer rule over the last 10 years, highlighting that New York has a more



restrictive transfer policy compared to other states. For instance, New Jersey allows one free transfer, while Florida's transfer rule is shaped by legislative decisions. Renee added that the undue hardship provision has remained a key component of the rule over the years, ensuring flexibility where needed. From a legal standpoint, the transfer rule is considered strong and well-positioned.

- 5. National Perspective Grant shared that the conversation around transfers and recruiting in Oklahoma mirrors discussions happening across the country. In 2011, Oklahoma introduced Rule 14 to address private school success, but similar challenges persist, with data showing trends comparable to those in New York. Grant explained that the lawsuit brought by five private schools was in response to amendments made to Rule 14. One notable aspect was the judge's decision to deem a "success factor" that bumps schools up by more than one classification as unconstitutional. The state is still navigating how to refine its classification rule and potentially adjust the way schools are classified.
 - a. Joe S. inquired about the possibility of a separate classification for private schools during postseason play. Grant responded, cautioning that using the term "separation" implies that one group of schools is fundamentally different from the other, and this was not a recommended avenue to pursue. Grant mentioned the judge in Oklahoma advised to stay away from "separating."
 - b. Dr. Zayas advised against making decisions based solely on potential litigation risks but emphasized the need to be prepared for what is likely to occur with litigation and more importantly, legislative challenges. Joe added that there are also concerns about litigation from public schools. Adam mentioned that there could be an opportunity for schools in Section VI to join NYSPHSAA and compete for a state championship. Stephen expressed confidence that their section has done well in determining appropriate classifications for its schools.
- 6. Litigation Overview Renee provided a review of the litigation history related to this issue, with relevant documents included in the meeting packet. From a legal standpoint, she explained that separating non-public schools into their own classification is unlikely to hold up in court. Renee urged the group to consider the legal challenges faced in previous cases when evaluating potential changes.
 - a. Marisa asked why New Jersey is able to have separate championships for nonpublic schools. Dr. Zayas explained that New Jersey has always operated under that system, which is why it has been allowed to continue, similar to Section VI's success in denying non-public participation in Western New York (i.e., Section VI).
- 7. Insurance Greg J. explained this issue has been ongoing for 20+ years. The association's insurance policy provides coverage for the association, its sections, board members, employees, and the decision-making process around rules and regulations. The policy has a \$5 million coverage limit with a \$50,000 deductible per claim. As of January 1, the retention will increase to \$100,000 due to the amount of litigation the insurance company is handling throughout the country. If 10 schools were to sue the association, the insurance would incur up to \$1 million in defense costs. Legal claims can take a long time to resolve, sometimes lasting over 5 years. This is not a quick process.
- 8. Discussion/Next Steps: Adam asked if there is any appeal in creating opportunities for Schools Without Boundaries. Buddy suggested that any issues arising within sections should be addressed at the section level, as there are already systems in place that should be utilized. Adam also proposed viewing the situation as an opportunity for more nonpublic schools to join and more opportunity to win championships.



- a. Chris C. raised the question of when the will of the people should factor into the decision-making process. Renee noted that while public opinion can be considered, legal factors such as due process and equal protection claims must be taken into account. Chris C. asked how creating a Class AAA differs from having a separate classification. Renee explained that such comparisons likely wouldn't hold up legally. Joe S. pointed out that an additional classification has never been tested in court, and one potential benefit could be providing Schools Without Boundaries more opportunities to win championships. Dr. Irving added that league structures wouldn't necessarily change. Stephen highlighted cost concerns for Schools Without Boundaries, suggesting that instead of having a Class AAA, they could explore adding another classification altogether. However, he cautioned that continually adding classifications could lead to over-expansion, benefiting everyone without solving the core issues. Russ disagreed with the logic of this argument as they do not coincide with one another. Buddy mentioned that even smaller schools are negatively impacted by these changes. Further discussion followed.
- b. Section I Suggestion: Section I presented suggestions to address the Schools Without Boundaries issue at the July Central Committee meeting. Russell Bartlett, NYSPHSAA President at the time, directed their suggestion to this Ad Hoc Committee. It was shared with group via the meeting packet. Suggestions surrounding this topic were discussed thoroughly throughout the meeting.
- c. Todd/Dr. Zayas presented an idea that would abide by the current criteria for the classification of non-public and charter schools. The "idea" would essentially create a separate classification for Sections to use when a Section has four or more non-public/ charter schools in Class 3A. The Section would then have the 3A nonpublic/ charter schools and the 3A public schools to play off to determine the Section's representative in the regional round. The ad hoc did not provide much interest in pursuing the idea. Discussion with 3A Select: Joe S. - Has concerns about gamesmanship and whether it will continue to create problems. Dr. Zayas acknowledged that unintended consequences often arise from changes. Dr. Sugar pointed out that equitable competition is not being achieved as per the NYSPHSAA Constitution and suggested there should be a dedicated entity to investigate and make decisions on these issues. He mentioned the possibility of considering another association if the current one cannot meet the needs of his community. Pat responded that the NYSPHSAA was established because the New York State Education Department (NYSED) allowed it to be. Renee advised focusing on specific issues that are not problematic and addressing those directly. Joe S. suggested inviting representatives from New Jersey to explain why their system works, noting that their model has not faced legal challenges. He proposed having them speak to this group for further insight. Greg raised concerns about recruitment and emphasized the need to take a closer look at the clause regarding recruitment, suggesting a redefinition of what constitutes recruiting. Pat noted that Section VIII reviews every transfer. Adam agreed that redefining recruitment is possible, but stressed that if sections do not enforce the rules, changes will not be effective. Dr. Sugar identified this as a state-wide issue and mentioned that the oversight committee can be used and is working on recommendations for the committee. Michael called for consistency in determining which factors should lead to a school



being bumped up in classification. Dr. Sugar added that consistency is needed in areas such as undue influence, recruiting, and classification.

- 9. Next Steps:
 - a. Each section will prepare a proposal with substantive details.
 - b. A proposal deadline was set for December 20th, with plans for an in-person meeting, including small group discussions.
 - c. Joe S. requested a separate meeting for nonpublic/charter schools to discuss issues specific to charter and non-public schools.
 - d. Dr. Irving suggested drafting a statement to share with the sections, outlining the group's direction.

- 2. January Sections review all submitted Proposals

All participants for the 2025 Section 6 Tournament must fill out a waiver stating their intentions for participation in the NYSPHSAA State Championships prior to the May 19th Section 6 Tournament. The waiver does not have an effect on golfer's placement in the tournament or starting hole order. This only has an effect on how many alternates and the order of alternates will be needed in case a golfer(s) decides to opt out of the state tournament. We will need to know this ahead of time in order to settle tiebreakers on the day of the tournament.

Justification: For the last two seasons, there have been golfers who have qualified for the NYSPHSAA State Tournament, however, decided the day after the tournament that they had a prior commitment. This caused major headaches when it came time to add alternates. In 2024 there was a tie among alternates. This could have caused major issues if one of the alternates did not have a prior commitment to begin with. With the waiver,

the golfer will have notified their coach and the section chair of their intentions. All tiebreakers and placements would be completed on the day of the tournament.

Special Reminder: Girls that compete on their school's Boys Varsity Golf Team may qualify for postseason play in girls competition. Boys coaches were contacted by the Section VI Chairperson in the fall via their league coordinators. These girls must compete according to the Boy's rules, play a minimum of 6 matches, and have a 9 hole stroke average of 54.99 or better.

Other Pertinent Information:

For individual, individual/team sports, when a school district does not have a team designated for each singular gender, the Section Executive Director may grant a waiver of the Representation Standard for Sectional Competition when a student has met the qualification for participation in the current school year's NYSPHSAA Championship event. Status Updates/Items Discussion/Action Taken:

- 1. Concussion Management Update:
 - a. BIANYS is continuing to work with legislators to update the NYS Concussion Management Law. These updates include the list of providers that can clear a student back to participation. BIANYS is also providing COPE training to school nurses, school medical directors, coaches, athletic directors, and parents. Diversity, Equity & Inclusion (DEI) Committee Meeting Report Date: October 2, 2024 @ 2:00PM

Status Updates/Items Discussion/ Action Taken:

- 1. Review definitions of Diversity, Equity, & Inclusion within NYSPHSAA Dr. Zayas Requested feedback from Sections on the draft DEI definitions provided. Aubrey - Praised the state's progress in DEI but suggested it should be reflected in NYSPHSAA's Mission Statement. He also emphasized the importance of aligning the DEI language between NYSPHSAA, Sections, and Leagues. Sam – Noted that not all Sections currently have a DEI committee, with only Sections I, V, VIII, IX, and XI being exceptions. She emphasized that if NYSPHSAA is committed to DEI, alignment across all Sections is necessary. She questioned how to encourage Sections to establish or adopt DEI practices at the local level. Robert - Stated that the goal today is to define DEI and include these definitions in the NYSPHSAA Handbook. He asked whether "Belonging" should be included in the definitions. Aubrey – Explained that "Belonging" refers to the feeling of being accepted and included, an outcome of inclusion efforts. Joe - Supported the idea, noting that each Section handles things differently. Kru -Asked whether NYSPHSAA is required to follow New York State Education Department (NYSED) recommendations exactly. Dr. Zayas - Clarified that NYSPHSAA is not limited or restricted by NYSED guidelines. Sam - Believed that "Belonging" is already embedded in the DEI definition and that creating a separate definition for it could dilute its meaning. She stressed staying true to the core DEI purpose, as these practices exist because historically, marginalized groups have not been included. Dr. Zayas - Asked if it would be possible to intertwine the concept of belonging within the existing definitions. Reggie - Agreed that "Belonging" is already inherent in the current definitions. Dr. Zayas -Suggested adding terms such as "connected," "heard," and "accepted" to the definitions. Dr. Manning Campbell – Proposed adding "respected" as well. Sam – Pointed out that these are definitions, not necessarily actions, and asked how to translate them into actionable steps. Kristen -Suggested that once the definitions are finalized they will be sent to the group for formal approval at the next meeting. Then, proposals should be developed to put DEI work into action.
- 2. Pathways to Promote Diversity on NYSPHSAA Committees Dr. Zayas Discussed efforts with the Big 5 to increase involvement. He noted that most NYSPHSAA committees have sectional representation, except for a few specific exceptions outlined in the meeting agenda. Dr. Zayas also outlined the NFHS approach to DEI on committees, emphasizing that NYSPHSAA aims to be purposeful and intentional in its approach. Sam Proposed renaming the "minority representative" position the NFHS uses to something less problematic, such as "At-Large Representative." Dr. Cotto Agreed, expressing that the current term may imply inferiority. He also raised the question of how to recruit within each section, noting that education should inspire youth, and perhaps candidates outside of day-to-day athletics could be considered. Dr. Zayas Highlighted the importance of ensuring underrepresented groups have a voice at the table. Adam Suggested adding a representative from the Big 5 to committees, including a discussion about possible changes to the Central/Executive Committee structure. Dr. Zayas Supported adding a Big 5 representative to all standing and ad hoc committees as this would ensure diversity and increased representation for the largest school districts in NYS. However, the topic of the Executive/Central Committee would require a constitutional change, needing a 2/3 referendum vote from the NYSPHSAA membership.



He requested that the representatives take these ideas and the definitions back to their sections for further discussion, noting that the positives would outweigh any negatives. Dr. Cotto – Stressed the importance of representation as voting members. Camaron – Expressed concern about the infrequency of meetings, suggesting it could take years to implement changes. She emphasized the need for consistency. Dr. Zayas – Reassured that meetings can be held as frequently as needed. It was decided to meet again in early December.

- 3. New Business
 - a. Camaron Emphasized the importance of establishing policies for Sections and schools once DEI definitions are finalized, particularly for handling infractions. She noted that schools consistently violating DEI principles should face consequences. Dr. Zayas Responded that current NYSPHSAA rules allow Sections to censure, sanction, or place a school on probation for violations. If a school fails to address these issues, the Section and Robert should become involved. Camaron Asked if there is a standard operating procedure (SOP) for handling such infractions. Dr. Zayas Clarified that there is no formal SOP, as no specific penalty is prescribed. The actions taken can vary depending on the situation. Dr. Cotto Suggested incorporating professional development and providing opportunities for schools to engage with families. He asked if there could be more direct connections to local resources, workshops, and trainings to exhaust every possible way to engage. Kru Stressed the importance of athletic directors meeting with their student sections to address these issues.
 - b. Adam Expressed appreciation for the group's commitment to this work despite busy schedules. Tim – Highlighted the importance of continuing to move this work forward for the benefit of the association and the students it serves. Debra – Thanked everyone for their efforts and encouraged continued focus on the mission statement moving forward.
