4.0 **EXECUTIVE DIRECTOR'S REPORT** (M. DiFilippo)

4.1 Notice of Claim

There is a pending lawsuit against Section VI regarding an incident that occurred at a December 2023 boys ice hockey event between a student and ticket taker.

4.2 Assistant Executive Director Position

The open position was posted March 14, 2024. The deadline to apply is April 17, 2024. The Executive Committee will begin conferring to schedule interview dates.

4.3 Baseball/Softball Update

As mentioned at last meeting, the WNYUA (Group 5) was dissolved by the NYS Softball Association this year, in advance of the spring 2024 season. The Niagara Frontier Softball Board and Cattaraugus County Softball Board agreed to cover the WNYUA territory. The softball assignments were recently made and JV and varsity levels are covered. There is concern with modified level coverage.

It was noted that they are issues with WNYUA (Group 5) baseball coverage at the V and JV levels. It was noted that the NYS officials groups determine the boundaries of what schools fall within the officials groups' jurisdictions. M. DiFilippo has reached out to the state, providing two years worth of data, to request change in jurisdiction to alleviate the lack of coverage.

4.4 Fall AD Workshop, August 19, 2024

The mandatory AD workshop was originally scheduled for August 21 and has now been changed and confirmed for **Monday, August 19, 2024.** At this workshop, the Section VI launch of the Inside Out program will take place. The intent of this program is to assist athletic directors develop character coaches. The NFL and the Buffalo Bills are funding this program. There is no cost to Section VI. Sections 1 and 8 have already implemented this program. Section 5 plans to launch its program at the same time as Section 6. Three zoom training sessions are scheduled in October, November, and December.

M. DiFilippo to request to move this date to Monday, August 19 in consideration of the state action item to move the football start date to August 21.

4.5 Fall Coaches Meetings

The new format of leagues meeting separately and then linking together virtually as a Section is working out nicely. For planning purposes, all coaches meetings will be scheduled the Wednesday before the start of the season. The fall coaches meeting date is Wednesday, August 21.

4.6 Girls Wrestling

This 23-24 year, there was a significant increase in participants. Discussions pertaining the procedures of Girls Wrestling are ongoing.

Not all school programs have the numbers to compete one on one, but athletic directors are encouraged to have their female wrestlers compete against other females. At present, female wrestlers are permitted to wrestle males. It was noted that the weight classes between females and males.

Additionally, A. Conti, chairperson is retiring. The vacancy for the position will soon be posted.

4.5 All-Star Basketball

M. DiFilippo asked council members to share with their respective leagues that only seniors are permitted to participate in sanctioned all-star contests representing their school. In addition, there are several non-sanctioned events known about, including Buffalo's Best and 716 vs. 585. Participating student-athletes in a non-sanctioned event should not wear their school's team uniform. Underclassmen who represent their school in a non-sanctioned event lose eligibility in that sport.

- Video Review (Reference Male/Female agenda item 6.7c2) Predominantly against NYSPHSAA rules. Only
 select sports offer video review if the infrastructure is available and in state finals where a video monitor is
 available on the sideline or at the scores and only to approve last minute shots or something that can be clearly
 defined table.
- Private Schools The state office received numerous inquiries after four (4) private schools won state championships in the sport of Girls Basketball. Section VI is the only section that does not have private schools as members. In 2016, there was a state committee that was convened to review the matter of private schools. A private school winning does not create justification for removal, it is the Sections' responsibility to vet private schools to reclassify them, to censure or sanction them for violations of transfers rules, and to prove recruitment. If this is another statewide issue that needs to be revisited, a section needs to bring it forward at a state meeting. NYSPHSAA has been advised, legally, that there has to be solid justification for removing private schools.
- Transgender Athletes In light of Nassau County passing a law not permitting transgender ath to compete within county facilities. NYSPHSAA continues to advise everyone to follow SED guidance to allow any student to participate in the gender they identify with. If there is an issue, an appeal may be made to the Commissioner of Education and it will be handled on a case-by-case basis. The state attorney general office and the state legislature are investigating ways to counter to Nassau County ruling.
- NFHS The authenticating mark is going up to .50 to 5% of the price to align with the price of industry standards. NYSPHSAA is requesting the NFHS to reconsider before the pricing goes into effect for the 25-26 school year.
- Regional Rotation for 6 Class Sports NYSPHSAA encourages sections to be prepared to vote on regional rotations at the July 2024 state meeting.
- NYSPSHAA Foundation Update NYSPHSAA has added fundraising to ticketing at the state level. NYSPHSAA is hoping that each Section will conduct a fundraiser this year.

Proposal:

The NYSPHSAA Boys and Girls Bowling State Committee is seeking approval to permit the use of rotating at-large berths when a division (1,2 or composite) has an odd number of teams competing in the NYSPHSAA Bowling Championships. At-large berths would eliminate pacer teams at the State Tournament and be a part of the state tournament competition.

Effective Start Date:

Winter (March) 2025

Rationale:

Each year the host section is responsible for providing a different "pacer" team for each session due to the odd number of teams that are competing. This is done so teams are not bowling alone on a pair. Securing pacer teams requires the host section to recruit and get students out of school for Friday competition and ask them to volunteer Saturday and Sunday as well. It is a challenge to secure students all day for three days. Furthermore, this proposal would alleviate the management of the pacer teams during the tournament (lane assignments, hospitality, etc) and alleviate the concern of providing quality bowlers to pace with another teams.

It is proposed to establish a schedule which will specify which section will be awarded an at-large berth in each division of the NYSPHSAA Bowling Championships. The schedule will consist of sections who have ten (10) or more competing schools for each of the respective divisions.

Proposal Originated:

Section VI- Dan Kaplan at the NYSPHSAA Boys/Girls Bowling State Committee meeting on October 13, 2023.

Budgetary Impact:

Additional Information:

Here is a brief overview of how the Girls Ice Hockey committee has utilized the practice using an "out-bracket" concept for the inclusion of any "new" teams/sections for a fair and equitable advancement to its NYSPHSAA Regional Final Four Tournament. This concept has also eliminated any possibility of a single team participating in a section from advancing "straight" to a Final Four berth without having to play in some sort of a playoff event.

Prior to the 2012-13 winter sports season, Girls Ice Hockey was only represented by the following Sections: ¾ (3 and 4 combined), 6, 7, 10. This made for an easy tournament advancement as each Sectional winner would automatically advance to our culminating event. This was prior to NYSPHSAA recognizing this event as a "Regional" Event.

In 2013-14, the Girls Ice Hockey Committee submitted a proposal for consideration of their High School tournament event to be recognized as a NYSPHSAA Regional Championship event based on the criteria. It was approved and has remained a "NYSPHSAA Regional Championship". In the 2019-20 season, our season was cancelled due to the Covid - 19 pandemic.

In the 2021-22 school year, Section 1 sponsored two (2) new teams which necessitated a discussion on a temporary solution by the committee to include Section 1 in the postseason for the Regional Championship. The committee met after each coordinator had discussed options and came to the recommendation that we create an "Out-bracket" for the tournament which would/could be rotated annually among the participating sections for that season.

In the 2022-23 school year, Section 2 sponsored one (1) new team which necessitated a discussion on a temporary solution by the committee to include Section 2 in the postseason for the Regional Championship. The committee met after each coordinator had discussed options and came to the recommendation that we revise the current "Outbracket" for the tournament which would/could be rotated annually among the participating sections for that season.

In the 2023-24 school year, Section 5 is sponsoring one (1) new team which necessitated a discussion on a temporary solution by the committee to include Section 5 in the postseason for the Regional Championship. The committee met after each coordinator had discussed options and came to the recommendation that we revise the current "Outbracket" for the tournament which would/could be rotated annually among the participating sections for that season.

Of note: The "Out-bracketing" committee takes into consideration:

- The previous out bracket matchups for that season's rotation
- More importantly, we also plan for time, travel and if there are unique costs involved.
- The # of Out bracket contest(s) that are needed to properly advance teams, while whittling down to a final four group in a timely manner.
- The number of Sectional Representatives/Champions has changed each year for the last three (3) seasons. This
 item is a good scenario for girls' hockey as we have gained three (3) new sections and have maxed out the # of
 sections for our sport as Sections 8 & 11 do not sponsor boys or girls ice hockey.

Call to Order by Chair Greg Ransom at 10:03 am. He asked for a motion to approve the minutes of the September 27, 2023 meeting. **MOTION by Mark, SECOND by Julie. CARRIED 9-0.**

Greg offered Dr. Robert Zayas opening remarks. Dr. Zayas reported on the progress of the Ad Hoc committee which has met several times since October. This committee is focused on addressing the inequities of regional rotations brought forward by Section 1 last year. They are currently discussing ideas and options, which include "guiding principles", to solve the concern. Mike Andrew added Chair that Tim Mullins has done a terrific job keeping that committee on task.

PROPOSALS

(These items will be presented as discussion or action at the next Executive Committee Mtg)

Outdoor Track 3rd Division – Girls Coordinator Tom Wells explained the proposal. Joe noted that financial figures were added in the budgetary impact due to the Executive Committee requesting the staff look closer at finances of state championships and proposals. Eileen asked if this will be an added cost to the section. Joe stated it depends on how you hold your sectional tournament but would likely be. Jamie asked if there's a concern with the hotels with the amount of additional athletes participating. Tom responded its always a challenge in Middletown but sections get it done. He has researched hotels in some of the sections that can host and believes they can handle a larger state tournament.

During the CAC-only discussion, Jamie continued to express the concern of hotels. Julie suggested considering 2026 as the first year of this (also when there would be a new bid). Deb asked if this is our largest sate tournament. Joe stated yes, it will now be approximately 1,700 athletes (plus coaches) participating. Greg noted Middletown has a concern running the event and how it impacts its school. Joe reported he had a conversation with Dave Coates, Athletic Director at Middletown HS, and at this point in time they are willing to host with an additional 2-3 hours each day, preferably tacked on to the end of the days. **MOTION by Deb to support the proposal. SECOND by Josh. CARRIED 9-0.**

Boys/Girls Bowling Establish At-Large Rotation – In place of the coordinators, Joe Altieri explained the proposal. Julie asked if there was an additional cost for awards. Joe stated no, we currently award three High Series awards for each gender and would simply now award a champion, runner up and 3rd place for each gender instead of High Series. Greg said he is a little leery of their 10-team limit for this proposal. Joe explained the 10-team minimum helps with quality of the tournament as opposed to small sections in a division who may have weaker at-large/second place teams. Greg noted you could have quality with just 7-8 teams in a section in a division and asked about the numbers in each division. Todd reported Sections 7 and 10 would be eliminated in the at-large rotation because they are the only two sections below 10 teams in a section in a division. Joe recalled that was the data the committee discussed and ultimately helped them determine the 10-team minimum.

Julie said it should be noted there is now an instructional impact with missed school time that schools will not have a choice when to travel in. Peggy recognized that but reported numerous teams have been traveling in early anyway.

Softball Championship Site Selection 2025-27 – Assistant Director Joe Altieri explained the lone bid submitted by Greenlight Networks Grand Slam Park (Section IV). He indicated both staff and state committee agreed on Greenlight as the recommendation. **CAC expressed no concerns.**

Girls Lacrosse Championship Site Selection 2025-27 – Assistant Director Joe Altieri explained the lone bid submitted by SUNY Cortland (Section III). He indicated both staff and state committee agreed on SUNY Cortland as the recommendation. **CAC expressed no concerns.**

Skiing Championship Site Selection 2025-27 – Assistant Director Joe Altieri explained the three bids submitted by Gore/North Creek, Whiteface/Mt. Van Hoevenberg, and Bristol/Harriet Hollister. He indicated both staff and state committee agreed on Gore/North Creek in 2025, Whiteface/Mt. Van Hoevenberg in 2026, and Bristol/Harriet Hollister in 2027 as the recommendation. **CAC expressed no concerns.**

Boys Lacrosse EAST SEMIFINALS Site Selection 2025-27 – Assistant Director Joe Altieri explained the lone bid submitted by Middletown High School (Section IX). He indicated both staff and state committee agreed on Middletown HS as the recommendation. **CAC expressed no concerns.**

Boys Lacrosse WEST SEMIFINALS Site Selection 2025-27 – Assistant Director Joe Altieri explained the lone bid submitted by SUNY Cortland (Section III). He indicated both staff and state committee agreed on SUNY Cortland as the recommendation. **CAC expressed no concerns.**

Boys Lacrosse FINALS Site Selection 2025-27 – Assistant Director Joe Altieri explained the three bids submitted by Hobart & William Smith Colleges, Hofstra University and Ithaca College. He indicated the staff recommended Hofstra and state committee recommended Hobart William Smith, and why there were differences in the recommendations. Sue asked where donations come from. Joe explained from companies

and individuals. They are required to submit a commitment letter in the bid then follow with payment if they win the bid. Deb asked how many championships are in Section V and Section VIII. Kathy noted there are currently three in Section VI. Joe stated there are two on Long Island in 2023-24. Deb indicated spreading out championships for the good of the state is important. Robert said he's encouraged Long Island and other sections to bid on more events. Greg asked CAC what he should like to communicate to the Executive Committee on January 31st. Deb suggested finances should be strongly considered. Tim noted basketball will play a big part in this decision since the differences in the recommendations have similar elements. Sue reinforced basketball and lacrosse should be the same decisions because of that. Robert indicated if both venues are similar then the finances determine the decision. Eileen said there are other variables in bids, not just finances. She also stated the unknowns of admission revenues. Sue said we should base our feedback on the outlined costs in the bid. Mark agreed with focusing on finances since everything else is even. He added the Executive Committee can make the decision since CAC is zeroing in on the key elements of the bid. Greg gathered the following consensus: **CAC recognizes both venues are of high quality and can host the event. The difference in expenses should be considered.**

Boys Basketball Site Selection 2025-27 – Assistant Director Joe Altieri explained the three bids submitted by Broadview Center, Cool Insuring Arena and Visions Veterans Memorial Arena. He indicated the staff recommended Visions Memorial Arena and state committee recommended Cool Insuring Arena, and identified the differences in the recommendations. Mark asked about attendance and revenues in Binghamton. Mike stated there was a major snow storm the first year Binghamton hosted and the following two years attendance exceeded Glens Falls. Mark stated we should go to Binghamton based on the significant financial differences. Robert reviewed attendance figures when Binghamton and Glens Falls hosted this event. Greg gathered the following consensus: CAC recognizes both venues are of high quality and can host the event. The difference in expenses should be considered.
