#### 4.0 **EXECUTIVE DIRECTOR'S REPORT** (M. DiFilippo)

#### 4.1 Motion to approve for Clarence for participate in Division 1 Boys Ice Hockey for the 24-25 school year. **OPPOSED; 4 yes votes, 1 abstain** Taylor/Fallacaro-Dougherty

Per the Section VI Constitution, Article 12 Classification, 12.3 3 Schools must compete within their sectional classification numbers for all sports except Ice Hockey. In the sport of Ice Hockey, teams may move up from the small school division to the large school division. The Ice Hockey exemption will be reevaluated annually.

Concern continues about the contradiction of equity, inclusion, and opportunity, and competition and how they don't always align. In this case, specifically, there is a rule just for Boys Ice Hockey.

The history of the move to change this constitutional item was reviewed. At the May 2023 athletic council meeting, the motion to remove this exception to the constitution was carried. However, per article 10 of the constitution, after an approval of an amendment to the constitution by the athletic council, each member school district must then submit a ballot vote. The results of the ballot vote did not meet the 2/3 minimum to initiate the constitutional change.

#### BELOW IS THE EXCERPT FROM THE MAY 2023 ATHLETIC COUNCIL MEETING MINUTES

Motion to remove the exception for Boys Ice Hockey within 12.3 of Article 12 Classification of the Section VI Constitution. CARRIED 18 in favor, 8 opposed Jeff Roth/House

12.3 Schools must compete within their sectional classification numbers for all sports <del>except Ice</del> Hockey. In the sport of Ice Hockey, teams may move up from the small school division to the large school division. The Ice Hockey exemption will be re-evaluated annually.

The Sectional/Intersectional Committee thought it was important to be consistent and equitable across all sports. It's also thought that with the implementation of the 6 classes that more schools would inquire about moving classifications.

With the approval of this action item and because this is a Constitutional item, a post card ballot will be sent to all school districts. Athletic directors, principals, and superintendents are expected to sign their ballot. A 2/3 vote in favor will enact the removal of the exception to 12.3 of Article 12.

Subsequent results of the post card ballot. 9 districts did not submit a vote 8 districts abstained For the change to occur, 38 votes in favor were needed. There were only 32 votes in favor and 25 Against, which does not meet the 2/3rd minimum vote to initiate the change. Therefore, the constitution will remain unchanged, and Ice Hockey will continue to have the ability to request to play up a classification.

Per the current constitution, this motion must be voted on. Moving forward, the Constitution/Bylaws/Policy Manual Ad Hoc Committee is charged with reexamining this constitutional item.

#### 9.0 GUEST REPORTS

9.1 NYSPHSAA (R. Zayas)

NYSED Mixed Competition Regulatory Amendments (Appendix C) The proposed amendments are trying to provide easier access for a student to gain entry onto a team that doesn't correspond with their biological gender. The regulation would benefit females who want to gain access to an all-male team and a less restrictive pathway for a male to participate on an all-female team. The goal of the proposed amendments is to provide equity, but the concern then becomes an equal access issue.

- 1. R. Zayas cautioned that removing "significant adverse effect" from the current regulation would be problematic. Currently, the regulation states that a male cannot play on a female team if the school or section determine he will have a significant adverse effect. "Significant adverse effect" although broad in nature, provide schools/sections the ability to say the male student-athlete will displace a female student-athlete and/or present a safety concern.
- 2 If a school has a field hockey team and they don't have a male equivalent team sport, then the school will be forced to post selection criteria for that team on the school's website, which will only add criticism to the coach. Selection criteria would only be required to be posted, per the proposed amendments, if the school didn't have a male equivalent team.
- 3 Proposed amendment to eliminate the athletic placement process. If approved, 7<sup>th</sup> and 8<sup>th</sup> graders could tryout for a high school team as long as they have parental consent.

Council members were encouraged to express their concerns, if any, during the 60 day public comment period, which will begin May 22, 2024.

At the September regents meeting, the proposed amendments will be up for a vote. If the proposed amendments are approved, mixed competition would be implemented for the 24-25 winter season, but the APP timeline is July 1, 2025.

R. Zayas is working on a memo to the NYSED Commissioner regarding these concerns as he continues to discuss them with NYSPHSAA membership.

#### Notes:

The GoFan fee structure is \$1 plus 5% of the ticket price, so a \$10.50 ticket would carry a \$1.53 fee and the final price will be \$12.03 for all GoFan venues.

Those venues that do not permit the use of GoFan will continue to allow for cash sales, where the final ticket prices will be \$10.50 plus fees. Tickets for the JMA Wireless Dome and MVP Arena would be \$12.50 due to their current \$2 fee per ticket sold. Tickets sold through contractually obligated platforms such as Ticketmaster or SeatGeek will have additional fees added on, which is outside the control of NYSPHSAA.

Ticket prices were streamlined for NYSPHSAA to net \$10 per ticket in the 2021-2022 school year, with the approval of the all-digital ticketing platform.

Pool play guarantees that each team will play six (6) sets of volleyball (competing against all teams in their class) over an extended period of time, whereas bracket play only guarantees a minimum of 3 sets against one team) which can sometimes be completed in as little as 45 minutes. Student-athletes work tirelessly their entire career with dreams of making it to the NYSPHSAA Final Four. Teams across the state are accustomed to pool play during regular season multi-team tournaments. The pool play format will provide student-athletes a more memorable experience rewarding the hard work and dedication that they have endured to make it to the final four. While pool play and bracket play both have their flaws in determining the two state finalist teams, our committee feels that pool play will ultimately lead to the top two teams in the state facing off in the final match.

Once the committee experienced the length of time it took for six classes playing bracketed play, the initial concern for the length of time it took to add another team to pool play was no longer a concern.

#### **Proposal:**

The NYSPHSAA Football State Committee is seeking approval to move the 8-man regional championship to week #22 and conduct it at the JMA Dome during the 11-man finals. The <u>attached</u> regional rotation for 2024-26 is part of this proposal.

**Effective Start Date:** 

Fall 2024

#### Rationale:

Due to the growth of 8-man football and seeking an additional week to play postseason, the committee would like to play the 8-man championship prior to the first 11-man final or immediately following the last 11-man final on the weekend of week #22. The committee also believes moving the regional final to the Dome creates an equitable situation with 11-man football where both can share the same venue.

The regional rotation being proposed meets the recently established Guiding Principles of Regional Rotations addressing equity in hosting and traveling to regionals.

#### **Proposal Originated:**

NYSPHSAA Football State Committee on December 20, 2023. The State Committee formed a sub-committee and voted 6-2 (plus 1 abstention) to present this to the State Committee. The state committee supported this proposal by an 8-0 vote.

#### **Budgetary Impact:**

In the West Semifinal, since officials, awards, travel, and some facility fees are already rolled into expenses and revenues are accounted for, there won't be any change to the financials. For the East Semifinals, however, an additional game will increase costs, potentially by approximately \$3,000. Anticipated revenue would be \$3,000 based on 300 fans for the additional game, resulting in a net profit/loss of \$0. An additional game at the JMA Wireless Dome will incur an extra \$13,400 in expenses due to facility, staffing, security, etc. However, with anticipated ticket sales of approximately 300 fans generating \$3,000, this would offset some of the costs, resulting in a net loss of approximately \$11,400 for the one additional game.

#### Proposal:

The NYSPHSAA Football Committee is recommending revising the NYSPHSAA Sportsmanship Penalty for the sport of football. Any player disqualified by a sport official for unsportsmanlike behavior or flagrant foul will be ineligible for the next two consecutive halves.

#### **Effective Start Date:**

2024-2025 school year

#### **Rationale:**

Currently, a student-athlete could be disqualified on the first play of a game and would have to sit out that entire game and the following game. This could equate to 25% of their season, based on an 8-game schedule. This is not equal, compared to all other NYS high school team sports. All other sport teams that have 16 or 20 games would only sit out 12.5% or 10% of their season. This rule will make it 12.5% for an 8-game schedule and 10% for a 10-game schedule. More than 75% of all football playing schools only participate in 8 games. This would mirror what the penalty is for a disqualification for targeting currently in the NYSPHSAA handbook.

The Boys Wrestling Committee is recommending allowing Sections to have an early weight Certification date starting no earlier than the Monday of week #17. Schools would be required to register any wrestlers participating in the early certification date by the Saturday of week #15.

#### **Effective Start Date:**

2024-2025 school year

#### **Rationale:**

NYSPHSAA has approved the 1.5% weight loss descent plan for all wrestlers competing in the boys season as of the 2023-2024 season. The weight loss descent plan locks wrestlers into a specific weight based on their certification weight at the beginning of the season. The descent plan is based on a student losing a maximum of 1.5% of their body weight each season. Unfortunately, some wrestlers were not able to compete for a majority of their season because their descent plan did not allow them to get to an eligible weight based on the certification at the beginning of the year. Other wrestlers were not eligible for a desired weight because their plan maxed out right above a particular weight class. If a Section was allowed to have an earlier certification date, then some wrestlers would be able to get certified and then start their weight descent plan 6 weeks prior o the season therefore maximizing their participation. If an earlier start date was allowed this would mean that the Section consultants would have to organize their staffs on two different time periods to certify the wrestlers prior to the season starting. There is also no guarantee that a wrestler will follow the descent plan and be at the desired weight class at the beginning of the season.

There may be an increase cost to the Section but in theory the same amount of wrestlers is being certified before the season.

NOTE: For individual, individual/ team sports, when a school district does not have a team designated for each singular gender, the Section Executive Director may grant a waiver of the Representation Standard for Sectional Competition when a student has met the qualification for participation in the current school year's NYSPHSAA Championship event. *In the sport of Girls Wrestling, if a school does have a team for both genders the female wrestlers may choose to compete in either the boys post season or the girls post season but not both.* 

#### **Effective Start Date:**

2024 - 2025 Season

#### **Rationale:**

The sport of girls wrestling continues to grow across NYS. Some schools are reluctant to start a girl's teams for a variety of reasons because girls are allowed to compete on the boy's team and still be eligible to compete in the girls post season. Data from across the country and shown that many more girls will wrestle if the school offers a girl only team. Until the sport grows to wear female wrestlers can practice and compete against other girls there is still a need for some wrestlers to compete and practice on boys' teams. The committee feels this recommendation will encourage schools to offer a girl's team and still accommodate female wrestlers that have been wrestling on boys teams for many years.

#### Proposal:

The NYSPHSAA Boys and Girls Bowling State Committee is seeking approval to establish two divisions for its Composite Division—Division 1 and Division 2—for competition during the State Tournament.

#### **Effective Start Date:**

Winter (March) 2025

#### **Rationale:**

Splitting the existing composite division by the current division enrollment numbers creates equitable opportunity to qualify for the state championship. The composite division awards state champions for Individuals as well as section teams. With 17,253 varsity bowlers in NYS in 2022-24, bowling would still be within its 5-8% range, per Championship Philosophy.

#### **Proposal Originated:**

Section 5 shared at the committee meeting in March 2024.

#### **Budgetary Impact:**

This does not increase the length of the tournament as unused lanes in the bowling center will be assigned to Division 2 teams. Approximate cost to added lineage is expected to be \$3,000 for an addition 700-864 games. Anticipated attendance is 300-400 additional spectators, equivalent of \$3,000-\$4,000. To send additional teams, sections/schools will incur additional travel and lodging costs for student-athletes competing. NYSPHSAA must also book additional rooms to cover the second division lodging needs.

#### Notes:

The Boys and Girls Bowling State Committees supported this proposal with a 18-0 vote on March 9, 2024.

#### **Proposal:**

The NYSPHSAA Boys and Girls Bowling State Committee is seeking approval to modify the bowling format of the Division 1 and Division 2 school team events during the State Tournament to utilize a 6-man format.

#### **Effective Start Date:**

Winter (March) 2025

#### **Rationale:**

The existing format uses a 5-man format on a single pair of lanes (10 bowlers across 2 lanes). All five (5) scores currently count towards the team game total. While the 6-man format increases bowler participation with the additional competing player, the lowest individual score is dropped from the team total. The 6-man format also utilizes an additional pair of lanes (12 bowlers across 4 lanes) resulting in a more efficient tournament and better experience for student-athletes and fans instead of long days.

#### **Proposal Originated:**

Section V Coordinator shared this concept at the committee meeting in March 2024.

#### **Budgetary Impact:**

An additional 20 competing players over both Division 1 and 2 events will result in an increase of approximately \$500 in lineage cost for NYSPHSAA. With 20 additional players now guaranteed to compete, it may result in additional admissions to offset lineage cost.

#### Notes:

The Boys and Girls Bowling State Committees supported this proposal with a 16-2 vote on March 9, 2024.



# Issue for Discussion

Should the Board of Regents adopt the proposed amendment of sections 135.1, 135.4, and 135.5 of the Regulations of the Commissioner of Education relating to mixed competition and extra class athletics?

# **Reason for Consideration**

Review of Policy.

# Proposed Handling

The proposed amendment is presented to the P-12 Education Committee for discussion at the May 2024 Regents meeting. A copy of the proposed rule (Attachment A) is attached.

# **Procedural History**

A Notice of Proposed Rule Making will be published in the State Register on May 22, 2024, for a 60-day public comment period. Supporting materials are available upon request to the Secretary of the Board of Regents.

# **Background Information**

Girls have an equal right to participate in athletics. The State Education Department first addressed this issue 51 years ago when it adopted amendments to Commissioner's regulation §135.4. This amendment provides parameters for male and female students to participate on the same interschool athletic team under circumstances when a school

did not offer separate male and female teams. These parameters are sometimes referred to as "mixed competition."

Current mixed competition requires female students to obtain the approval of a review panel before they may participate on a team with males in sports including football, basketball, and ice hockey. Federal regulations are even less generous, allowing school districts to prohibit girls from trying out for "contact sports"; *i.e.*, those sports that involve "bodily contact."<sup>1</sup> This policy rests upon a protectionist rationale.

Courts, however, have been skeptical of "[t]he exclusion of girls to protect them from injury," finding that exclusionary policies are arbitrary where schools only consider sex stereotypes "without any regard for the wide range of individual variants within each class."<sup>2</sup>

In 2022, the Department learned that a female student who attended a nonpublic high school was subjected to multiple requirements to which male students were not subjected before being allowed to participate on the boy's football team. The student was required to pass the Presidential Physical Fitness test, undergo a health examination that included the Tanner Sexuality Maturity Rating,<sup>3</sup> submit a written statement of interest, and receive a determination of eligibility to play on the team after a panel evaluation. Some of these requirements were derived from Department guidance regarding mixed competition.

The Department thereafter reviewed its guidance and regulations regarding participation in extra class athletic activities and mixed competition. The Department convened a series of meetings of stakeholders to further inform the development of new regulations and guidance. Stakeholder groups included the New York State Public High School Athletic Association (NYSPHSAA), Office of Children and Family Services, Department of Health, Association for Health, Physical Education, Recreation and Dance (NYSAPHERD), Association of School Nurses, and the Athletic Administrators Association. The Department met with these groups, as well as several students and their family members, on five evenings in October 2023 to discuss the current regulations.

Most participants underscored the importance of considering the well-being and inclusivity of all students, particularly those from marginalized or underrepresented groups such as transgender students. Many questioned the relevance and appropriateness of the current fitness test requirements for mixed competition, as required tests measure types of fitness levels that may not be required for the desired sport (e.g., a mile run for

students who want to participate on the swim team). Almost unanimously, participants stated the requirement for a determination of eligibility to be made by an evaluation panel was unfair, subjective, and lacked transparency. Participants requested standardized decision-making processes across different schools and regions. Participants also raised concerns about maintaining fairness and equity, especially regarding whether male students should be allowed to participate on female teams.

Participants recommended that revised regulations:

- Modify language to promote clarity and inclusivity;
- Update outdated sport lists;
- Eliminate gender distinctions wherever possible;
- Redefine fitness evaluation criteria and impact assessment;
- Replace the review panel procedure with a more straightforward and equitable system;
- Provide clear guidelines when only one gender team is offered and allow members of the other gender to try out; and
- Provide a uniform team selection process for all athletes.

## **Proposed Amendment:**

Based upon the review of the law and research and with guidance from stakeholders and affected students, the Department proposes the following amendment of Part 135 of the Commissioner's regulations. The Department is committed to providing athletes of all genders equal opportunities to play and participate in extra class athletic activities, as athletics are a vital part of any student's education. This includes promoting equality between separate male and female athletic programs and encouraging mixed gender teams. The Department believes this is an important step in ensuring equality.

The proposed amendments also require that where a school employs a selection process for student athletes to participate on a team, eligibility for participation should be determined during the try-out process, where school staff can determine whether student athletes have sufficient sport-related skills, motor development, knowledge of the sport, motivation, cognitive and social development to be on a particular team.

## Terminology

The proposed rule employs gender neutral and gender inclusive language throughout. Additionally, the proposed rule updates outdated terminology used to reference students with disabilities.

# Definitions

The proposed amendment defines the term "extra class athletic activities" and deletes the definitions of "mixed competition" and "physiological maturity."

### **Health Examinations**

The proposed amendment:

- Clarifies that documentation from a licensed health professional, consistent with their scope of practice, is sufficient to determine which areas of the physical education program in which a student with activity limitations can participate.
- It clarifies, and codifies in one section, the requirements for health examination before tryouts begin, ensuring that students provide proof of health examination and clearance to participate in extra class athletic activities. The proposed rule also indicates when an additional health history must be provided in accordance with the Dominick Murray Sudden Cardiac Arrest Act.
- It clarifies that health care providers must assess a student athlete's overall
  physical fitness and readiness to participate while ensuring that the irrelevant
  and intrusive Tanner Rating of secondary sex characteristics is not utilized for
  student athletes who wish to be considered under the Athletic Placement
  Process.
- It permits the district's director of school health services (a.k.a. medical director), after consultation with a student's health care provider, to preclude a student with a severe health condition from participation in extra class athletic activities for health and safety reasons.

## **Requirements for Participation**

Beginning July 1, 2025, the proposed amendment clarifies the Athletic Placement Process for those districts that choose to allow students in grades 7 and 8 to play up to high school level teams or students in grades 9-12 to move down to play at the modified level. These changes ensure that:

- student athletes participate safely at an appropriate level of competition;
- the process includes informed consent of the parent or person in parental relation; and
- that the student successfully demonstrates sufficient personal and social responsibility, sport-specific skill development, knowledge of the game, and physical fitness to be eligible during team selection.

The proposed rule provides that requirements to participate on a team must be the same for all genders for any interschool athletic competition, intramural or extramural extra class athletic activity in any sport, including a sport where there may be a heightened risk for a student athlete's safety.

## Equal Opportunity to Participate in Extra Class Activities

- The proposed amendment requires school districts to provide equal opportunity to students to participate in extra class athletic activities, either on separate teams or on the same team, as follows:
  - By providing separate extra class athletic activities for students of different genders. This is not intended to prevent schools from providing opportunities for students of different genders to play together on the same team; or
  - Where a school does not provide sufficient opportunity for students of different genders to participate on separate teams, schools must permit a student of a different gender to participate in the team selection process. The expectations for personal and social responsibility, health, physical fitness, and sport-specific skill development and knowledge of the game requirements must be the same for students of all genders.
- The proposed amendment requires that criteria for determining whether students will be selected to participate on the team shall be the same for all students who wish to participate, regardless of student-identified gender, and shall be publicly posted on the website of every school district or nonpublic school or school system which elects to be governed by these provisions.
- The proposed amendment requires that if no selection process is employed for participation in a particular extra class athletic activity, all students must be permitted to participate equally, regardless of self-identified gender.
- The proposed amendment clarifies that a person aggrieved by the selection process for participation in interschool competition or the decision that a student cannot participate in such competition may appeal to the Commissioner in accordance with Education Law § 310.

## **Tanner Scale Evaluation and Risk**

The Department proposes elimination of the use of the Tanner Sexual Maturity Rating because, while it has been used as a vehicle to assess risk, there are less intrusive and more accurate ways to do so. The Athletic Placement Process for Interscholastic Programs (APP) is a program for evaluating students who wish to participate in sports at higher or lower levels. The intent of the APP is to provide a protocol for those districts that choose to allow students in grades 7 and 8 to try out for high school level teams (Freshman, Junior Varsity, or Varsity), sometimes referred to as "playing up"; or for students in grades 9-12 to move down, playing at the modified level; allowing students seeking to participate safely at the appropriate level of competition based upon physical and emotional readiness and athletic ability rather than age and grade alone. One part of this process has been to have a student's health care provider or the district's director of school health services (a.k.a., medical director), conduct a health examination that also determines the developmental age or maturity level of the student using the Tanner Sexual Maturity Rating. While Tanner staging conducted by a licensed healthcare provider indicates an approximation of physical development, it is not intended to be used as a means to assess a student's potential for injury related to playing with older or younger students, as it is currently being used in New York State.

Current regulations also require that students with disabilities who wish to participate in inclusive interschool athletic competition undergo the Tanner Sexual Maturity Rating Scale.

The Department recommends elimination of the Tanner Scale, which is intrusive and demeaning. Instead, the Department recommends that schools use research-based<sup>4</sup> factors that affect the likelihood that a student would be more susceptible to injury, including:

- o age;
- kinematics/biomechanics (movement of the body);
- body composition (% fat, bone, and muscle in the body);
- previous injury;
- grade of competition;
- training load (hours per week);
- position played;
- competition or practice;
- o strength;
- player experience;
- o checking, tackling, body contact; and
- o environmental factors.

Other considerations that can impact injury risk are:

- emotional development;
- o student's interest in sports (is the child ready and interested);

- o education and awareness about safety precautions and potential injury;
- o availability and appropriateness of sports safety gear/equipment;
- playing environment: well-lit and appropriate for the sport;
- proper physical conditioning of players';
- knowing and enforcing safety rules';
- o ensuring players are and remain hydrated; and
- taking breaks to prevent overuse injuries.5

## AMENDMENT TO THE REGULATIONS OF THE COMMISIONER OF EDUCATION

Pursuant to sections 207, 803, and 3201-a of the Education Law.

1. Section 135.1 of the Regulations of the Commissioner of Education is amended to read as follows:

Section 135.1. Definitions

Definitions as used in this Part:

(a) ...

(b) ....

(c) ...

(d) ...

(e) Adaptive physical education means a specially designed program of developmental activities, games, sports and rhythms suited to the interests, capacities and [limitations] <u>abilities</u> of [pupils] <u>students</u> with [handicapping conditions] <u>disabilities</u> who may not safely or successfully engage in unrestricted participation in the activities of the regular physical education program.

(f) ...

(g) ...

(h) *Extra class [periods in physical education] <u>athletic activities</u> mean those sessions organized for instruction, [and] practice, <u>and/or competition</u> in skills, attitudes and knowledge through participation in individual, group, and team activities organized on an intramural, extramural, interschool athletic or inclusive athletic basis to supplement regular physical education class instruction.* 

(i) *Extramural activities* mean those games or other events which involve the participation of [pupils] <u>students</u> from two or more school districts and which are conducted as play-days or sports days at the end of the intramural season.

(j) ...

(k) ...

(l) ...

(m) *Intramural activities* mean those activities conducted within one school district involving only those [pupils] <u>students</u> enrolled in such school district and which are organized to serve the entire enrollment.

(n) ...

(0) ...

(p) [*Mixed competition* means the combination of male and female pupils participating on the same interschool athletic teams.

(q)] Organized practice means a session of [an athletic squad or group] <u>a team</u> organized for interschool athletics for the purpose of providing instruction and practice in physical conditioning activities, skills, team play, and game strategy, under the supervision of a qualified school official.

[(r)] (q) *Physical fitness activities* mean those physical activities which are designed to develop endurance, strength, and agility and to fit the individual so that [he] <u>the student</u> can perform the task repeatedly without undue fatigue and with a reserve capacity to meet unexpected stresses and hazards.

[(s) *Physiological maturity* means a stage of maturation identified by the school physician in determining an appropriate level of interschool athletic competition in accordance with standards established by the commissioner.]

[(t)] <u>(r)</u> *Recreation* means the program which is organized to include types of activities such as arts and crafts, athletics, dramatics, music, rhythms, sports, swimming, and water safety provided at the discretion of school district authorities under the supervision of qualified personnel and designed to provide for the worthy use of leisure by individuals and groups.

[(u)] (s) Sports day means a day when [pupils] students from two or more schools meet and engage in a variety of competitive sports events.

[(v)] (t) Section means an organization of schools within a specified geographic area which holds membership in an athletic association, and is established for the purpose of administering athletic programs for the member schools and leagues within such area.

[(w)] (u) Inclusive athletic activities mean those activities which provide competition between representatives of two or more schools and which combine students with and without disabilities on teams for the purpose of interscholastic play and which ensure proportional representation of students with and without disabilities.

2. Section 135.4 of the Regulations of the Commissioner of Education is amended to read as follows:

#### Section 135.4 Physical education

(a) School district plans. It shall be the duty of trustees and boards of education to develop and implement school district plans to provide physical education experiences for all [pupils] <u>students</u> as provided in this section. Such current plans shall be kept on file in the school district office and shall be filed with the Division of Physical Education, Fitness, Health, Nutrition and Safety Services. All school districts shall comply with the provisions of this section by August 1, 1982. However, the requirement for submission of a plan shall become effective by January 1, 1983. A school district

may conduct an instructional physical education program which differs from, but is equivalent to, the required program of instruction set forth in paragraph (2) of subdivision (c) of this section, with the approval of the commissioner. An equivalent program may be implemented only after approval from the Division of Physical Education, Fitness, Health, Nutrition and Safety Services. A request for approval to conduct an equivalent instructional physical education program shall be filed with the Division of Physical Education, Fitness, Health, Nutrition and Safety Services, and shall include the:

(1) ...

(4) ...

(b) Nonpublic schools. Similar courses of instruction shall be prescribed and maintained in private schools in the State, and all [pupils] <u>students</u> in grades kindergarten through 12 shall attend such courses. If such courses are not established and maintained in any private school, instruction in such school shall not be deemed to be substantially equivalent to instruction given to children of like ages in the public school or schools of the city or district in which the child resides.

(c) Program plans. School district plans shall include the following:

(1) Curriculum.

(i) The curriculum shall be designed to:

(a) ...

(h) provide opportunities for the exercise of [pupil] <u>student</u> initiative, leadership and responsibility; and

(iii) There shall be opportunity provided for participation in appropriate [extraclass] <u>extra class athletic</u> activities.

(iv) There shall be activities adapted to meet the needs of [pupils] <u>students</u> who are temporarily or permanently unable to participate in the regular program of physical education. Adaptive physical education programs shall be taught by a certified physical education teacher.

(v) There shall be continuous evaluation of the instructional program and assessment of individual [pupil] <u>student</u> needs and progress. Appropriate cumulative records shall be maintained which cover the essential features of the physical education program for each [pupil] <u>student</u>, and when a [pupil] <u>student</u> transfers to another school, such records shall be transferred with the student's transcript.

(2) Required instruction.

(i) Elementary instructional program--grades K through 6. [Pupils] <u>Students</u> in grades K-6 shall participate in the physical education program as follows:

(a) all [pupils] <u>students</u> in grades K-3 shall participate in the physical education program on a daily basis. All [pupils] <u>students</u> in grades 4-6 shall participate in the physical education program not less than three times each week. The minimum time

devoted to such programs (K-6) shall be at least 120 minutes in each calendar week, exclusive of any time that may be required for dressing and showering;

(b) notwithstanding the provisions of clause (a) of this subparagraph, [pupils] <u>students</u> in grades 5-6 who are in a middle school shall participate in the physical education program a minimum of three periods per calendar week during one semester of each school year and two periods during the other semester, or a comparable time each semester if the school is organized in other patterns; or

(c) ...

(ii) Secondary instructional program--grades 7 through 12. All secondary [pupils] <u>students</u> shall have the opportunity for regular physical education, but not less than three times per week in one semester and two times per week in the other semester, taught by a certified physical education teacher, and all such [pupils] <u>students</u> shall participate in the physical education program either:

(a) ...

(b) ...

(c) for [pupils] <u>students</u> in grades 10 through 12 only, a comparable time each semester in [extra class] <u>interschool athletics</u> programs for those [pupils] <u>students</u> who have demonstrated acceptable levels of physical fitness, physical skills, and knowledge of physical education activities; or

(d) for [pupils] <u>students</u> in grades 10 through 12 only, a comparable time each semester in out-of-school activities approved by the physical education staff and the school administration; or

(e) ...

(3) Attendance.

(i) All [pupils] <u>students</u> shall attend and participate in the physical education program as approved in the school plan for physical education and as indicated by physicians' examinations and other tests approved by the Commissioner of Education. [Individual medical certificates of limitations] <u>For students with activity limitations,</u> <u>documentation from a licensed health professional, consistent with their scope of</u> <u>practice,</u> must indicate the area of the program in which the [pupil] <u>student</u> may participate.

(ii) School district plans shall indicate through the sequential curriculum the steps to be taken to insure that each [pupil] <u>student</u> meets the requirement for participation in <u>a</u> physical education program which complies with the provisions of this section. School districts may award local diploma credit for the required program, and may also submit plans for elective units in physical education for additional credit.

(4) Personnel.

(i) ...

(iii) Each school district operating a high school shall employ a director of physical education who shall have certification in physical education and administrative and supervisory service. Such director shall provide leadership and supervision for the class instruction[, intramural activities, and interschool athletic competition] and <u>extra</u> <u>class athletic activities</u> in the total physical education program. Where there are extenuating circumstances, a member of the physical education staff may be designated for such responsibilities, upon approval of the commissioner. School districts may share the services of a director of physical education.

(6) Administrative procedures.

(i) School district plans for the physical education program shall include information on the following administrative procedures:

(b) appropriate examinations and tests to be employed by school authorities in determining [pupil] <u>student</u> needs and progress in physical fitness, knowledge and skills;

(d) to determine the need for an athletic trainer and to permit individuals to serve as athletic trainers for interschool athletic teams, intramural teams or physical education classes only in accordance with the following:

(2) Scope of duties and responsibilities. The practice of the profession of athletic training shall be as defined in Education Law, section 8352. Consistent with Education

Law, section 8352, the services provided by an athletic trainer shall include, but not be limited to, the following:

(e) to give primary consideration to the well-being of individual [boys and girls] <u>students</u> in the conduct of games and sports;

(h) to equalize insofar as possible the [powers] <u>abilities</u> of opponents in individual and group athletic competition;

(i) to [provide adequate health examination before participation in strenuous activity and periodically throughout the season as necessary, and to permit no to participate in such activity without the approval of the school medical officer] <u>ensure</u> students provide proof of health examination before participation in extra class athletic <u>activities as follows:</u>

(A) a health certificate pursuant to Education Law §903; or

(B) a health appraisal pursuant to Education Law §904.

(ii) For interschool athletics, such health examinations shall be valid for 12 months through the last day of the month the exam was conducted in. Provided however, if the examination was conducted more than 30 days before the start of the season, the student must submit a health history to the school in accordance with standards established by the commissioner. Provided further, if the 12-month period for the health examination expires during an interschool or inclusive athletic season, which includes try outs for that season, or during the scheduled time frame for intramural or extramurals, participants may complete the season or scheduled time frame so long as a health history was submitted not more than 30 days prior to the season for interschool or inclusive athletics, or once during the school year before the student participates in intramural or extramural activities.

(iii) Pursuant to sections 136.5(d) and 136.9(d) of this Subchapter, the director of school health services must approve the resumption of participation of students who are believed to have sustained a mild traumatic brain injury or display signs or symptoms of pending or increased risk of sudden cardiac arrest.

(iv) After consulting with a student's health care provider, the director of school health services may determine that the student may not participate in extra class athletic activities if the student has a severe health condition such that participation would be detrimental to the student's health and safety;

(j) to maintain an equitable division of facilities, budget, equipment, scheduling, and personnel [between boys and girls] <u>opportunities provided for students of different</u> <u>genders;</u>

(k) ...

(p) to provide opportunity for instruction, practice and<u>/or</u> competition for [pupils] <u>students</u> in grades four through six in [extra class programs which shall be basically] intramural <u>and extramural</u> activities;

(q) to provide opportunity for instruction and practice for [pupils] <u>students</u> in grades 7 through 12 in [extra class athletic activities which are] intramural <u>and</u> <u>extramural</u> activities and approved interschool competition;

(r) to limit athletic activities conducted by the school to appropriate competition and practice between [pupils] <u>students</u> in grades 7 through 12[, except that a postgraduate pupil may participate in intramural activities];

(s) to provide the same general degree of opportunity for participation in <u>extra</u> <u>class athletic</u> activities to [both males and females] <u>students, regardless of gender</u>.

(ii) Provisions for interschool athletic activities for [pupils] <u>students</u> in grades 7through 12. It shall be the duty of the trustees and boards of education to conduct

interschool athletic competition for grades 7 through 12 in accordance with the following:

(a) Interschool athletic competition for [pupils] <u>students</u> in junior high school grades seven, eight and nine. Such competition shall be conducted in accordance with the following: Seventh and eighth grade teams may participate only with teams of like grade groups, with the following exceptions:

- (1) ...

(i) [A] (A) Prior to July 1, 2025, board of education may permit pupils in grades no lower than seventh to compete on any senior high school team, or permit senior high school pupils to compete on any teams in grades no lower than seventh, provided the pupils are placed at levels of competition appropriate to their physiological maturity, physical fitness and skills in relationship to other pupils on those teams in accordance with standards established by the commissioner.

(B) Beginning July 1, 2025, a board of education may permit students in grades no lower than seventh to compete on any senior high school interschool athletic team, or permit senior high school students to compete on any teams in grades no lower than seventh, provided the parent or person in parental relation has submitted an informed consent in accordance with standards established by the commissioner and the student successfully demonstrates sufficient personal and social responsibility, sport-specific skill development, knowledge of the game, and physical fitness to be eligible during team selection. Criteria for determining whether students will be selected to participate in the team shall be the same for all students who qualify to tryout, regardless of

student-identified gender, and publicly posted on the website of every school district or nonpublic school or school system which elects to be governed by this clause in accordance with standards established by the commissioner.

(ii) Nothing in this subclause shall prohibit a bona fide seventh or eighth grade student, as defined by section 135.1(g) of this Part, who is regularly enrolled in a public school district organized for [pupils] students in kindergarten through eighth grade that contracts with a neighboring school district or districts on a tuition basis for the education of its high school students pursuant to Education Law sections 2040 and 2045 and section 174.4 of this Title, from seeking to participate in a high school team, in accordance with the standards described in item (i) of this subclause, provided that the boards of education of the sending school district (as such term is defined in section 174.4(a)(1) of this Title) and the receiving school district(s) (as such term is defined in section 174.4(a)(2) of this Title) adopt a resolution to permit such participation. In the case of seventh and eighth grade students attending a public school district organized for [pupils] students in kindergarten through eighth grade that contracts with more than one neighboring school district for the education of its high school students, any such seventh or eighth grade student who participates in high school athletics pursuant to this subclause may select only one high school in which to compete during their seventh and eighth grade participation; if, following participation in a high school team during seventh and/or eighth grade, such student chooses to attend a different high school with which the student's kindergarten through eighth grade school district contracts for the education of its high school students, such student shall be ineligible to participate in any interscholastic athletic contest in a particular sport for a period of one year.

(b) Interschool athletic competition and inclusive athletic activities for [pupils] <u>students</u> in senior high school grades 9, 10, 11 and 12. Inter-high school athletic

competition and inclusive athletic activities shall be limited to competition between high school teams, composed of [pupils] <u>students</u> in grades 9 to 12 inclusive, except as otherwise provided in subclause (a)(4) of this subparagraph for interschool athletic competition. Such activities shall be conducted in accordance with the following:

(1) Duration of competition. A [pupil] student shall be eligible for senior high school athletic competition in a sport during each of four consecutive seasons of such sport commencing with the [pupil's] student's entry into the ninth grade and prior to graduation, except that otherwise eligible students graduating at the end of the spring semester may continue to participate in athletics until the conclusion of the spring interscholastic athletic season, or except as otherwise provided in this subclause, or except as authorized by a waiver granted under clause (d) of this subparagraph to a student with a disability, or as authorized for participation in inclusive athletic activities pursuant to clause (e) of this paragraph. If a board of education has adopted a policy, pursuant to subclause (a)(4) of this subparagraph, to permit [pupils] students in the seventh and eighth grades to compete in senior high school athletic competition, such [pupils] students shall be eligible for competition during five consecutive seasons of a sport commencing with the [pupil's] student's entry into the eighth grade, or six consecutive seasons of a sport commencing with the pupil's entry into the seventh grade. A [pupil] student enters competition in a given year when the [pupil] student is a member of the team in the sport involved, and that team has completed at least one contest. A [pupil] student shall be eligible for interschool competition in grades 9, 10, 11 and 12 until the last day of the school year in which he or she attains the age of 19, except as otherwise provided in subclause (a)(4) or clause (d) of this subparagraph, or in this subclause. The eligibility for competition of a [pupil] student who has not attained

the age of 19 years prior to July 1st may be extended under the following circumstances.

(i) If sufficient evidence is presented by the chief school officer to the section to show that the [pupil's] <u>student's</u> failure to enter competition during one or more seasons of a sport was caused by illness, accident, documented social/emotional condition, or documented social/emotional circumstances beyond the control of the [pupil] <u>student</u>, such [pupil's] <u>student's</u> eligibility shall be extended accordingly in that sport. In order to be deemed sufficient, the evidence must demonstrate that:

(A) the [pupil's] <u>student's</u> failure to enter competition during one or more seasons of a sport was caused by illness, accident, documented social/emotional condition or documented social/emotional circumstances beyond the control of the [pupil] <u>student;</u>

(B) as a direct result of such circumstances the [pupil] <u>student</u> is required to attend school for one or more additional semesters in order to graduate; and

(C) such participation would not have a significant adverse effect upon the opportunity of other [pupils] <u>students</u> to participate successfully in interschool competition in the sport. However, nothing herein shall be construed to extend a student's eligibility beyond the age of 19, except as provided in clause (ii)(d) of this subparagraph.

(ii) If the chief school officer demonstrates to the satisfaction of the section that the [pupil's] <u>student's</u> failure to enter competition during one or more seasons of a sport is caused by such [pupil's] <u>student's</u> enrollment in a national or international student exchange program or foreign study program, that as a result of such enrollment the [pupil] <u>student</u> will be required to attend school for one or more additional semesters in order to graduate, and that the [pupil] <u>student</u> did not enter competition in any sport

while enrolled in such program, such [pupil's] <u>student's</u> eligibility shall be extended accordingly in such sport.

(iii) If the section declines to extend the [pupil's] student's eligibility in accordance with this subclause, the section shall provide written notice of such determination to the chief school officer, with a copy to the [pupil's] student's parent, guardian or person in parental relation. Such notice shall include, as applicable: information regarding the athletic association's internal appeal process, including the name of the individual and address to which such appeal is to be directed; or a statement that the determination may be appealed to the Commissioner of Education, in accordance with Education Law section 310, within 30 days of the date of such determination and shall include the name and address of the section official upon whom such appeal shall be served. If the athletic association hears and denies an appeal, written notice of the determination shall be provided to the chief school officer, with a copy to the [pupil's] student's parent, guardian or person in parental relation. Such notice shall include a statement that the determination may be appealed to the Commissioner of Education, in accordance with Education Law, section 310, within 30 days of the date of such determination and shall include the name and address of the athletic association official upon whom such appeal shall be served.

(2) Registration. A [pupil] <u>student</u> shall be eligible for interschool competition or inclusive athletic activities in a sport during a semester, provided that [he or she] <u>the</u> <u>student</u> is a bona fide student, enrolled during the first 15 school days of such semester, is registered in the equivalent of three regular courses, is meeting the physical education requirement, has not graduated from high school, except that otherwise eligible students graduating at the end of the spring semester may continue to participate in athletics until the conclusion of the spring interscholastic athletic season

and has been in regular attendance 80 percent of the school time, bona fide absence caused by personal illness excepted. Nothing in this clause shall be construed to preclude a chief school officer, athletic association, league or section from duly considering a request for an accommodation on behalf of an otherwise qualified student with a disability who is not registered in the equivalent of three regular courses as a result of [his or her] their individualized education program under the Individuals with Disabilities Education Act or education plan approved under section 504 of the Rehabilitation Act of 1973 or the Americans with Disabilities Act.

(3) Sports standards. Interschool athletic programs shall be planned so as to provide opportunities for [pupils] <u>students</u> to participate in a sufficient variety of types of sports. Inclusive athletic activities shall be planned so as to provide proportional representation of students with and without disabilities and meaningful participation. Sports standards, such as number of contests, length of seasons, time between contests, required practice days, etc., for all interschool sports shall conform to guidelines established by the Commissioner of Education.

(c) [Male and female pupils on interschool athletic teams and inclusive athletic activities] Equal opportunity to participate in extra class athletic activities.

(1) Equal opportunity to participate in <u>extra class athletic activities</u> [interschool competition and inclusive athletic activities], either on separate teams or [mixed competition] on the same team, shall be provided to [male and female] students, except as hereinafter provided. In schools that do not provide separate [competition] <u>extra</u> <u>class athletic activities</u> for [male and female] students <u>of different genders</u> in a specific [sport] <u>activity</u>, no student shall be excluded from such [competition solely by reason of sex] <u>activity</u>, except in accordance with the provisions of [subclauses (2) and (4)]

<u>subclause (3)</u> of this clause. [For the purposes of this clause, baseball and softball shall be considered to constitute a single sport.]

(2) [In the sports of baseball, basketball, boxing, field hockey, football, ice hockey, lacrosse, rugby, soccer, softball, speedball, team handball, power volleyball where the height of the net is set at less than eight feet, and wrestling, the fitness of a given student to participate in mixed competition shall be determined by a review panel consisting of the school physician, a physical education teacher designated by the principal of the school, and if requested by the parents of the pupil, a physician selected by such parents. Such panel shall make its determination by majority vote of the members, and in accordance with standards and criteria issued by the department.

(3)] Where a school provides separate [competition] <u>extra class athletic activities</u> for [male and female pupils in] <u>students of different genders.</u> [interschool athletic competition or inclusive athletic activities in a specific sport, the superintendent of schools, or in the case of a nonpublic school or school system which elects to be governed by this clause, the chief executive officer of the school or school system, may permit a female or females to participate on a team organized for males. However, where separate competition is provided, males may not participate on teams organized for females] <u>students shall participate in the separate extra class athletic activities provided for the student's identified gender</u>. This requirement does not prevent schools from providing opportunities for students of different genders to play together on the same team.

[(4)](3) Where a school does not provide [separate competition for male and female pupils] <u>separate opportunity for students of different genders</u> in <u>the same extra</u> <u>class athletic activities</u>, [interschool athletic competition or inclusive athletic activities in a specific sport] the superintendent of schools, or in the case of a nonpublic school or

school system which elects to be governed by this clause, the chief executive officer of the school or school system[, or the section may decline to permit a male or males to participate on a team organized for females upon a finding that such participation would have a significant adverse effect upon the opportunity of females to participate successfully in interschool competition or interschool athletic activities in that sport] shall ensure that students of a different gender are able to participate fully in the team selection process, if applicable, and that expectations for personal and social responsibility, sport-specific skill development, knowledge of the game, and physical fitness are the same for all students, regardless of gender. If a school develops criteria for determining whether students will be selected to participate on the team, these criteria shall be the same for all students who wish to participate, regardless of studentidentified gender, and shall be publicly posted on the website of every school district or nonpublic school or school system which elects to be governed by this clause. If there is no selection process employed for participation in a particular extra class athletic activity, all students shall be permitted to participate equally, regardless of identified gender.

(4) A person aggrieved by the selection process employed for participation in interschool competition or a decision that a student cannot participate in interschool competition based on such selection process may appeal to the Commissioner in accordance with Education Law § 310.

(*d*) Waiver from the age requirement and four-year limitation for interschool athletic competition for students with disabilities in senior high school grades 9, 10, 11, and 12. For purposes of this clause, the term non-contact sport shall include swimming and diving, golf, track and field, cross country, rifle, bowling, gymnastics, skiing and archery, and any other such non-contact sport deemed appropriate by the

Commissioner. A student with a disability, as defined in section 4401 of the Education Law, who has not yet graduated from high school, except that otherwise eligible students graduating at the end of the spring semester may continue to participate in athletics until the conclusion of the spring interscholastic athletic season, may be eligible to participate in a senior high school noncontact athletic competition under the following limited conditions:

(1) such student must apply for and be granted a waiver to the age requirement and four-year limitation prescribed in subclause (b)(1) of this subparagraph. A waiver shall only be granted upon a determination by the superintendent of schools or chief executive officer of the school or school system, as applicable, that the given student meets the following criteria:

(*i*) such student has not graduated from high school as a result of [his or her] <u>the</u> <u>student's</u> disability delaying [his or her] <u>the student's</u> education for one year or more;

(*ii*) such student is otherwise qualified to compete in the athletic competition for which [he or she] <u>the student</u> is applying for a waiver and the student must have been selected for such competition in the past;

(*iii*) such student [has undergone a physical evaluation by the school physician, which shall include an assessment of the student's level of physical development and maturity, and the school physician has determined that the student's participation in such competition will not present a safety or health concern for such student] <u>successfully demonstrates sufficient personal and social responsibility, sport-specific skill development, knowledge of the game, and physical fitness to be eligible during team selection; and</u>

(*iv*) ...

(2) ...

(e) Exemption from the age requirement and four-year limitation for inclusive athletic activities. A student who is enrolled in grades 9 through 12 and has not yet graduated from high school, except that otherwise eligible students graduating at the end of the spring semester may continue to participate in athletics until the conclusion of the spring interscholastic athletic season, may be eligible to participate in inclusive athletic activities under the following limited conditions:

(1) such student may be granted an exemption to the age requirement and fouryear limitation prescribed in subclause (b)(1) of this subparagraph. An exemption shall only be granted upon a determination by the superintendent of schools or chief executive officer of the school or school system, as applicable, that the given student meets the following criteria:

(*i*) ...

(*ii*) such student is otherwise qualified to compete in the inclusive athletic activities for which [he or she] <u>the student</u> is applying for an exemption; and

(*iii*) such student [has undergone a physical evaluation by the director of school health services which shall include an assessment of the student's level of physical development and maturity, and the director of school health services has determined that the student's participation in such activities will not present a safety or health concern for such student] <u>successfully demonstrates sufficient personal and social responsibility</u>, <u>sport-specific skill development</u>, knowledge of the game, and physical fitness to be eligible during team selection; and

(2) ...

3. Subdivision (a) of section 135.5 of the Regulations of the Commissioner of Education is amended to read as follow:

(a) Coaches of extra class [periods in physical education] <u>athletic activities</u>, as defined in section 135.1(h) of this Part, shall meet the requirements of this section.

**Call to Order** by Chair Greg Ransom at 1:07 pm. He asked for a motion to approve the minutes of the January 10, 2024 meeting. **MOTION by Deb. SECOND by Jamie. CARRIED 10-0.** 

Greg offered Joe opening announcements. Joe wished colleague Todd Nelson a Happy Birthday and introduced intern Joe Baez. He also stated although every committee works hard on their proposals, he wanted to make a point, in conjunction with the office, the fall sport committees put in many hours of work on and off zoom calls to get their regional rotations to meet as many guiding principles as they could. He thanked them for that.

#### **PROPOSALS**

(These items will be presented as discussion or action at the next Executive Committee Mtg) Following proposal presentations by Sport Coordinators, Greg announced Sport Coordinators may depart the call so the CAC can discuss and vote on proposals.

**Outdoor Track 3<sup>rd</sup> Division Classification** – Girls Coordinator Tom Wells explained the proposal. Kathy asked if they will be called divisions or classes. Tom stated they will be divisions. Kathy indicated the trickle down effect with combined teams, etc. Greg asked the rationale of the breakdown (25%, 25%, 50%). Tom responded Division 1 is 40% of the individuals in NYS, Division 2 is 30% and Division 3 is 30% based on the NYSPHSAA participation survey. Todd noted traditionally with two divisions, D1 was 30% and D2 was 70% so the logic was to break down the 70% into D2 and D3. Mark asked if track looked at size of teams in our state. Tom said yes and agreed size may make a difference but there's about 6,000 athletes in D2 and D3 and 8,000 in D1 so they believe it's equitable.

During the CAC-only discussion, Greg asked if they will review this every year. Todd said no they are a variation sport. Mike asked if they can run a three-division meet in two days. Todd noted that question was answered in the original proposal and they can do it in two days. Joe stated they are also looking at other options to

shorten the meet. Greg asked if the most athletes are in the bottom class. Todd clarified the most teams are in the bottom class, not athletes. The athletes are spread out in three classes. Deb commended the track committee for diving deep into how many athletes within those teams exist then figuring out the number. **MOTION by Mike A. to support the proposal. SECOND by Josh. CARRIED 10-0.** 

**Boys/Girls Bowling Modify D1 & D2 to a Six-Person Format** – Coordinator Eileen Shultis explained the proposal. Eileen clarified this is not an additional cost to schools/sections. The extra competitors are already on the bench at the state tournament. Now they would all compete. Joe confirmed travel and lodging for schools/sections will be removed from the proposal.

MOTION by Jamie to support the proposal. SECOND by Deb. CARRIED 10-0.

**Boys/Girls Bowling Split Composite Division into Two Divisions** – Coordinator Eileen Shultis explained the proposal. Greg asked if they are within the 5-8% of participation of the Championship Philosophy. Eileen stated yes. Joe reported there are over 17,000 varsity boys and girls bowling participants in bowling in NYS.

During CAC-only discussion, Greg asked if the office had a concern about costs. Joe stated anytime there is an increase in costs there is a concern however, this proposal is anticipated to cover costs with the additional admissions coming through the door.

MOTION by Kathy to support the proposal. SECOND by Mike A. CARRIED 9-1.

**Girls Wrestling Section Qualifier** – Assistant Director Todd Nelson explained the proposal. Greg asked if the format has been established. Todd indicated the details of the plan have not been determined yet and will be at the next girls wrestling meeting. Greg stated he's comfortable with the concept but wants the CAC to review it at their next meeting. Kathy noted Sections IV and V voted no because they wanted a regional tournament format.

**MOTION by Josh to support the proposal. SECOND by Susan. During discussion, Josh rescinded his motion and Susan rescinded her second.** It was agreed to table this until the June CAC meeting when the details of the format are determined by the girls wrestling committee.

**Girls Volleyball Revert Back to Pool Play for States**– Coordinator Peggy Seese explained the proposal. No questions or concerns were raised.

During CAC-only discussion, Todd clarified their reasoning for pool play and also noted the committee was most comfortable with this. Deb stated coaching philosophy within this committee may be a factor in their struggles on deciding what they want to do.

MOTION by Josh to support the proposal. SECOND by Jamie. CARRIED 8-2.

**Football 8-Man Regional Date and Site Revision** – Coordinator Gary Vanderzee explained the proposal. No questions/concerns were raised.

During CAC-only discussion, Adam inquired about finances and the estimated loss or expense. Joe clarified we're adding \$13,400 in expenses for an extra game at the Dome and anticipating \$3,000 in admissions revenue to create an \$11,4000 net loss. Todd stated the reason for this proposal coming forward was due to the growth of football; 8-man needed an extra week to fit in the games. Deb had a concern about the

significant cost for one game. Adam asked if its equitable to allow a regional game at this type of venue while Kathy inquired if Flag Football and other regional sports will be seeking a larger venue someday as well. Todd stated the backup would be to schedule the game outside if it wasn't at the Dome. Greg indicated he will report to Executive Committee that CAC is opposed because it's not a state championship and other regional sports do not play at venues like this in addition the finances and the schedule. Eileen said 8-man was created to keep schools involved in football and indicated we do invitational events to promote other sports. **MOTION by Josh to support the proposal. SECOND by Jamie. DEFEATED 9-1.** 

**REGIONAL ROTATION with Guiding Principles - FOOTBALL** – Coordinator Gary Vanderzee explained the proposal. No questions/concerns were raised. **MOTION by Adam to support the proposal. SECOND by Deb. CARRIED 10-0.** 

**REGIONAL ROTATION with Guiding Principles – GIRLS VOLLEYBALL–** Coordinator Peggy Seese explained the proposal. No questions/concerns were raised. **MOTION by Mike A. to support the proposal. SECOND by Adam. CARRIED 9-1.** 

**REGIONAL ROTATION with Guiding Principles – FIELD HOCKEY –** Coordinator Bev Hooper explained the proposal. No questions/concerns were raised. **MOTION by Kathy to support the proposal. SECOND by Deb CARRIED 9-1.** 

**REGIONAL ROTATION with Guiding Principles – GIRLS TENNIS TEAM –** Coordinator Chris Horgan explained the proposal. He also stated, at one point his committee discussed the idea of all sections sending their champion to the state tournament and being seeded before competition, which would help with equity. No questions/concerns were raised.

MOTION by Mike A. to support the proposal. SECOND by Jamie. CARRIED 10-0.

**REGIONAL ROTATION with Guiding Principles – GIRLS SOCCER –** Coordinator Joe Vaz explained the proposal. No questions/concerns were raised.

MOTION by Adam to support the proposal. SECOND by Mark. CARRIED 8-2.

**REGIONAL ROTATION with Guiding Principles – BOYS SOCCER –** Coordinator Mike Andrew explained the proposal. No questions/concerns were raised. **MOTION by Mike A to support the proposal. SECOND by Deb. CARRIED 8-2.** 

Kathy asked about the 9-2 girls vote and 6-5 boys vote to recommend these rotations. Mike indicated his committee was not pleased with the process more than the outcome. They felt rushed, they wanted a shorter term, different matchups, etc. Kathy reported her section received information last Monday and did in fact feel rushed in the process. Mike responded that the girls committee did not have an issue with the timeline to review and recommend the rotation.

Susan applauded all the committees for looking at regional rotations however she noted certain sections were still given opportunities to consistently play each other in the new regional rotations. Joe respectfully stated the priority was to create equity in sub-regionals and that was accomplished in every fall rotation. Because of that, other areas of the regional rotations were impacted and following the guiding principles.

#### **REVISED PROPOSALS OR STATUS UPDATES**

**Boys/Girls Bowling At Large for Pacer Team Proposal** – Assistant Director Joe Altieri provided a status update on this proposal which was <u>recommended by the CAC with a 9-1 vote at the January 10<sup>th</sup></u> <u>meeting</u>. He explained there were concerns from the Executive Committee in May so he asked the Bowling Committees to re-consider that a minimum of 10 teams in a section be eligible for the at-large berth. The committee convened, discussed and reaffirmed their vote to go forward with the original proposal. Greg stated he does not object to the at-large berth but is not in favor of eliminating sections to be eligible for it. Josh agreed and stated this at the February 1<sup>st</sup> meeting. Susan cited the similarities of other sports like football allowing all sections the opportunity to be included.

#### FOR REVIEW/INPUT/CHAMPIONSHIP SITE SELECTIONS:

**Boys Soccer 2025-27** – Assistant Director Joe Altieri explained the two bids submitted by Middletown High School (Section IX) and Hudson Valley CC/LaSalle Institute (Section 2). He indicated both staff and state committee agreed on Middletown as the recommendation. Both Joe and Mike Andrew reported both bids were outstanding which made it a difficult decision. **CAC expressed no concerns with the recommendations.** 

**Gymnastics 2025-26 RE-BID** – Assistant Director Joe Altieri explained this was a re-bid and Clarence HS in Section VI (2025) and Whitesboro HS in Section III (2026) were the only two sites to submit a bid for just two years. He indicated both staff and state committee agreed on the join bid for 2025 and 2026. **CAC expressed no concerns with the recommendations.** 

#### **INFORMATIONAL:**

**Boys & Girls Swimming/Diving Standards for 2024-25** – Joe explained due to both sports staying within 5-8% participation rate, per Championship Philosophy Committee, the standards will remain the same.

**2023-28 Championship Dates & Sites** – Joe noted the updated championship documents in the packet noting the championship recommendations above. He pointed out the changes to boys tennis this spring (Fri, Sat, Sun) and girls tennis in the fall (Mon, Tue, Weds).

MOTION by Josh SECOND by Deb. CARRIED 10-0. The meeting adjourned at 2:47 pm.

Transitional skills alone do not get points for the Driver, only if they lead into or out of something else.

Future discussion of a Way to identify and reward use of single based skills potentially as an added driver for COED teams

#### Pyramid

Clearly define Pyramid. Allow any skill performed in pyramid section to count in pyramid section. Define pyramid to begin once skills are in a position to be in place to connect (work on that wording). Still working on this clarification

#### Cheer

Work on adding the extra video into the rotation demonstrating the types of Cheer, and how to score and maximize points with either style

<u>**Classification Breakdown**</u> The Committee recommends that schools are assigned to three divisions based on BEDS. 100% of the BEDS numbers will be used for the 24.25 school year for combined teams since swimming is technically a one classification sport. This will have very minimal impact on classification organization.

The S/I Committee will review this proposal for all 3 sports (Girls Swim, Boys Swim, Indoor Track) with their respective leagues before making recommendation. This proposal is excused from the request for approval of this report at the May 15, 2024 athletic council meeting. (Sectional Intersectional April 10, 2024)

The Committee also recognizes that BEDS numbers do not always correlate to a team's strength and performance. Therefore, utilizing crossover meet opportunities again this fall, based on 2023 results, will help to strengthen competition and build programs.

<u>Sectional 6 Classification Championship Meets / State Qualifier Meet</u> The format used for Class championships hosted by member schools as a three-day format (swim prelims, diving, swim finals) worked well in the 2022 and 2023 seasons.. A timed final state qualifier meet held at a college facility, recognizing the fastest swimmer/top diver within the section. Both the boys and girls committees continue to evaluate this format, based on data reports available through swimcloud to determine if we are giving athletes the best opportunity to be the most successful.

#### Team Sectional Championship - Year 3

#### Of Special Note:

- We continue to have the lowest % of teams participating in Team Sectionals across the State. (15 in 2023)
- Teams need to make sure that they have scheduled enough matches for players to be eligible. They
  need to have played 6 matches in order to be eligible for sectional play.
- 3. We will again use a top 8 format for each division because of low participation with teams from each league being represented fairly. The committee would like some flexibility in case more or less teams choose to participate.
- 4. Clarification of practice/line-up rules will again be made prior to the tournament.
- In the Section VI Team Championship tournament, we will use the following format to match the format at the state level.
  - Division 1 3 singles and 4 doubles (11 players) If you do not have enough players to field all positions, you will forfeit at that position.
  - Division 2 2 singles and 3 doubles (8 players) \*Format is part of a 2-year pilot that will be used for 2024 and 2025. \*\*\*\*\*

#### **Team Sectionals**

#### Day 1 - Saturday September 28th: Quarterfinals and Semifinals

8 Team Bracket - Single elimination Draw

This will be a regular scoring, best 2 out of 3 set matches.

Seeds will be based on team record up until Sept. 20th, BEDS, perceived strength according to chairpersons, and may consist of UTR, past performances, or other information available at that time. The goal is to have a fair and equitable tournament for all teams in order to send our strongest team to Regionals.

Once a site is determined (Division 1 must be at a site with 8 courts if at all possible), a schedule of time will be made available.

#### Day 2 - Tuesday October 8th: Finals

This will be a regular scoring, best 2 out of 3 set match using the format listed above. The winners will advance to Regionals vs. Section V during the week of October 21st.

# In case of rain, we will use the next available day to get the matches in. In some cases, we may need to use a Sunday, or more sites/multiple days.

#### Sectional Championship matches will take precedence over league matches.

#### Changes in Policy/Practice for the upcoming season

For the Individual Sectionals each league will send reps as follows: ECIC (7), NFL (3), CCAA (3), Buffalo (3). If Buffalo again does not send a full field, the next highest seeded players amongst the CCAA, NFL and ECIC (as agreed upon by the committee) will fill in the brackets.

The Executive Committee approved a 2 singles/3 doubles format for Division 2 NYSPHSAA Team Championships as a two-year pilot which will be used in the 2024 and 2025 girls' team championships. Therefore, in the postseason - we will use that same format for Division 2 Team Sectional Tournament as well as the Section VI vs Section V regional match.

For the 2024 NYSPHSAA Individual Tournament, Section 6 will send 3 singles qualifiers and 4 doubles teams.

NYSPHSAA has received an offer by Diadem for a five-year agreement to provide all the tennis balls for the state tournaments (individual & team) and sectional level tournaments. These tennis balls are USTA and ITF approved for tournament play. This is not a done deal.

#### Rule Changes for 2024-2025:

We will follow the most up-to-date safety information and protocols (if any) regarding Covid-19.

#### **Other Pertinent Data**

- A joint proposal for boys and girls tennis was approved which states that all NYSPHSAA tennis players are required to claim their profile in the Universal Tennis Rating (UTR) system prior to the season. Coaches/schools are also required to claim their teams and update their rosters. This provides NYSPHSAA and member sections a comprehensive system to properly seed its tournaments..
- <u>2.</u> Coaches will be required to report scores using the UTR website as our official score reporting site. This is free and step by step instructions will be given. The UTR is the most important number when it comes to seeding players at the State level and for many sections, at the section level as well.
- <u>3.</u> We will hold our <u>Section 6 individual tournament</u> at the Lakewood YMCA. The club has already committed to hosting the event and has agreed to the proposed tentative start times. They have agreed to 5 courts on Friday and 4 courts on Saturday.
- Section VI will be hosting the Section VI vs. Section V Regional matches this year on the week of October
   21st and a location to be determined as well as times.
- 5. The Individual State tournament will be held Monday October 28th to Wednesday October 30th, at the USTA National Tennis Center in Flushing, NY. I am awaiting more info to confirm on a block of 10 rooms

at a host hotel.

- <u>6.</u> The transportation/meal/hotel policy has worked out very well for years now and I would again recommend continuing with this policy.
- <u>7.</u> The State committee seeding meeting at the State Tournament will be held on Sunday October 27th.

#### APPENDIX F

#### Exchange Students

We request a review of the NYSPHSAA regulation regarding foreign exchange students. Alden had a student mired in a ruling on this last fall. The student had participated in a very recreationlevel soccer program in her home country. She was staying with a district employee (who has hosted foreign exchange students in the past multiple times). Because of her connection with this teacher and NYSPHAA regulations, she was originally barred from competing at the JV level of soccer.

We believe that, at the lower levels of interscholastic sports (such as modified and JV) in which sectional or state titles are not awarded, school records are not kept, and scholarships are not earned, there was no reason why this young person with very limited recreational experience in the sport should have been restricted originally.

Again, Alden believes that the situations should be viewed on a case-by-case basis, with competitive advantages considered.
