The GoFan fee structure is \$1 plus 5% of the ticket price, so a \$10.50 ticket would carry a \$1.53 fee and the final price will be \$12.03 for all GoFan venues.

Those venues that do not permit the use of GoFan will continue to allow for cash sales, where the final ticket prices will be \$10.50 plus fees. Tickets for the JMA Wireless Dome and MVP Arena would be \$12.50 due to their current \$2 fee per ticket sold. Tickets sold through contractually obligated platforms such as Ticketmaster or SeatGeek will have additional fees added on, which is outside the control of NYSPHSAA.

Ticket prices were streamlined for NYSPHSAA to net \$10 per ticket in the 2021-2022 school year, with the approval of the all-digital ticketing platform.

The NYSPHSAA Football State Committee is seeking approval to move the 8-man regional championship to week #22 and conduct it at the JMA Dome during the 11-man finals. The **attached** regional rotation for 2024-26 is part of this proposal.

Effective Start Date:

Fall 2024

Rationale:

Due to the growth of 8-man football and seeking an additional week to play postseason, the committee would like to play the 8-man championship prior to the first 11-man final or immediately following the last 11-man final on the weekend of week #22. The committee also believes moving the regional final to the Dome creates an equitable situation with 11-man football where both can share the same venue.

The regional rotation being proposed meets the recently established Guiding Principles of Regional Rotations addressing equity in hosting and traveling to regionals.

Proposal Originated:

NYSPHSAA Football State Committee on December 20, 2023. The State Committee formed a sub-committee and voted 6-2 (plus 1 abstention) to present this to the State Committee. The state committee supported this proposal by an 8-0 vote.

Budgetary Impact:

In the West Semifinal, since officials, awards, travel, and some facility fees are already rolled into expenses and revenues are accounted for, there won't be any change to the financials. For the East Semifinals, however, an additional game will increase costs, potentially by approximately \$3,000. Anticipated revenue would be \$3,000 based on 300 fans for the additional game, resulting in a net profit/loss of \$0. An additional game at the JMA Wireless Dome will incur an extra \$13,400 in expenses due to facility, staffing, security, etc. However, with anticipated ticket sales of approximately 300 fans generating \$3,000, this would offset some of the costs, resulting in a net loss of approximately \$11,400 for the one additional game.

The NYSPHSAA Football Committee is recommending revising the NYSPHSAA Sportsmanship Penalty for the sport of football. Any player disqualified by a sport official for unsportsmanlike behavior or flagrant foul will be ineligible for the next two consecutive halves.

Effective Start Date:

2024-2025 school year

Rationale:

Currently, a student-athlete could be disqualified on the first play of a game and would have to sit out that entire game and the following game. This could equate to 25% of their season, based on an 8-game schedule. This is not equal, compared to all other NYS high school team sports. All other sport teams that have 16 or 20 games would only sit out 12.5% or 10% of their season. This rule will make it 12.5% for an 8-game schedule and 10% for a 10-game schedule. More than 75% of all football playing schools only participate in 8 games. This would mirror what the penalty is for a disqualification for targeting currently in the NYSPHSAA handbook.

The Boys Wrestling Committee is recommending allowing Sections to have an early weight Certification date starting no earlier than the Monday of week #17. Schools would be required to register any wrestlers participating in the early certification date by the Saturday of week #15.

Effective Start Date:

2024-2025 school year

Rationale:

NYSPHSAA has approved the 1.5% weight loss descent plan for all wrestlers competing in the boys season as of the 2023-2024 season. The weight loss descent plan locks wrestlers into a specific weight based on their certification weight at the beginning of the season. The descent plan is based on a student losing a maximum of 1.5% of their body weight each season. Unfortunately, some wrestlers were not able to compete for a majority of their season because their descent plan did not allow them to get to an eligible weight based on the certification at the beginning of the year. Other wrestlers were not eligible for a desired weight because their plan maxed out right above a particular weight class. If a Section was allowed to have an earlier certification date, then some wrestlers would be able to get certified and then start their weight descent plan 6 weeks prior to the season therefore maximizing their participation. If an earlier start date was allowed this would mean that the Section consultants would have to organize their staffs on two different time periods to certify the wrestlers prior to the season starting. There is also no guarantee that a wrestler will follow the descent plan and be at the desired weight class at the beginning of the season.

NOTE: For individual, individual/ team sports, when a school district does not have a team designated for each singular gender, the Section Executive Director may grant a waiver of the Representation Standard for Sectional Competition when a student has met the qualification for participation in the current school year's NYSPHSAA Championship event. *In the sport of Girls Wrestling, if a school does have a team for both genders the female wrestlers may choose to compete in either the boys post season or the girls post season but not both.*

Rationale:

The sport of girls wrestling continues to grow across NYS. Some schools are reluctant to start a girl's teams for a variety of reasons because girls are allowed to compete on the boy's team and still be eligible to compete in the girls post season. The NYSPHSAA Boys and Girls Bowling State Committee is seeking approval to establish two divisions for its Composite Division—Division 1 and Division 2—for competition during the State Tournament.

Effective Start Date:

Winter (March) 2025

Rationale:

Splitting the existing composite division by the current division enrollment numbers creates equitable opportunity to qualify for the state championship. The composite division awards state champions for Individuals as well as section teams. With 17,253 varsity bowlers in NYS in 2022-24, bowling would still be within its 5-8% range, per Championship Philosophy.

Proposal Originated:

Section 5 shared at the committee meeting in March 2024.

Budgetary Impact:

This does not increase the length of the tournament as unused lanes in the bowling center will be assigned to Division 2 teams. Approximate cost to added lineage is expected to be \$3,000 for an addition 700-864 games. Anticipated attendance is 300-400 additional spectators, equivalent of \$3,000-\$4,000. To send additional teams, sections/schools will incur additional travel and lodging costs for student-athletes competing. NYSPHSAA must also book additional rooms to cover the second division lodging needs.

The NYSPHSAA Boys and Girls Bowling State Committee is seeking approval to modify the bowling format of the Division 1 and Division 2 school team events during the State Tournament to utilize a 6-man format.

Effective Start Date:

Winter (March) 2025

Rationale:

The existing format uses a 5-man format on a single pair of lanes (10 bowlers across 2 lanes). All five (5) scores currently count towards the team game total. While the 6-man format increases bowler participation with the additional competing player, the lowest individual score is dropped from the team total. The 6-man format also utilizes an additional pair of lanes (12 bowlers across 4 lanes) resulting in a more efficient tournament and better experience for student-athletes and fans instead of long days.

Budgetary Impact:

- d. State Meet – is there a specific time that a coach must declare a false start by? – The referee will notify the coordinators at the meeting when a DFS needs to be declared by. This notification will be given directly to the meet referee.
- e. NISCA (National Interscholastic Swim Coaches Association) has so much to offer from their AA programs for Swimmers, Divers, Academics, Team Awards to Coaching insurance; Encourage participation within your sections as participants from New York State is a very LOW percentage from across the United States.

- g. If official or coach is a member of NFHS, you may download rule book free.
- h. **Swim Cloud** - Scott Kitzman was on the call and explained that last year was the first season of them supporting New York State. Swim Cloud had offered this service for free and in turn they noted that there was at least 12 K spent alone to New York State with support and staffing which is no real way to run a business and cover costs. This year Swim Cloud will offer discounted membership to all teams, all sections and prices will be dependent upon if a team is joining as an individual member or if the entire section is being picked up by the section office. It was noted that Swim Cloud needs to get the form completed in order to be Ed Law compliant.
- i. **Officials Association** – Jay Tucker reported that there are very little changes to the NFHS rule book for the 2024 – 2025 season

Welcoming Remarks - Introduction of Committee Members

1. NYSPSAA Office: The NYSPHSAA staff deferred their reports until the joint meeting so that it only needs to be reviewed once.
2. Bid - Thank you to Joe Altieri for getting the bids out to the Girl's Coordinators in advance of the meeting to review and provide feedback. Voting was held as follows

11. NYSSO Swimmer/Scholar Award – The officials association will be meeting to select the award.

Discussion topics include raising the required application GPA 95. Request that each section receives all applications from their scholar athletes and narrows the field down to the most qualified 1 candidate for submission at the state level. This would require applications to be put in early. Candidates who then do not make the NYS meet can then be removed from the Sectional Selection Committee reviewing the applications. Final candidates would need to be sent with entire packets to the reviewing Officials Chairperson – Tom Nangle. Uniform Diving for dual meets for state: From NFHS rule book

ART. 6 In other meets, the competition shall consist of one voluntary dive which shall be done first – Week 1= forward group, Week 2 = back group, Week 3+ inward group, Week 4 = twisting group, Week 5 = reverse group. Etc., and five optional dives, coming from at least four of five groups and which may include any of the dives other than the voluntary dive. Any dive from a group may be designated as a voluntary dive. It will receive its assigned dd through 1.8. Any designated voluntary dive with a dd greater than 1.8 will be assigned a dd of 1.8.

NOTE: For interstate competition, the voluntary dive group of the week shall follow the schedule of the host school's state unless state association policy determines otherwise.

16. Sectional Concerns:

Discussion:

Letter from Section 5 Coaches– Joe indicated he had planned to address the letter at the end of this meeting but had spoken to Diane about bringing up the concerns during the meeting. The concerns were addressed. The committee noted that it should also have come through the coordinator of the section. Joe will provide a written response to Section 5 coaches following the meeting.

17. Old Business

1 – Alternates at state meet: too much leeway with alternates we need to establish guidelines. A school may bring one alternate only for a relay; only if the relay has no other individual member in meet that may be used in case of illness/ or injury.

1 – JV – within the states prevue to regulate like modified. Do we have any sections following different protocols from modified or varsity? No

2 – NY specified for females two-piece suits and tie backs are not acceptable at any time even warm-up for swimmers or divers

3 – The referee needs to check with the computer people and advise them that they have the authority to overrule – both computer person and referee should make sure no athlete exceeds NFHS rule on entries.

4 - NFHS rule 5-1-2a

In non- championship events, diving may be the first event. Diving may be conducted either first, last or simultaneously with swimming events.

"In addition, it is now permissible to conduct 11-dive competitions during any non-championship meet with **PRIOR mutual consent** of competing teams. Do we know how many 11 dive opportunities we conducted during the 2021 season in each section?

NFHS rule 4-2-1d – **A MANDATORY pre-meet conference with the referee, starter and the captain and coach of each team must be held to review meet procedures, special instructions and unusual pool conditions.**

Equipment requirements were addressed in Rule 2-4-5 which now mandates a 15-meter mark on both side of the pool deck.

18. New Business:

2024 NFHS Swimming and Diving Rule Changes – Peter Hugo sent out an online link to the rule book. There were very little changes this year.

Athletes may not wear smart watches during competition!

Outstanding Competitor Award - Upon completion of the Breaststroke, not before. NYSPHSAA will not allow this award during the meet and it will be presented LAST after the 400 Freestyle Relay Awards.

4. 2024-2025 State Meet: Ithaca College – March 6,7,8 2025

A. Entries for 2024 Meet: We will again use SwimCloud. Instructions to be sent in February. Status Updates/ Items Discussion/ Action Taken:

1. Regional Rotations – All teams will play a subregional in 2025.
 2. Number of Teams – Maintain “NYSPHSAA Emerging Sport Status”
 - a. Section I – Anticipate having 3 teams. Having trouble getting a host school for 3rd team. Section IX may be starting a team.
 - b. Section 2 – Only one team at the moment. Albany Academy looking to come on last year. That may not be out of the realm of possibility. Shenendehowa is working on getting another team. Younger participants are increasing at lower level. Hoping to have 2-3 teams in the next five years.
 - c. Section III – Same number of teams had in the past. Ithaca plays with Section III. Alexandria Bay plays in Section X. There are 4 teams.
 - d. IV – 1 team – Ithaca plays in Section III currently may have a couple of new teams potentially starting up in 2025-26 season TBA.
 - e. V – 1 team TBA on new teams.

Report on changes in policy or practice: This was the last year for Glens Falls to hold the State Championships. They will be moved to Binghamton for the next 3 seasons.

Problems encountered/concerns:

Health Sciences played in the Buffalo Public Schools league, while Global Concepts and Tapestry Charter schools played in the ECIC league. Buffalo Academy of Science and Maritime Charter remain independent. Of the 5 Charters, we believe Health Sciences is the only school that needs to be re-classified for the 24-25 season.

Post Covid, a growing problem has been the use of social media at the high school level. It has become an issue for us as the Boys Basketball Committee because of the amount of photographers and videographers who feel it is their "right" to be on the floor at Buffalo State during Sectional games. Schools themselves are sending kids down from their video yearbook staff, while "professional" videographers that are hired by individual players are showing up and expect court access. And this is

all while WNY Athletic, who is streaming our playoff games for the NFHS network, has their own workers on the floor filming the game. It is becoming not just a safety hazard, but we need to find a better way to control who it is that we are allowing on the court. This may be an issue for the Athletic Council to look into and provide some guidelines for ALL to follow. We would like some feedback that we can implement as early as next season. I would like to see a “badge” of some sort that only myself or an assistant could hand out that would allow ANYONE on the floor. That way, no one can show up “unannounced” and expect to be on the floor. All this info could be sent to media/schools well ahead of time so we could process all those desiring access.

Other pertinent data:

Class AAA was new this season. Jamestown will join Lancaster and Niagara Falls next season. We are discussing/investigating if moving Health Sciences up to the AAA Class would be a good idea. More to come on that front soon. This will also make scheduling at Buffalo State a real challenge, trying to fit everyone in within our time constraints.

Next year's Class Breakdowns looks like this - Class AAA - 3 schools Class AA - 17 schools Class A - 25 schools (A1 & A2) Class B 23 schools (B1 & B2) Class C - 16 schools Class D 6 schools - so 8 Classes for seeding purposes, and 2 crossover games in Classes A and B,

I am also anticipating a change in the Regional schedule based on information I have received. More to come as I am told more at the State level, but I am aware of changes for the Fall Sports Regional rotation are currently in the works.

The assigning of officials during the regular season is an issue. Some leagues use a full time paid assigner, others designate an Administrator to watch over specific sports, while some leagues use secretaries. Having said all this, we have an issue that specific officials are being “pre-assigned” to certain schools that are deemed to be “difficult to get officials to go to”, such as Pioneer, Lake Shore, Springville, etc. (mostly schools that are further away from the Buffalo metro area). To that end, some of these schools are ending up with the SAME OFFICIALS on their games for 5 or 6 home games. That's not a good scenario for ANY school. We would like to see this practice “tweaked” in some way to prevent that from happening.

The new policies in relation to seeding/point system/tie-breakers worked very well. However, we still believe strongly that the **# of league WINS AND LOSSES IS ABSOLUTELY USELESS !!!!** Between Buffalo, ECIC, Niagara-Orleans, NFL, and CCAA, **WE ALL PLAY DIFFERING AMOUNTS OF LEAGUE GAMES!!!!!!** We are trying to avoid ANY coin flips if possible. So here is a “NEW” proposal concerning seeding points tiebreakers. Four steps as follows:

1. League winning percentage (already in place)
2. Head to head in league (already in place)
3. Overall winning % **WITHIN YOUR CLASS** (new) - so if team A played 11 games in Class A, and team B played 14, the team with the higher winning % would be the higher seeds. This would allow teams to play difficult schedules against larger schools without being “punished”
4. Overall winning % of **ALL 20 GAMES** (new)

***The above proposal is tabled and excluded from the action item to approve this report at the June 12, 2024 athletic council meeting (per the May 30, 2024 Sectional Intersectional Committee meeting). The S/I Committee is in ongoing discussions to establish a tiebreaker framework for all sports.**

In an unusual calendar year, February break, will fall **DURING THE REGULAR SEASON**. The postseason/seeding meeting is scheduled for the following **Saturday, 2/22/25**.

CURRENT PILOT PROGRAMS:

1. Split classifications after opt-out Pilot Program (in the sports of Boys Basketball, Girls Basketball, Baseball and Softball (approved Nov 2023 AC))

Last season, we agreed to be a part of the pilot program that allowed the Chairman to decide on Classifications within a Class later in the season after teams exercised their decision to opt out of the playoffs, supporting the girls basketball committee. They generally have quite a few teams opting out, and waiting until late in the season to divide their Class AA, A, B divisions into equitable brackets with similar amounts of teams is a good idea for them, as well as some other sports. Boys basketball generally have VERY FEW boys teams opt out. This past season, we had 2. However, with ties in the BEDS #'s, and

While we understand this is a 2 year pilot program, we are asking to be taken OUT of the pilot program if possible and continue how we have in the past. The anticipated positive that this gives girls basketball DID NOT have the same positive outcome on the boys side. Please keep up posted on your decision.

2. 4,5,6 Point System Pilot Program (Boys Soccer, Girls Soccer, Girls Basketball, Boys Basketball, Softball, and Baseball) for the 23-24 and 24-25 school years.

*Note Boys and Girls Basketball began this pilot with the 22-23 school year, and was extended a year through 24-25 (approved AC May 2023).

Recommendations for next season (including dates/sites): Buffalo State and Jamestown CC remain outstanding venues for our semi-final and Finals. All sites and dates will be determined in the next few weeks. Our concern at this time is the fallout from the end of last season with some girls teams concerned about not playing their semi-finals at a venue such as Buff State. I've has many discussions with girls Basketball Chairman Chris Durr and we will continue to communicate and do what is best for both the boys and girls. Let me remind you that Class C & D girls have been playing at JCC for many years now, we have shared the venue with no issues. AND, Mr. Durr has used other college venues for semi-finals in the past, only to receive numerous complaints from the girls teams/schools/coaches about extra travel, parking issues, venues being too big, etc. I don't envy the position he is being put in.

MORE RECOMMENDATIONS -

Lastly, the schedule below will need to be revamped for next season. That is currently being worked on and will be finalized in the near future. Section V will be hosting Regionals, but, as stated earlier, I

believe there will be changes made statewide in the Regionals rotations, so we will wait and see what that looks like, as well as what dates will be.

Report on changes in Policy or Practice that were implemented:

- All games were scored live using electronic scoring. No scoresheets were used for the 15 league games. Using iPads, the off-ice officials scored the game, on-ice officials verified the game end results, and the data was immediately reflected on the website.
- This was the third year for our divisional alignment. Four divisions were established that followed the pattern of the existing leagues schools presently complete in. The ECIC group was 14 schools and therefore it was broken into two divisions based on the BEDS numbers.
- The stats adjustment form was used for the second year for coaches to request that the league approve and correct any stats for players that were reported incorrectly. In total 21 requests were made from 7 different schools out of 230 league and non-league games.
- The running clock rule in the 3rd period when the score reached an 8 goal differential was reinstituted.
- The league hosted a senior all-star game for the second time. 52 senior athletes participated. It was very successful.
- Sweet Home/Depew merged with North Tonawanda for the first time. The team completed in the ECIC I division and the DI sectionals.
- NYSPHSAA allows the OT in a regular season game to be 4 on 4 or 3 on 3. The membership rejected this proposal for our section, we continue to run a 5 on 5 OT.

Problems encountered/concerns:

- There were some live scoring problems due to a programming bug early in the season. This required rewriting the software and launching it during the regular season. While difficult it was successfully managed. Most other issues were human error. Therefore, there will be a mandatory training session for scorekeepers and coaches conducted in November of 2024 before the league games begin.
- There are also some software edits to the system that need to be made for next year so that certain specific data can be recorded accurately. The website is also being updated for next season. This will include a secure area for coaches and ADs to access documents and forms.

Recommendations for next season including proposed calendar:

- We will continue to fine tune the electronic scoring procedure games. The distribution, maintenance and collection of equipment also needs to be addressed. A better system must be implemented to make this process more manageable.
- The start date for the season is November 13, 2023. Section VI will host the regional games on Saturday March 8th and the NYS Championships on March 15 & 16, 2025.
- We will reduce the league schedule so that all teams receive 14 games. This allows each division to play a balanced schedule within their division and reduce the number of cross-over games. It also allows teams to book weekend tournament more easily.
- The three official system will again be used for the sectionals and finals. This is in line with the NYSPHAA decision to use three officials for regionals and the state tournament.

The WNYGVIHF, in it's 14th season, for the first time used the same venue for all playoff rounds. Buffalo State Arena staff did a great job hosting the Section VI Playoffs and a NYSPHSAA Quarterfinal. Webster became the 1st Section V district to sponsor girls varsity ice hockey. They played 7 of the 9 Section VI teams in non league games and lost to KenGiPort in the NYSPHSAA Quarterfinals. There was no Player of the Year this season.

Problems encountered/ concerns

Some teams were only able to secure game ice that started at 4pm. This makes it a challenge for some visiting teams to make. The league managed and there were no games curfewed. Snow postponements were quickly rescheduled. A bus driver shortage in most districts caused some games to start late.

Recommendations for next season including proposed calendar

The girl's league has continued to thrive due to the high level of interest and exposure. The cooperation between high school coaches and travel coaches has again helped with development of the student-athletes and the league. The Section VI playoffs will return to Buffalo St. The champion will travel to Section V for NYS Quarterfinal

Recommendations for next season, including the proposed calendar:

- Continue awarding patches by class (A, B, C) for Championships Meets
- Continue to support funding meets at ECC & UB.
- The tentative calendar below reflects the 2024-2025 championship format which may change as a result of the May 2024 State Section Coordinator's meeting.
- Qualifying times will be studied and adjusted as appropriate to better meet the needs and talents of our Section VI athletes
- **Classification Breakdown** The Committee recommends that schools are assigned to three divisions based on BEDS. 100% of the BEDS numbers would be used for the 24.25 school year for combined teams since swimming is technically a one-classification sport. This will have very minimal impact on classification organization.
- **Sectional 6 Class Championship Meets and Sectional/State Qualifier Meet/s:** The format used for Class championships hosted by member schools as a three-day format (swim prelims, diving, swim finals) worked well in the 2022 and 2023 seasons. A timed final state qualifier meet held at a college facility, recognizing the fastest swimmer/top diver within the section.

After researching the other 10 sections across the state's postseason format, both the boys and girls committees continue to evaluate this format, based on data reports available through swimcloud to determine if this format continues to give our athletes the best opportunity to represent the section at the State Championship.

Post Season Report 2023-24

All WNY Sportsmanship Winners: NA (They only recognize sportsmanship winners at “Official” state championships)

First Practice – Nov. 13 th

Initial Weight Certifications: Nov. 17 th -21 st

Report on changes in policy or practice that were implemented:

This year we had 1,343 NYSPHSAA female wrestlers that were weight certified for the 2023-24 season. There were well over 1,600 if you count the PSAL, CHSAA, and the AIS. Because of the number of athletes AND the amount of teams that signed on as “All Women” wrestling teams, we WILL be having a fully sanctioned NYSPHSAA State Championship on the 34th week of the 24-25 season. It will be held at the same venue as the Boys State Competition and will be conducted on the Thursday prior to the boys championship. We had 207 young ladies certify in Section 6 which was an increase of 72.

Qualifying will take place at the Sectional level but there was much discussion on a regional format, stating that Sections would still have representation, because the regional concept would be the first leg of the process. Since we will be qualifying out of each section and allocations will be based on an equation to include Certified participants and strength of prior state placing, it will be necessary to have a Section 6 Championship to come up with our State representatives.

I would recommend that the Sectional tournament be run during the 30th week in place of the past class tournaments or the 33rd week, so teams who have 1 coach for both boys and girls teams, do NOT run into a conflict. In the future, our hope will be that school districts see the growth potential and value, and hire a women’s coach or assign a boys assistant to be in charge of the women’s program.

Again, this season, the NYSPHSAA office ran an “Invitational State Championship” held at Onondaga Community College in Syracuse. It was a fantastic event and all who attended saw a tremendous jump in talent across the state.

Wrestling coaches will still be required to enter all weigh-ins on TrackWrestling. **We will NOT be implementing the 1.5% weight descent rule for the 2024-25 season. Discussion is ongoing as to what measures we will take to ensure a healthy weight plan for our women’s teams.**

Problems encountered/concerns:

Our season ran very smoothly. We had very few issues this season. The only real problem took place when schools closed and we were unable to run our ladder tournament. This issue made it much more difficult to decide an order for entrance into the State Invitational. However, when all was said and done, the coaches were extremely understanding with the process and appreciative of the number of individual athletes we were able to enter into the tournament.

Since we will be having a Section 6 Championship, we will need to consider a single site with approximately 4 mats and 5 officials. Awards should be in line with the Boys tournament with patches being given.

New policies for 2024-25

The State Championship will be run as a “Freestyle” event. The NYSPHSAA offices are currently partnered with the NYSOA and are working to get a sufficient number of officials on board. There are freestyle “Officials Clinics” being held throughout the state.

As far as our Championship series (2024-25):

NYSPHSAA Invitational: NYSPHSAA will be hosting the 1st ever Female Wrestling State Tournament and if things go as planned, it will be the first ever State HS sanctioned Freestyle event. It will be held on Thursday February 20th at the AlbanyMVP Arena. (Or whatever they are calling it now) The Championship will be something that is bid on and rotated throughout the state.

I have been made aware that BuffState is very interested in hosting this event and as the ONLY section in NY State with 2 different colleges who have added Women’s Wrestling, I would hope that is taken into consideration. Much like changing the state meet that was held in Syracuse for YEARS, to an area that supported College wrestling.

I would highly recommend that a Section 6 Dual meet championship be budgeted for and put in place. Last year this tournament was run as an invitational at Dunkirk and had a two contact point requirement. It was an extremely successful and well run tournament. *This item is excluded from the action item to approve this report at the June 12, athletic council meeting (per the 5/30/24 Sectional Intersectional Committee meeting).

Since the boys have a dual meet championship in place, the girls should have the same. With Section 6 leading the way, we will set the standard for the state to hold the women’s Dual meet State Championship in the near future. This event should be held in conjunction with the Boys Dual Meet Championship.

To include the entire State:

NYS Federation Invitational: As you are aware, NYS has 4 HS Athletic Associations. NYSPHSAA is the largest. PSAL are the public schools in NYC. The CHSAA are the catholic schools in NYC and Buffalo. The AIS are the independent schools in NYC. The PSAL is still unhappy with our move towards Freestyle as our wrestling style, even though they run the same style during the spring season. The NYSPHSAA would still like to host a NYS Federation Invitational to accommodate all 4 athletic associations but must get buy-in from the other associations prior to moving forward with this. Currently we do NOT have that.

Not only did it give these young ladies some extra combative mat time, but it also gave purpose to the teams and their athletes to continue to show up to practice and stay involved with the sport. Otherwise there is very little reason for any athletes to continue to come to daily practices past the 42 that were selected to participate at the State Invitational as participants or alternates.

Section 6 State Championship Results (1/27/23 SRC Arena):

In total, We ended up with 31 Section 6 wrestlers entered into the NYSPHSAA Invitational tournament and 9 place-finishers. As stated in an email, our section (with 207) had the 2nd most certified girls in New York State. Our State total grew to 1,343 overall. Our section should be very proud of being part of that success.

Post Season Report 2023-24**

First Practice – Nov. 18th

Centralized weight certification: 11/21 – 11/25.

Report on changes in policy or practice that were implemented:

1. The first season of using the 1.5% descent plan for weight loss seemed to be a general success. Other than a few data entry errors on the coaches' part; with the help of the admins from TrackWrestling, we were able to rectify those situations that arose. Coaches and wrestlers seemed to learn quickly how to manage the descent plans as they pertained to lineups for their contests.

Problems encountered/concerns:

1. Coaches were not happy with the Ad-hoc committee decision to give out Section patches at only one postseason event for individual sports. I reiterated to them that the decision was made for all individual sports and not just for wrestling. Coaches were informed at the beginning of the season about the new policy at our preseason meeting. Nevertheless, several still voiced their displeasure. From the feedback that I received from wrestlers and parents; it seemed apparent that some coaches did not inform their teams/parents that patches would not be given at the Class Tournaments until the weekend of the tournament.

New policies for 2024-25

1. Pausing the Class tournaments: Coaches were all informed that Section 6 would be pausing the Class tournament for the next 2 seasons to evaluate our current state qualifying system. As the Class tournaments currently exist, the quality of the Class Tournaments has been degrading the past several years. Smaller programs, multiple mergers etc. have resulted in Class tournaments that are not necessarily required. Coaches were generally not pleased with the decision. Coaches asked if the decision could be overturned. I expressed doubt about that to them at our Sectional meeting.
2. NYSPHSAA Wrestling Committee is seeking approval to have an initial weight certification as early as 6 weeks prior to first competition for those individuals who would like to get a jump on the 1.5% descent plan for weight loss (This would allow them to compete at a lower weight earlier in the season). Especially those athletes who play football. Responsibility for payment will most likely be up to those individuals who elect an earlier certification than our centralized sites.

Concerns heading into 2024-25

1. Prior to this season's sectional tournament, I pointed out the fact that within the 4 Class tournaments, several teams submitted a second entry into a weight class on their postseason lineup with a losing/non-existent varsity record. Class AA – had 14 second entries with losing records; Class A – 14; Class B – 22; Class C/D – 17. The second entry into a weight class (original spirit of the rule) was instituted for those teams who had 2 varsity caliber wrestlers in the same weight class. Our rules dictate that within the 13 weight classes, a team may enter up to 15 wrestlers (doubling up as needed). The original intent of the rule has been diluted as teams are now entering JV level wrestlers as a second entry to gain "experience". It may be prudent to put restrictions that define what a second entry into a weight class should be as the Sectional tournament is our premier event of the season. This would improve the quality of competition at our Sectional events. For example, if two wrestlers are entered into the same weight class in the postseason, they must both have at least 6 contests with a .500 winning percentage at the varsity level. This is a subject that will be discussed among the leagues in the offseason / preseason prior to the beginning of the 24-25 season.

2024-25 Post Season Calendar - Buffalo State University would be an option for an Open Sectional. We will meet with Brent Ford (Facilities Manager) to discuss the potential of hosting our event.

Proposed new individual qualifying procedures for Section 6 Wrestling:

2 weeks prior to the NYSPHSAA Individual State Wrestling tournament, Section 6 will hold its Individual Wrestling Championships (2 tournaments – D1 and D2). Schools may enter up to 15 wrestlers total with a maximum of 2 per weight class. If there are 2 entries in any weight class, **both** entries must have a minimum of 6 varsity contests (on 6 separate dates) with at least a .500 win-loss record. All matches (Public, Private, Catholic, Federation) will count towards a wrestler's record. The tournament will be standard double elimination. If there are more than 32 wrestlers entered in a weight class, the school whose "second entry" has the worst win-loss percentage" will be forced to move to another weight class or withdraw from the tournament. Additional tiebreaking criteria will be established in the event that there is more than one second entry with identical records (to resolve which wrestler has to leave the weight class with more than 32 entries).

The tournaments will be held over 2 days. In most cases, they will be Friday-Saturday events. Saturday-Sunday will also be considered based on the availability of the host sites. An ideal site would have the space for putting down 5 mats (8-9 mats if we hold D1 and D2 at the same site. A typical schedule will resemble the following:

Friday

10:00 am – 11:00 am Weigh-ins

12:00 noon Wrestling begins (32-man bracket)

A tentative schedule would be to wrestle **2 rounds forward** in the championship bracket and **3 rounds back** in the consolation bracket. This will allow for an early Friday departure. Wrestlers should not be competing in the later hours of the evening.

Saturday

7:30 – 8:30 am Weigh ins

9:30 Wrestling starts with the Quarterfinal round of 8

11:00 - Semi finals

2:00 – Consolation Finals (5th – 6th place matches)

3:00 p.m. Finals (1st/2nd; 3rd/4th bouts run at the same time)

Followed by any "true second" bouts as needed to determine our state qualifiers.

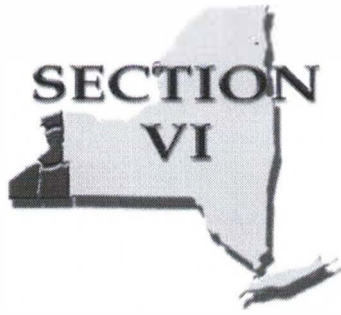

BY LAWS

Article 1 - Title IX

- 1.1 Title IX is the portion of the Educational Amendments of 1972 which prohibits sex discrimination in Federal Assist Programs. Specifically, Title IX states, "no person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal Financial Assistance."

Article 2 – Advisory Membership of the Athletic Council

- 2.1 Advisory Council –Superintendents, High School and Middle School Principals, Athletic Directors and Coaches of member schools are members of the Advisory Council of this Association and may be convened at the pleasure of the President. They are eligible to serve on committees and entitled to make recommendations to the Executive Committee on all matters pertaining to the conduct of interscholastic athletics.

Article 3 - Executive Director

- 3.1 Title: Executive Director - Section VI New York State Public High School Athletic Association, Inc.
- 3.2 Qualifications
 - 3.2.1 Possesses a valid New York State teaching or administrator certificate.
 - 3.2.2 Current or former employee of a New York State public school system or BOCES.
 - 3.2.3 Experience as **an athletic administrator**, League officer, Section officer or Section sport chairperson preferred.
 - 3.2.4 Possesses other qualifications as the Section VI Athletic Council may find appropriate and acceptable.
- 3.3 Reports to
 - 3.3.1 Section VI President, **all Executive Committee members, and**~~the~~ Athletic Council **and appropriate Erie 1 BOCES administration.**
- 3.4 Supervises
 - 3.4.1 Any staff designated in the Constitution, Bylaws or as assigned by the President or Athletic Council, **including office staff.**
- 3.5 Purpose
 - 3.5.1 To assist the Section VI Executive Committee and Athletic Council in the development, implementation and coordination of the Section VI interscholastic program. ~~for boys and girls.~~
- 3.6 Performance Responsibilities – To **complete, assign and** ensure but not limited to, the following:
 - 3.6.1 July - August
 - 3.6.1.1 Prepare and mail annual dues notices.
 - 3.6.1.2 Collect information on awards needed each year, order and distribute to sport chairpersons.
 - 3.6.1.3 Complete payment of spring activities.
 - 3.6.1.4 Distribute Section VI passes and Lifetime passes as per Section VI Pass Policy.
 - 3.6.1.5 Complete annual financial report.
 - 3.6.1.6 Order necessary supplies such as pins, contestant numbers, etc.

- 3.6.2 September - June
- 3.6.2.1 Record and pay all bills.
 - 3.6.2.2 Send out bills to member schools, extra awards, etc.
 - 3.6.2.3 Send out annual budget forms to all sport chairpersons.
 - 3.6.2.4 Prepare and mail minutes of all meetings.
 - 3.6.2.5 Assist President in daily conduct of Section affairs.
 - 3.6.2.6 Assist sport chairpersons in conduct of their sport. **Provide training, direction and vision for each chair.**
 - 3.6.2.7 Assist in the preparation of the annual Section VI Directory for upcoming year (should be done in May and June).
 - 3.6.2.8 Assist in keeping the Constitution updated.
 - 3.6.2.9 Assist in keeping rules and regulations updated.
 - 3.6.2.10 Assist member schools with interpretation of rules/ regulations.
 - 3.6.2.11 Prepare necessary news releases with approval of President.
 - 3.6.2.12 Assist Finance Committee in preparation of annual Section budget.
 - 3.6.2.13 ~~Carry out such other responsibilities as requested by Section VI President, Executive Committee or Athletic Council.~~
Ensure that all Section committees meet regularly and provide minutes of said meetings.
 - 3.6.2.14 Carry out appropriate activity through the media to promote interest in and understanding of interscholastic athletics in Section VI.
 - 3.6.2.15 Transportation: Act as liaison between the Executive Committee, Athletic Council, Sport chairpersons and designated Travel Agency.
 - 3.6.2.16 Approve waivers for the minimum number of contests needed to compete in Sectionals with retroactive approval by the Athletic Council.
 - 3.6.2.17 Approve applications for Senior All-Star and Outside Agency contests, Friends and Neighbor Status and Combining Schools with retroactive approval by the Athletic Council.
 - 3.6.2.18 Notify **and work with member** schools of **if it is determined that the** disciplinary actions the schools have determined **regarding** ~~violations of eligibility rules if school's response is not sufficient.~~
 - 3.6.2.19 Approve all venue contracts.
 - 3.6.2.20 Determine in accordance with the Subsequent Arrest Policy, if the charge regarding the arrest of a sports official affects the official's duties or forward to the Section attorney to make that determination.
 - 3.6.2.21 **With approval, serve as** spokesperson for the Section when the President is not available.

3.6.2.22 All other duties and responsibilities as assigned by the President and Executive Committee

3.7 Terms of Employment

3.7.1 Work hours – as specified in the contract.

4.1.1 Definition and Makeup - The Finance Committee of Section VI shall consist of an appointed chairperson, preferably a standing School Business Official, the Executive Director, and one representative from each of the leagues. Additional members may be named by the chairperson.

4.1.2 Purpose

- 4.1.2.1 Develop a proposed budget or financial plan in cooperation with sport and committee chairpersons.
- 4.1.2.2 Present a budget recommendation to the Athletic Council at its November meeting with a corresponding vote held at the January meeting.
- 4.1.2.3 Update the Athletic Council on the financial status of the Section at each regular meeting and present recommendations when needed.
- 4.1.2.4 Provide recommendations on expenditures.
- 4.1.2.5 Review and set sectional admission prices annually. Prices will be based on venue and past attendance and standardized across sports to achieve consistency within the section. Sportchairs will be notified by the Section office of the prices established for the upcoming year.
- 4.1.2.6 ~~Participate in Conduct~~ contract negotiations with the official's chapter(s) on behalf of the Section
- 4.1.2.7 Responsible for contract interpretation, administration and implementation.

4.2 Sectional/ Intersectional Activities Committee

4.2.1 Membership

Shall consist of the Executive Director as chairperson, one representative from each league and the Boys and Girls Representative from the Central Committee.

4.2.2 Duties

- 4.2.2.1 Responsible for development of the boys and girls sectional and intersectional activities calendar, one calendar year in advance if feasible. The calendar for Section VI should indicate the following:
 - Section starting dates for practices.
 - Sectional dates and sites.
 - Intersectional dates and sites.
 - Athletic Council Meeting dates, times and sites.
 - Timeline for Finance Committee budget.
 - National and State Testing Dates.

Copies of this calendar to be distributed to the following:

- Athletic Council and Executive Committee. It is the responsibility of the League/ BOCES representatives to distribute it to their constituents.
- Sport chairpersons.
- Committee Chairpersons.

4.2.2.2 Responsible for overseeing sport chairpersons and their activities:

- Handbooks
- Dates
- Sites

4.2.2.3 Responsible for developing a format for and review of sport handbooks.

4.2.2.4 Responsible for two reports annually or as directed by the President.

4.2.2.5 Review and approve all venues and contracts for sectional competition.

4.2.2.6 Oversee and coordinate corporate sponsorship for Section VI sports. Corporate sponsorships must have Athletic Council approval.

4.2.2.7 Responsible for the general conduct of sport activities including recommendations to the Athletic Council as needed.

4.3 Safety Committee

4.3.1 Membership

Shall consist of an appointed chairperson and the Executive Director. Additional members appointed from the Leagues/ BOCES as needed.

4.3.2 Duties

4.3.2.1 Responsible for representing Section VI at all NYSPHSAA Safety Committee meetings.

4.3.2.2 Responsible for reporting to Section VI on all aspects of Program Safety which affect the athletic programs of Section VI.

4.4 Modified Committee

4.4.1 Membership

Shall consist of appointed chairpersons (male and female) and additional appointed members as needed.

4.4.2.1 Represent Section VI at all NYSPHSAA Modified Sports Meetings.

4.4.2.2 Be responsible for the general conduct of modified sports, including recommendations to the Athletic Council as needed.

4.5 Policy Committee

4.5.1 Membership

Shall consist of an appointed chairperson, the Executive Director and one representative from each league. Additional members may be named by the chairperson.

4.5.2 Duties

Maintain and update the Constitution, Bylaws and sport policy handbooks.

4.5.3 Changes in the Constitution, Bylaws and sport policy handbooks will be reported in the Athletic Council minutes.

4.6 State Executive/Central Committee

4.6.1 Membership

Shall consist of four representatives: Superintendent, Secondary School Principal, Boys Rep of Athletics and Girls Rep of Athletics

4.6.2 Duties

4.6.2.1 Represent Section VI at NYSPHSAA Executive and Central Committee meetings.

4.6.2.2 Report to the Athletic Council regarding NYSPHSAA Executive and Central Committee meetings and provide recommendations for action at the NYSPHSAA meetings.

4.6.2.3 Represent their respective groups at NYSPHSAA Executive and Central Committee meetings and the Section VI Athletic Council.

4.6.2.4 Report to the Athletic Council and keep their respective groups informed about current issues.

~~4.7 Extended Eligibility Committee~~

4.10 Sportsmanship Committee

4.10.1 Membership

Chairperson is President-Elect of Section VI. Representatives from each league and any additional members as deemed necessary by Chairperson.

4.10.2 Duties

4.10.2.1 Rule on questions of sportsmanship.

4.10.2.2 Follow procedures of sportsmanship policy as listed in the Section VI Policy Manual posted on the Section VI website.

4.10.3 Activity Council – Pro-active

4.10.3.1 Duties:

Promote activities through the Section and within its Leagues that encourage and recognize exemplary sportsmanlike conduct.

4.10.3.2 Membership:

A maximum of 13 members as follows:

- Chairperson: The Section VI Sportsmanship Coordinator
- Members: One representative from each league and additional members as needed.

4.10.4 Review Council – Re-active

4.10.4.1 Duties:

Receive, review and rule upon reports of violations of standards of Sportsmanship. Their decision will be rendered only after providing all parties due process. Decisions of this council, or similar league committees will stand. Only appeals regarding process and procedure will be heard. Such appeals shall be directed to the appropriate Executive Committees; i.e., Section VI for sectional activities and League for league activities.

4.10.4.2 Membership:

- Chairperson: President-Elect of the Athletic Council
- Members: Two Central Committee Representatives, two retired Athletic Council members and two at-large members. The retired and at-large members shall be appointed annually by the President.

4.11 Veterans Committee

4.11.1 Chairperson

- a) Appointed by the Section VI President
- b) Duties
 - Approved/verified eligibility of new members
 - Organizes annual Veterans Dinner
 - Veterans representative for the Section VI Athletic Council

4.11.2 Membership

- a) Eligibility for Veteran status includes formal retirement from the prospective applicants Section VI member school and any of the following:
 - Held at least one term in office for Section VI
 - Former Section VI member school athletic director
 - Former Section VI committee member or Chairperson

~~4.12 Mixed Competition Committee~~

~~4.12.1 Membership: Chairperson appointed by the President of Section VI. Additional members as deemed necessary by the chairperson.~~

~~4.12.2 Duties: to address issues of mixed competition that are formally brought to the attention of the Section.~~

4.13 Nominating Committee

4.13.1 Membership:

Shall consist of five (5) members, one (1) member from each league. The President-Elect will serve as the chairperson.

4.13.2 Duties:

Shall convene when needed to solicit, interview and recommend candidates for the following positions: Central Committee Representative, Athletic Council President, Athletic Council President-Elect and Sport Chairperson.

4.13.3. Nominations may also be made from the floor for any office in this Association.

4.14 Combining of Schools Committee

4.14.1 Chairperson

- a) Appointed by the Section VI President

Duties: The Committee will meet after each sports season to address issues of combining of schools that are formally brought to the attention of the Section via the combining of schools post season reports.

4.14.2 Membership

Shall consist of five (5) members, one (1) member from each league.



4.15 Appeals Committee

4.15.1 Membership:

Shall consist of 5 members. Retired Athletic Council and Executive Committee members that are no longer connected to a school district are preferred.

4.15.2 Duties:

Shall convene when needed to hear Stage 2 appeals from school districts.

4.15.3 Nominations to this committee will be recommended to the Nomination Chair and approved by the Athletic council in May for the following year.


5.1 General Duties



5.1.1 Appointed by Athletic Council

5.1.2 Establish pre-post dates for meeting of advisory committee.

5.1.3 Prepare yearly sport budget.

5.1.4 Submit  sport calendar to Sectional/ Intersectional Committee, including dates for:

5.1.4.1 State meet

5.1.4.2 Qualifiers

5.1.4.3 Sectionals

5.1.4.4 Completion of league competition

5.1.5 Attend State sport chairpersons meetings.

5.1.6 Locate sites for qualifiers and sectionals and arrange for proper supervision. Confirm in writing with school officials. All venues must be approved by the Sectional/ Intersectional Committee.

 5.1.7 Appoint the meet and site chairpersons

5.1.8 Organize, duplicate and inform the meet and site chairpersons of their specific duties, including arrangements for proper supervision.

5.1.9 Arrange for officials at all sectional contests


5.1.10 Develop a method of communicating with Advisor Committee members

5.1.11 Arrange for awards for sectionals, regionals and state competition through the Executive Director.

- 5.1.12 Make arrangements for athletes to compete in post-sectionals
 - 5.1.12.1 Housing
 - 5.1.12.2 Meals for individual sports only
 - 5.1.12.3 Transportation - coordinate with Executive Director
 - 5.1.12.4 ~~Complete state required Code of Conduct~~
 - 5.1.12.5 Medical forms
 - 5.1.12.6 Guidelines for trip
- 5.1.13 Prepare a sport specific handbook to be dispensed to all member schools and the Athletic Council via the Section VI website.
- 5.1.14 Divide schools by population for classification according to sport. This is to be done according to existing classification guidelines.
- 5.1.15 All schools who enter sectionals or qualifiers are responsible for attendance of their teams at these events.
- 5.1.16 The sport chairperson shall be responsible to notify all schools if a school's team does not fulfill its commitment to participate.
- 5.1.17 Attend Section VI Athletic Council and Sectional/ Intersectional meetings as scheduled.
- 5.1.18 Act as a resource person for problems of eligibility, participation, and sport rules that are listed in the NYSPHSAA Handbook and any other specific rulebook used in the sport.
- 5.1.19 A Games Committee shall be established for each sectional sport contest. This committee shall be appointed by the sport chairperson. They shall deal with any questions and/or protests concerning games/meet rules and conduct of the game or meet. These questions/ protest shall be heard and decided by this committee. The committee's decision shall be final and not subject to appeal.

5.2 Specific Duties

- 5.2.1 Select date, site and time of each contest. **Once approved in the sport handbook**, all schools are required to honor these dates except for **unforeseen** emergency situations.
- 5.2.2 Monitor all expenses incurred in the operation of each sectional contest as specified in the approved budget. Follow all financial procedures as set forth in the Financial Policies section of the Policy Manual.
- 5.2.3 Prepare a guide for all game and site chairpersons relative to their duties and responsibilities. The game site-chairperson is required to secure an AED for the certified trainers' use for all sectional, regional and state contests.
- 5.2.4 Establish the number of cheerleaders and players who will be admitted to each sectional contest.

- 5.2.5 Prepare official game procedures for all Section VI contests:
- 5.2.5.1 Identify pre-sale tickets at game
 - 5.2.5.2 Submit cash or check for pre-sale tickets sold
 - 5.2.5.3 Submit the Section VI admittance form
- 5.2.6 Develop and implement a process for the assignment of officials for all sectional contests. This process will be documented in the sport handbook. **Active coaches who serve as a sports chair will not be involved with discussing or assigning officials in their school's classification.**
- 5.2.7 Determine composition of protest committee.
- 5.2.8 Send out evaluation reports to game chairpersons, coaches, directors and officials.
- 5.2.9 Distribute specific sport information to all personnel involved:
- 5.2.9.1 Superintendent
 - 5.2.9.2 Principal
 - 5.2.9.3 Athletic Director
 - 5.2.9.4 Coaches
- 5.2.10 Determine entry procedure for sectionals. Obtain Athletic Council approval and notify schools.
- 5.2.11 Publish tie-breaking procedures for team or individual competition.
- 5.2.12 Set up classification determination when necessary.
- 5.2.13 Prepare information on post-sectionals for all persons who are involved.
- 5.2.14 Arrange for transportation to post-sectionals according to Section VI Policy.
- 5.2.15 Submit to the Executive Director, all necessary results for awards, certificates, plaques, ribbons, shields for the sectional event, plus materials specific to the Chairperson's activity such as: numbers, pins, score sheets and tags
- 5.2.16 Send out information specific to the activity e.g.:
- Cross-Country: Course information, maps, date rosters, site, scoring and starting time.
 - ~~Softball: no metal spikes used.~~
 - Track: starting heights of infield events.
- 5.2.17 Maintain all Section VI and post-sectional records.
- 5.2.18 Act as resource person for issues of eligibility or participation in the particular sport according to the current NYSPHSAA handbook and sport rulebook. 
- 5.2.19 Prepare a sectional handbook to cover pertinent materials relative to sectionals that are not included in the NYSPHSAA Handbook and Sport

rulebook.

- 5.2.20 Submit a sport budget to Section VI Finance committee by established dates.
- 5.2.21 Determine policy for scheduling of dual sports conflicts; e.g. some leagues allow a competitor to participate on track and baseball teams.
- 5.2.22 Federation sports shall prepare schedules with the Sectional/ Intersectional Committee for approval by the Athletic Council.
- 5.2.23 Section VI Federation Sports, Varsity and Junior Varsity Policies, Rules and Regulations shall be prepared and approved by the Federation and the Athletic Council.
- 5.2.24 If the sport prepares a program booklet for sectional competition, sportchairs are allowed to hire an individual to perform this task. The expense will be taken from the sport's budget.
- 5.2.25 **Commit to being proactive and aware of issues of equity and fairness for all participants.**

5.3 Sports Advisory Committee - (sub committee of Sports Chairperson)

5.3.1 Membership

5.3.1.1 The Sports Advisory Committee shall be made up of one member selected by each of the participating leagues.

5.3.1.2 The sport chairperson can select additional members to participate on the committee on a non-voting basis such as:

- Meet Chairpersons
- Site Chairpersons
- Authorities on that sport

5.3.2 Guidelines for **Mandatory** Advisory Committee meetings held by sport chairpersons

- Pre-Season Meeting
- Post-Season Meeting
- Discretionary meetings when necessary
- Sports chairpersons will provide the Sectional/Intersectional Committee with their committee meeting dates and agendas. After each meeting, they will provide minutes including action items as well as discussions and the attendance list.

~~5.4 Publicity~~

~~5.4.1 At the conclusion of each contest, the chairperson in charge will call in the results to radio, television and newspapers. For the most current listing, refer to Media Information in the Section VI Directory.~~

5.5 Reports

Chairpersons report to the Executive Director, Athletic Council and Sectional/Intersectional Committee.

5.5.1 Develop a common format for pre and post season reports

5.5.2 Pre Season Report:

- List ALL Committee Members. Indicate which members have voting privileges.
- Proposed budget
- Information on sectional, post-sectional competition (dates, sites, times, etc.)
- Number of schools participating
- Changes in policy and/or practice
- **Recommendations for merged team combinations**
- Other pertinent data



5.5.3 Post Season Report:

- Section and post-sectional results
- Financial information (budget, receipts, expenditures) reconciled with the Executive Director
- Changes in policy and/or practice (requested and mandated)
- **Recommendations for merged team combinations**
- Other pertinent information

5.5.4 The sport handbook will be posted on the Section VI website for access by Athletic Directors, coaches and the Athletic Council prior to the start of the sport season.

5.5.5 Pre & Post Season Reports will be submitted to the Executive Director by dates listed below.

Pre Season

Fall - March 1
Winter - July 1
Spring - November 1

Post Season

Fall - January 1
Winter - May 1
Spring - September 1

5.5.6 Sport chairpersons will meet with the Athletic Council and Sectional-Intersectional Committee as needed.

Recommendations coming to the Sectional/ Intersectional Committee must be the result of a majority vote of the sport chairpersons committee.


5.5.7 Executive Director will notify a sport chairperson if needed at next Athletic Council meeting - reason for attendance will be given.

5.5.8 Sport chairpersons can request to speak to Athletic Council by contacting the Executive Director for placement on the agenda.

5.5.9 All sport chairpersons will attend a pre-season meeting run by the Executive Director and staff. All policies, procedures and forms will be reviewed at this meeting.

Article 7 – Executive Committee

7.1 Executive Committee Alternates:

The four members of the Executive Committee who represent a specific constituency (i.e., superintendents' rep, principals' rep, girls' rep and boys' rep) are responsible for obtaining an alternate if they cannot attend a meeting of the Athletic Council or Executive Committee. The alternate should be a member of the group the member represents (e.g., another principal should be an alternate for the principals' rep). If an alternate is not available, the President may select a former member of the Executive Committee who currently chairs a Standing Committee of Section VI or is an officer of one of the leagues to take the place of the absent member. This alternate will have full voting rights during the meeting.

The current NYSPHSAA Foreign Exchange policy reads, “No member of the school's coaching staff or athletic director, paid or voluntary, shall serve as a host family. School districts may apply to the Section for a waiver if the student is living with a member of the school’s coaching staff or athletic director and if the student has not played the sport competitively.”

Addressing the Sectional Concern:

Add the language “This only applies to students participating at the Varsity Level. Those students that play at the sub-varsity level are not held to this regulation.

Rationale:

Section VI members feel that this should not and does not have to apply to those students playing at the JV level.
