- 4.8 Spalding Football and Volleyball Requirement Update (Appendix D)
Spalding is experiencing a product supply issue in the sports of football and volleyball. Therefore, member schools do not have to use Spalding footballs for any 2022 Sectional play. Member schools hosting volleyball sectionals do not have to use the Spalding Volleyball, but Section VI will provide Spalding volleyballs for the neutral site championships.
- 4.9 NYSPHSAA procedure for action items
Adding action items to the state agenda without providing opportunity to having discussions at the section level prior continues to be a concern.
- 4.10 Boys Volleyball – Spring
At last week’s state executive directors meeting, some sections shared interest in moving Boys Volleyball to the spring season. The Executive Committee agreed that data would have to be collected to determine if moving Boys Volleyball to the spring season would help with officials coverage and member school participation, as well as if there would be any negative effects.

APPENDIX A

Officials contract negotiations

Items agreed upon for the 2022-27 Contract

- Officials will receive an additional **\$20** for mileage if they travel 60 or more miles round trip.
- Sectional pay will be **\$10** additional of that year's base pay.
- Agreed to successor contract negotiation language.
- **5th** football official on all Varsity football games.
- A full JV wrestling fee will be paid for **7** or more exhibitions along with per bout fees.
- All groups will provide end of the season reports.
- Recruitment and retention Account each school will pay \$200 and officials' groups will pay \$100 to reimburse expenses of new officials.
- 16 officials on Track Class meets 12 for league meets.
- 3-man umpire baseball/softball crews for **Semis** and finals of sectionals.
- Cleaned up language to have a minimum of 8 officials for league/sectional meets.
- Got rid of 2/3rds clause so an official will get **full fee** if they work multiple games at one site.
- Split the JV/V volleyball rate to Varsity up/V down/JV – 3 individual fees now.
- Varsity Volleyball fees will freeze through duration of the contract.
- Sectional Volleyball lines judges will be paid \$50, \$50, \$55, \$55, \$60
- Increased scrimmage rate to \$60, \$60, \$65, \$65, \$70
- 3-man crews for Sectional boys and girls ice hockey.
- Increased chain gang for sectionals to \$50, \$50, \$55, \$55, \$60
- Add \$60 to fee for track officials who use their own shells.
- 8 Gymnastics officials for Sectionals.
- 6 officials for cheerleading sectionals.
- 3-man basketball crews for All boys and girls sectional games.
- Removed field hockey language so that 2 officials will be assigned at all levels.
- Compensation for working alone will be an additional %50 at all levels.
- **Pay will increase \$4, \$5, \$5, \$5, \$4 = Total \$23 over 5 years.**
- **In the final year of the contract, groups can increase pay by \$2 additional dollars by having 75% of their officials working "the minimum number of games."**

The Central Committee approved eliminating the NYSPHSAA Jewelry Rule. In essence what that means is that NYSPHSAA will now follow the sport governing body rules as it related to Jewelry. For most of our sports that means following the NFHS rules for that particular sport. For other sports we will follow the NCAA, USA Softball, USTA, etc for the rules on jewelry. Please note this change does not change that was made in May 2022 as it related to hair adornments.

APPENDIX C

Section Executive Directors,

It has come to our attention NCAA Volleyball Rules require students to have a special accommodation waiver for religious headwear.

To ensure students are provided the ability to wear religious headwear in all sports and to avoid issues, the NYSPHSAA Officers have approved the addition of the following language to the NYSPHSAA Jewelry Rule (*page 52 of the Handbook*):

“Head coverings worn for religious reasons are permitted and shall not be made of abrasive or hard material and must fit securely.”

The NYSPHSAA Handbook is being updated to reflect this change.

The NYSPHSAA Constitution states:

“A committee of officers in consultation with the staff shall have the authority to act on all matters not provided for in this constitution and bylaws, and on such emergency business as may arise between regular meetings of the Executive Committee.”

RE: Spalding Alpha Football & Spalding Volleyball

DATE: September 9, 2022

Due to several factors, including, but not limited to COVID-19 impacting production operations, limited supply of leather material, and the temporary closure of the Spalding production plant overseas, NYSPHSAA and Spalding have mutually agreed to immediately to:

- suspend the requirement for the use of the Spalding Alpha Football for the entire Fall 2022 post season.
- suspend the requirement for the use of the Spalding Volleyball for the opening rounds of the Fall 2022 Sectional tournament; Sections will provide Spalding Volleyballs for Sectional tournament play at neutral sites. It is recommended the host school provide the game balls when the Spalding ball is not provided by the Section.

We recommend schools work with their local vendors for updates on production and fulfillment of current orders.

The post season Spalding ball requirements remain intact for the other Spalding sports (i.e., soccer, basketball, baseball, and softball). NYSPHSAA and Spalding are closely monitoring production operations and will keep the NYSPHSAA membership informed as to any further updates and/or changes.

The post season requirement for football and volleyball will fully resume for the Fall 2023 seasons.

APPENDIX G

Boys Basketball Tiebreaker Proposal

The BBK committee unanimously to see the **tie-breaker format changed**. As it stands, if seeding points are tied, the #1 criteria to break a tie is “most league wins.” Criteria #2 are “fewest league loses.” With Charter schools having to count ALL their games as league games (like an independent school), and with some leagues playing 14 league games, some 12, and some as few as 10, this criteria is no longer valid. We would like to see the #1 criteria (after seeding points) be a winning percentage. For instance, this past season, Olean and Lackawanna tied for the second seed in Class B1. Olean went 12-0 in league play, while Lackawanna went 13-1. When dividing their power points by league wins, they tied at 4.5 points each. Under the old criteria, Medina won a coin flip to be the higher seed. Under the proposed criteria, Olean’s league winning percentage would be 100%, while Lackawanna’s would be 93%, thus giving Olean the higher seed. This seems to us to be the more equitable tie-breaker than using a coin flip. Olean could not have done more than they did, and had Lackawanna gone 14-0, they would have won the tie-breaker just because they play in a larger league that plays more games in league play

APPENDIX H

Boys Basketball Point System Proposal

5 points would still be awarded for a win vs an opponent the same Class size. For a win against a Class larger than you, 6 points would be the **MAXIMUM point total, and 4 points only if the larger Class school should win.** This would be helpful in leagues where the discrepancy in Class size is larger than one (Ex. - McKinley (Class A) losing to MEC (Class C)) MEC would only receive 6 points for winning, McKinley would receive 4 points if they won. In the past, this would have been either a 7 or 3 points for the winning school. The rationale is this would keep teams on a more level playing field within each Sectional Bracket.

III. Executive Committee

Judy Salerno: The new Girls Basketball coordinator is Kirk Ehrensbeck (Section IV).

Todd Nelson: Strategic planning committee has identified 4 areas to focus on for the next five years. Including: Diversity; Equity; Inclusion; Fiscal responsibility and stability.

Another important and current goal is to increase the number of participating officials who are qualified, confident and trained to officiate. The focus on recruitment and retention of officials is being examined.

In the past, the training of officials and retention was geared toward the high school level. The focus should shift to the modified level. (Further report below) The realization of this needed shift occurred during the pilot of the girl's flag football program.

The recommendation of starting the girl's flag football would be to start at the modified level. The program is impeding the other spring programs such as girl's lacrosse, softball and TF. This is creating enrollment issues for various sports (which has been an issue for many districts even without adding girl's flag football).

The state is discussing adding another level of teams. If JV has been eliminated, there is discussion to add 6th graders in the modified programs. This would restructure groupings to the following: 6/7, 8/9, 10-12 level program. "Infancy phases."

A lot of middle schools and middle level programs include 6th graders in the buildings. They participate with 7th graders in outside groups.

Judy: Is there a mod rep on the committee?

Todd: not at the moment. The current focus is setting goals and not action items. The strategic plan will set the goal and then work with the committees to work on the action items to reach those goals.

Kevin: Sections and schools can be more restrictive.

Judy: Flag Football Program – the NFL provided the uniforms for teams?

Todd: NFL worked with their reps and Nike to provide uniforms. 51 teams – working with 6 different section 8, 11, 1, 5, 4, 6.

Recruitment and retention of officials:

Todd: Sally is the rep for NYS volleyball officials. She has been very "OCF" involved with the officials group. We are working with Sally's group to streamline the process on how to become an official and in particular at the modified level. We feel that at the association, to get someone in the door and get them working, they could use some basic training.

What it means is learning the basic rules and regulations and the proper mechanics/basic mechanics to do the job. We want to streamline the training and get officials involved where we are critically lacking officials...we have one official when we should at least have two officials.

Piloting a program:

Sally: President at the state level for boys and girls volleyball. Part of an OCF initiative to train fundamentals for modified programs. The pilot included 6 participants who were set up with mentors. Approximately 10-15 officials (potentials) start a class and only 4-8 finish. Several barriers; not as easy as they thought and personal obligations.

Every official needs a core basic of mechanics, rules and interaction skills for coaches, parents, spectators and athletes. We found out our barriers and over the summer we will create a plan based on our findings. Coaches were more than accommodating when they had enough officials on their contests.

Goal of the plan is recruitment and a big part is retention. Retention is also the responsibility of schools as there have cases where inappropriate behavior impacts retention.

Studies show that the number one reason why they (officials) leave is due to the abuse in the profession and poor behavior.

Todd: Schools need to take the necessary actions and that is what will keep officials working for us. Sally took the normal officials training and cut in half to have them work at the modified level and they were able to develop. We cannot overlook the fundamentals. We need to get them working (games) and learn the skills, but perhaps more condensed to get them right into the modified level to officiate.

Q: Are other official's organizations working on this?

Todd: Hot topic at the OCF meeting. Officials are independent contractors – we do not have direct jurisdiction to tell them how to do the training. We hope they can see the benefits of getting them training in a short period of time and getting out there as a modified official.

James Rose: Large group of new reps attended the workshop conducted in January. Any feedback and was the meeting helpful? No feedback.

a. Track and Field:

“3” event rule questioned to change to 4 events.

Joe Alger: Brought up 3-4 rule for participation in track and field. Is there possibility to do 4 events instead of 3? With low numbers this may also help. This would prepare the athletes for high school.

b. Soccer:

10 minute overtime in soccer: Section X (Laurie Brewer) 4 and 4 on different sides so one side is not full of mud. The additional two minutes also impact the official's contracts.

Section 7 – do not act on the overtime until more discussion.

- c. **Mouth pieces in soccer:** Mouth Pieces has to go to safety before executive. Youth soccer does not require for the athletes to wear them. Safety committee to discuss at the next meeting to give feedback. Need to get the data to see if it plays an important safety role.
- d. **Promotion Rule:**
NYSPHSAA Promotion Rule “APP” and restriction on promotion timeline (50% of season limit)
 Todd: why we have this from my understanding is that any 7/8th grade student who is talented enough to participate at the HS level, they should probably be tested up before 50% of the season has been completed. (APP is) Not intended to reward or give experience or fill out rosters. Only for the exceptionally talented to participate at the appropriate level of competition.

Section 7: Why is it 50%? Would like to make it an action item to change.

Barb: I would like to bring back to our sections before making an action.

MOTION: First motion, Vickie McMillan and second, John Burdick – to bring back the discussion to the sections and consider as an action item. Voting on making it an action item for next meeting after discussing with sections.

Todd: Every section and committee has the right to make this a discussion – we are tabling it for next meeting so you can go back to your section committee to discuss. Silence is consent if all in favor. Anyone opposed can bring their opposition to the table.

The NYSPHSAA Sportsmanship Committee is recommending adding the following NYSPHSAA Sportsmanship Spectator Regulations to the Handbook.

“Any negative, inappropriate, derogatory comments or actions that brings direct attention to a supervisor or school administrator by a spectator or group of spectators are required to be addressed by the host school, Sectional or NYSPHSAA representative in the following non-sequential order depending on the comments or behavior:

- First warning – Directing the spectator or group of spectators to refrain from any negative comments or actions.
- Second warning – A personal discussion with the spectators or group of spectators on the above NYSPHSAA expectations and reminding the spectators or group of spectators of the next step, removal of the game or event, will be utilized if the behavior continues.
- Removal from the contest – The spectator or group of spectators will be directed to leave the facility for the remainder of the game or event. If spectators or group of spectators refuse to leave the game or event, play will be stopped until they vacate the premise.

Penalty for being removed from a game or event: Any spectator removed from a game or event will have a minimum penalty of completing the NFHS Parent Credential course or a one game suspension before they are allowed to attend any interscholastic event, home or away. Once the course is completed the spectator will provide a certificate of completion to the athletic department office. Schools are required to communicate with the offending spectator on the NYSPHSAA Sportsmanship Spectator Expectations.

- Depending on the severity of the behavior/comments or future disqualifications by the offending spectator NYSPHSAA and the Section may get directly involved in the situation.

Note: A school may take any or all these actions during or after an interscholastic contest.

Additionally, often times games go extra innings in the state tournament due to outstanding pitching, case in point in 2019 when a semifinal game went 19 innings. In 2022, a Class B semifinal went to extra innings and the winning team was scheduled to play immediately after. They were offered a 30-minute break but declined and subsequently were beaten 14-2 in the final.

Although pitch count is not a factor in softball, quality of play is important in the state championship which would be significantly better if teams played one game per day and also enjoyed the experience of a two-day state tournament much like baseball and nearly all other NYSPHSAA team championships.

Transitioning to a 6th classification also prompts softball to explore a two-day event to ease the state tournament schedule. Fields at the current hosting facility are available for more games but the number of games for six classes would go from 15 games to 18 games and its more manageable for a two-day event to play 12 semifinals on day one and 6 finals to be played on day two. Keep in mind, most teams are coming in for a Friday afternoon practice already.

Proposal Originated:

At the June 2020 NYSPHSAA Softball Committee meeting a discussion and straw poll took place.

Budgetary Impact:

There will be a financial impact for schools who would have to travel in one night earlier (Thursday night) however the tournament will start on Friday afternoon of day one so teams would have time to travel in for their games. In 2022, NYSPHSAA began offering optional practices for teams and 19 out of 20 teams opted to use the practice time. NYSPHSAA would also endure only additional expenses (and

 - c. Mile split; *Joe then introduced Kyle from Mile Split; who explained his role in the meet . NFHS will provide live streaming and Pat will continue to timing and results.*
 - d. Bid opening: *Joe explained the procedures of the bid opening and the rationale behind the bid process. Chuck proved a comparison sheet of relevant topics to be used in reviewing the bids*

Queensbury Bid: Discussion included: success of prior state meets, history of many large meets, concerns about spectator visibility of the runners (only first and last ¼ mile) and parking problems of the past. Chuck and Brian had visited the course recently and met with people in charge to discuss the proposed changes in parking procedures. The changes in the bid appear to be workable. All criteria for a successful meet appear to be met.

Letchworth Bid: The ensuing discussion was different because the course has very little prior history and not seen by many. The coordinators explained that the sectionals they have held were very successful with rave reviews about the course. The course is very spectator friendly and wide open so people go anywhere on the course. From the start to the finish more that 60% of the course is visible with little movement. Again, parking issues arose about the collection of tickets. There are three entrances to the park with potential of two lines each with one having a bus bypass. Sections 5 and 6 will enter the west gate which will help, since a large percentage of spectators will be from those sections. The third entrance will be only for very local people. The parking lot will handle close to 1000 vehicles with adjacent lots being able to handle busses, official, etc. All the rest of the requirements a met in a satisfactory manner.

After a quality discussion of bid comparisons, Kathy Champagne moved the bid be award to both sites with Queensbury hosting in 2024 and 2026 and Letchworth in 2025. The motioned was seconded. Comments included this allowed time for Section V to host large invitations to get any potential “kinks” ironed out and also allows athletes to see various parts of the state.

The motions carried by a vote with every section voting yes.

SECTION VI POST-SEASON REPORT Track 2022

Report on changes in Policy or Practice that were implemented

The mandatory coaches' meeting at Erie 1 BOCES and online went smoothly. Unfortunately, we had 15 schools out of 86 schools not participate in the class meets. 9 schools from the Buffalo League, 4 schools from the NFL league and 2 schools from the Independents did not compete. We attempted to have the same number of teams in each division but having this many schools not participate does make it harder to stick with this. Also, we do have some Division I schools and Division II schools combined together in class A. In the class meets we stayed with limiting the number of competing athletes to 16 per event and each school allowed one relay. Allowing three entries per team per event with the cut down seemed to have work well. We have had a lot of feedback from the coaches that they like the class meet competition and the chance to win a team championship. We will continue to move the class meet and state qualifier meet sites around the section to utilize the best facilities the section has to offer.

Problems encountered/concerns

The number of teams not competing as discussed above and the misunderstanding of opting out of Section VI travel. We will emphasize this at the preseason meeting next year. Signed papers must be presented by the close of the State Qualifier Meet. We did try and sell t-shirts at the Class Meets and did ok but will have to adjust the numbers for next year.

Recommendations for next season including proposed dates

We have asked to hire two additional officials for the State Qualifier meet for the last few years without any progress. We continue to try and juggle the 20 officials assigned to cover the Section VI State Qualifier. Two additional officials would help cover the relays and we would be able to have umpires to watch infractions on the track. As it is now we have to pull officials off their regular field event duties to cover the relay exchange zones. If an infraction then occurs on the track there are no officials to monitor them.

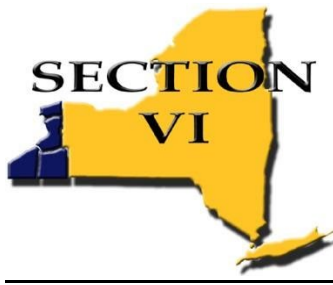

2021-2022 cut-off #'s AA: 965+, A: 500-964, B: 270-499, C: 150-269, D: 0-149 (same as past few years)

Proposed Classes for upcoming year: AA, A1, A2, B1, B2, C, D. Class AA continues to get smaller with just 7 schools now. Many Buffalo schools are housing more than 1 school in their buildings. With that, and for various other reasons, Buffalo now has combined a number of schools. This has led to a diminished Class C (17 teams) that will now be treated as just one classification for Sectional play. For this coming season, the basketball committee's recommendation is that charter schools Health Sciences be considered as a "Class AA" school and Tapestry Charter be considered as a "B" school. This is based on their play over the past # of seasons, dominance within their classification over that time period, and student athletes coming back to their schools for the coming season. Class B has 36 teams, considerably MORE than each of the other classifications now with the combining of schools and with many schools declining in enrollment. We would like to look at the possibility of three Classes (B1, B2, B3) based on what happens this fall with any more combining of schools or changes within other Classifications.

Changes in Policy/Practice for the upcoming season

Starting date for 2021-22 season will be Monday, November 14th. # of practices before first contest is now only 6. The State tournament will be hosted in Glens Falls this year. This will be the second of Glens Falls 3 year commitment to host the State Boys Basketball Tournament. Should any team qualify, the Federation tournament will be held the following weekend in March at Fordham University. Spalding continues to be the state provider for basketballs; the "Legacy" will now be used for Sectional play and beyond.

We will continue to use both Friday and Saturday dates to host quarter final games to assure quality officials will be available for all games that weekend. We will also continue to monitor and follow state guidelines as we proceed toward Sectional play regarding any Covid protocols that may exist at that current time. Buffalo State and JCC will be our playoff sites as they were in past years prior to Covid.

Local/Sectional/league protocols regarding Covid 19 policies in each gym/school for both practice and games will be monitored by our committee as play resumes in all sports this fall and winter. We will be prepared (best as possible) to meet any of those challenges again as we try and move thru what will hopefully be the end stages of this pandemic.

Rule Changes for 2022-23

Nothing major at this time.

Other Pertinent Data

With the NCAA transfer portal and other changes to the rules/protocols/guidelines on movement of student athletes from one school to another (for a myriad of reasons, including graduates who take on a year of grad school and are allowed to play for that new school), I believe many High School parents see transferring from one high school to another STRICTLY FOR ATHLETICS as an option that is good and allowable for them as well. We have seen kids now spend their high school years in 3-4 different schools for the sole purpose of looking for a different athletic situation for their son/daughter. We are seeing this trend primarily in boys basketball, but I'm sure there are cases involving football and girls basketball as well. While there is a transfer rule that does exist, that is not stopping these things from happening. I consider it to be an alarming trend that academics are so low on the totem pole and athletics are the basis of moving. I have NO IDEA how you change this perception, nor am I in a position to do so, but I wanted to share that concern as a life long coach that knows that 99.9% of our student athletes need to be considered as students first and athletes as a distant second.

Charter Schools continue to be a talking point at each of our meetings. While they may be public schools, coaches can and have been recruiting players that have already been playing on other teams. I get one or two texts daily during the summer from coaches letting me know kids from their school or another school are being recruited by a catholic school, playing AAU basketball for a coach associated with a Charter school (and thus being concerned that will lead to a transfer situation for that player), and even other public school coaches inviting kids to move into their districts to play for them. Transfer rule(s) are in place, but most seem to regard those as an inconvenience that they can find a way to navigate around.

I try and put this information in my reports as a way of reaching out to those with the administrative power and authority to possibly investigate or consider changes to what we already have in place. My biggest fear and concern is that High School athletics as we currently know it simply will not exist in 20 years if these growing trends are not somehow addressed. Schools will not want the headache of dealing with parents more concerned about their child's next 3 seasons on the basketball court than they are about their GPA.

As I stated in last year's report, the Buffalo News has very little to do with the reporting of high school sports any longer, at least not until playoffs arrive. With that in mind, we established a new website that was very well received by our coaches. In conjunction with that, for the first time, we as coaches had a direct hand in helping pick the All-Western NY boys basketball team. In the past, this was done exclusively by the Buffalo News. We hope this will continue to be the case.

Assisting Injured Athletes, Expansion of Exchange Zones Among Rules Changes in Track and Field/Cross Country

INDIANAPOLIS, IN (June 27, 2019) — The expansion of exchange zones in short relay events, which does not require tracks to be repainted/resurfaced, as well as assisting injured athletes, are among the rules changes for high school track and field and cross country. Seven rules changes were recommended by the National Federation of State High School Associations (NFHS) Track and Field and Cross Country Rules Committee at its June 10-12

meeting in Indianapolis, and all changes were subsequently approved by the NFHS Board of Directors.

The first change amends notes in Rule 4 (Competitors and Competition) and Rule 8 (Cross Country) which reads, "A competitor who provides assistance to an injured or ill competitor should not be disqualified if neither the individual competitor providing the assistance nor his/her team gains an advantage as a result of providing the assistance."

"Previous changes to the NFHS rules created the exception that allows a competitor to assist an injured or ill competitor without being disqualified when medical staff is not present," said Julie Cochran, NFHS director of sports and liaison to the Track and Field/Cross Country Rules Committee. "In a clear majority of these types of situations, the action is intended to be an act of good sportsmanship and not an attempt to circumvent the rules or gain an advantage."

While the injured or ill competitor is disqualified for receiving help, the competitor helping will not be disqualified, unless that competitor – or his/her team – gains an advantage. In all cases, the final decision rests with the meet referee, who has the sole authority to rule on infractions, irregularities and disqualifications in a meet.

Changes to Rules 5-3-3 and 5-3-4 expand the exchange zone in relays with legs of 200 meters or less from 20 to 30 meters. All exchange zones for races with legs longer than 200 meters will remain at 20 meters.

"The acceleration zone is now incorporated into the existing exchange zone, thus a 30-meter exchange zone for relay races with legs of 200 meters or less," Cochran said. "The rule change does not require that tracks be repainted or resurfaced in order to follow the new NFHS rules. Existing acceleration zone markings, such as

triangles, squares or colored tape, placed at that location may be used to denote the beginning of the exchange zones on a track.”

Rule 6-2-6 has been amended to prohibit athletes from running backwards or in the opposite direction (non-legal direction) during warm-ups on horizontal jumps, pole vault and javelin runways.

“This change promotes a more organized and efficient warm-up period,” Cochran said.

“Competitors should now be more aware of their surroundings.”

Two changes to Rule 6 provide equivalent metric increments for tiebreaking jump-offs in vertical jumps, as well as clarify distance requirements for long jump and triple jump pits. For long jump and triple jump pits constructed after 2019, the length of the pit shall be at least 23 feet (seven meters). In cross country, Rule 8-1-1 has been reorganized to clarify that a cross country course may be marked with any or all methods listed in the rule. An additional change to cross country rules adds language to Rule 8-1-3 regarding straightaways at the start of a course. The change provides a recommended minimum distance of 100 meters for beginning straightaways, and states that no narrow section of a course should be longer than 10 feet (three meters) long. Small cones of the appropriate color, at least 12 inches (30 centimeters) high, are also now permitted to be used in lieu of painted lines or survey chalk.

According to the 2017-18 NFHS High School Athletics Participation Survey, track and field is the most popular sport for girls with 488,592 participants and is No. 2 for boys with 600,097. Cross country ranks sixth for girls with 223,518 participants and sixth for boys with 270,095.

There have been some rule changes that will affect the relay zones and the jumping events. I have copied them below. If you are repainting your track, you will only need two triangle markers for the 4x100 meter relay. There will no longer be a need for three markers - fly zone marker & two regular zone markers. Already lined tracks will use the beginning fly zone marker and the end of the zone marker as the only two needed. There are a couple more changes but they are minor and I will present them later.

Thank you for letting us know.

I have finalized our upcoming season schedule, on one tab of the Google Sheets shared with you all at the link below, and our Section VI ITF Program Divisions and Championship Classification matrix on the second tab. Please toggle between these Sheets using the bottom tabs. The Championship Classifications were divided as equally as possible based on the 2022-2023 NYSPHSAA Classification populations with the caveat of Holland/EA Girls based on the reasoning noted on the matrix. The Divisional groupings were weaved from the largest population program through the smallest based on the 2022-2023 NYSPHSAA Classification populations.

At this point I would recommend reducing the number of contests needed to participate in the Section VI ITF Team Championships to four (4) contests in lieu of six (6). This is based on the current fact that we can only schedule six (6) competitions where the Throws and the Pole Vault are included based on facility availability. There are no additional dates available to our League at Houghton College and Buffalo State College does not support the Throws and Pole Vault. Pete also attempted to contract a date or two with Brockport State College but there was no availability there. Pete has attempted to contact the Lancaster CSD Athletic Office about contracting the use of their Field House, as we did last winter season, for the purpose of contesting the Pole Vault and Throws on the weekends that our League is scheduled at Buffalo State College but there has been no response as of yet.

Please let us know if there are any issues with the schedule, Division format, and/or Championship Classification format as soon as possible so we can begin to detail the 2022-2023 Section VI ITF Handbook.
