C. Durr, Girls Basketball Chairperson, is investigating Villa Maria College and D'Youville as potential sites for Girls Basketball semi-finals. C. Durr was asked to formally survey girls basketball coaches and student-athletes for their sentiment on venue.

4.4 Transportation to State Championships

M. DiFilippo shared continuing issues with multi-point pick-up locations for buses to state championships Issues are specific to inspection as well as uneven numbers between bus capacity and student-athlete location (north and south). M. DiFilippo recommends a central location for inspection and then for instances when multiple buses are involved, plan routes to pick-up athletes located in the north and south respectively. Discussions to continue to find resolution to these issues.

6.4.1 Boys & Girls Soccer Semi-Finals

The Boys Soccer Committee requested to move semi-finals to the higher seed, to which the Sectional Intersectional Committee is in favor and is an action item for the March 2024 athletic council meeting. Girls Soccer is not in favor of moving semi-finals to the high seed. As such, and in order to remain equitable, M. DiFilippo asked C. Durr, Girls Soccer Chairperson, to formally survey the girls soccer coaches about their sentiment toward semi-final venue.

Recommendation to obtain student-athlete input as well. League SAAC representatives at Executive Committee meetings and Thought Exchanges are initial ideas to accomplish this goal.

 - b) Girls Tennis Proposal

The NYSPHSAA Girls Tennis Committee is proposing to change the venue for the Girls Tennis Individual and Team State Tournaments to the National Tennis Center in Flushing, NY for Fall 2024-Spring 2028. The purpose is to provided equity between the girls and boys. It would remain week 17 of the calendar but it will be a Mon-Wed tournament with travel on Sunday instead of Thur-Sat with travel on Wednesday.

NFL, ECIC, BPS, NO are in support of the Girls Tennis Proposal.

*The CCAA is meeting tomorrow to discuss both proposals.

Regardless of how the CCAA votes, the majority of leagues are in favor of both proposals and J. Roth, Male Representative, and M. Fallacaro-Dougherty are to vote in support of both items at the February 26, 2024 NYSPHSAA Executive Committee emergency meeting.

M. DiFilippo asked J. Sortisio and C. Alvarez to share both proposals with superintendents and principals in case there are any concerns.
