Executive Director's Report:

Non-league, tournament, and scrimmage games prior to 9/26 will be cancelled by the office. All games (league, non-league, tournaments) scheduled after 9/26 will stay as is. Modified schedules WILL NOT be reworked. If you want to reschedule a modified contest you should do that with the opposing school and let us know ASAP. Golf schedules which are created by the schools should be adjusted accordingly. Please try to start scheduling ASAP with golf. You can have golf matches as early as 9/22 or 9/23. Once your team is selected.

Update on School camps/clinics/workouts - there have been a lot of phone calls and questions and "whistleblowing" about summer workouts and camps. Please remember that the governor NOT NYSPHSAA have made the mandate about NO SCHOOL ACTIVITIES.
