### Welcome:

**-Introductions:** Welcome everyone. Fall has been a challenge. Transportation is going to be a huge challenge also.

**-Division Breakouts 5 minutes** Discuss school spectator procedures that apply to your individual schools. Divisions I, II, III and IV to discuss indoor procedures or any type of any individual school issues or any ideas about spectators and fans. Some schools can accommodate fans and some cannot. Take a 5 minute break for division discussion.

Division I: Volleyball procedure. Frontier being strict in trying to temperature checks and have spectators sign in. No one else in Division I league doing same. Frontier may drop. Basketball a concern of wearing masks for players in the winter in basketball. Hopefully things change. Impossible for boys/girls to run up and down court with masks.

Division II: Previous year wearing full mask during basketball games was difficult. Athletes constantly on/off process. Unable to keep mask on all time like expected. Starpoint is a Niagara County school so regulations not as strict as is in Erie County. Starpoint for volleyball, athletes must mask up 100% of the time until play. Once playing masks removed and play begins. Try to comply as much as possible as Erie County. Non forcing of mask because of concern of issues. Williamsville directed to have masks on at all times and during competition. That is the direction that we have right now. I have to follow protocol.

Division III: Each school in division pretty consistent. Lakeshore parents pretty respectful. Signs up everywhere. Masks on, social distancing, when possible. The only time there is a struggle with mask is when athletes watching varsity or football comes out for practice. On the bench masks worn at all times. During game play they are on person. No masks worn outside at Lakeshore.

Division IV: Each school in division same with masks whether indoors or outdoors. Indoors, strictly enforced. Something will be said if no mask worn. Encourage social distancing indoors. With size of gyms try to limit athletes crossing paths from different schools.

**- Golf Chairperson:** Need.

League needs a golf chairperson. Scheduled championship is at Diamond Hawk on October 12, 2021. Without a chairperson some decisions must be made. A) are we going to host championship and continue; b) and if ECIC hosts how to accomplish. Course reserved and food

**Executive Director's Report**

- Schedules: Fall schedules no changes every day, done; Winter schedules are 99.9% done and Spring alignment is in the process of being prepared. Activity Board check of beds numbers for accuracy. Hopefully by next week if not earlier a draft of spring alignment will be provided to athletic directors. Please review for accuracy.
- Officials: There are not enough officials to cover games. Modified games with officials are lucky. If you move from selected dates you are moving to dates of other leagues. If games moved, diminish chance from an already bad situation to obtain an official. Cannot provide something that is not there. Moving games not an issue but be aware that it is next to impossible to obtain an official. Are we running a modified program if there are not enough officials? We need to find different alternatives to recruit officials. No

new people. Part of the officials' agreement is to actively recruit officials. Numbers are not seen. Like idea of using parent/coach or someone on school other than school base official who could now be used for Lakeshore when not signed up for Lake Shore. Works for West Seneca wants to do West Seneca games and next year unable to use because one-year eligibility. Have a shortage, would rather call coach, run as scrimmage. Kids can play. Not in favor of school based official based on one-year. Contractual to have 2 officials on varsity volleyball. Slots for 2 so contractually should fill 2. We are going to be unable to fill 2 slots for volleyball. Suggestion to have modified games at dismissal time. Fill games with 2/1/1. Do you need advance notice of locating an official? Couple days advance notice would be good. Advance notice of no officials helps locate officials for uncovered games setting up with PE, parents, etc. Lake Shore used school based official on as a chaperone. Situation will not get better if no change in how business is completed. Using own person for game as long as indicated as a scrimmage.

- Arbiter: All schools using Arbiter. Must information section office by end of month that all schools using Arbiter.
- F. Hockey – 2 divisions:
- Coaches Meetings: Feedback: Nothing to share by group. Question of way to find out if there was attendance by a coach. No knowledge of an attendance list.
- Buffalo Bills Girls' Flag Football: Buffalo Bills sponsoring a girls' flag football which was discuss last May. Jets and Giants are doing the same. Interested, we can acquire more detailed information. It may be a sport for the spring for those schools that wish to compete. Eligibility rules must be followed. It could be considered a pilot, but all rules must be followed. Todd Nelson did not provide much information. Start date? How many games played? Todd just indicated to let him know if interested. Possible information meeting. No date as of yet.
- Niagara Frontier League: Unified sports schedule by their league only. They would only play NFL teams and if you would like a non-league you would find someone else. Does ECIC wish to follow this as well. ECIC has enough to take care of own league. NFL traveling out, difficult with population of athletes and out late. Interest in doing something different better for the athletes. Discussion to take place continue on as is without NFL or change to league structure. Difficulty recruiting officials. Many schools looking for custodians, teachers, subs, bus drivers, etc.
- Athletic Directors Meetings: Held monthly, all discussion, ideas take place during meeting.
- Athletic Council Meeting: Held every other month run by Steve Smith at which time votes take place.
