### Opening Remarks:

*Rich Gray*

- **Guest Speaker Dr. Jeff Rabey, Superintendent (Depew)/Charter School Placement:** Dr. Rabey, Jim Graczyk, Mark DiFilippo, Buffalo Public Schools, Charter School representatives at meeting to discuss the best way to handle placement of charter schools. Accomplished a solution for placement of charter schools. Vote to take place in (2) weeks at section meeting. Charter schools not necessarily looking to be a part of ECIC league. Charter schools wish to have a schedule. Looking for games scheduled against ECIC league. Charter schools for fall have (3) teams, Buffalo, Science Global and Tapestry, combined with Health Sciences.

**Boys Soccer:** Buffalo, Science Global and Tapestry, combined with Health Sciences. Varsity only for boys' soccer. Amicable decision for Buffalo Public Schools would include the (3) schools at the varsity level for boys' soccer to include these in the Buffalo schedule.

**Boys Volleyball:** Tapestry, varsity only. ECIC agreed to provide (8) games. Cheektowaga (1); Maryvale (1); Iroquois (2).

**Girls Volleyball:** Health Science, Buffalo Science, Global are Varsity only; Tapestry JV and Varsity. ECIC to provide (16) games.

West Seneca East/West (2); Holland (2); JFK (2); Cleveland Hill (1); Tonawanda (2); Lackawanna (2); Iroquois (1); Pioneer (1) total (13)

**X-Country:** Tapestry, boys/girls; Global boys/girls. These schools will be included with other schools and combine with our scheduled meets. Any schools participating will follow Depew's X-Country schedule.

Plan (A): Option for ECIC to include charter schools which would qualify for the state, the section, Buffalo public, and ECIC in order to work this to the advantage of all schools.

Plan (B): Decision against this solution and it reverts back to the State office and the decision will be the States decision relative to placement of charter schools.

May 9, 2022, Monday vote will take place and decision to be made at Athletic Council meeting.

Plan (A) as option, league schools to make decision on playing each fall season for boys' volleyball (8) games total and girls' volleyball (16) games total with the charter schools.

Charter schools not concerned about participating or winning ECIC championships. If ECIC provides a schedule for charter schools as a league, they should be charged for participation in the sport in the ECIC league. Charter schools should pay the financial burden of the officials and travel.

- **Mark DiFilippo—Officials:** Met with the State OCF. Huge disconnect between section executive directors and/or representatives that represent the sections and the sport officials' representatives in terms of the shortage of officials. Topic of discussion is trying to streamline the process to certify individuals to becoming officials sooner. Response received is that officials are leaving because of the poor behavior in the stands and schools need to address behavior. Behavior in stands one problem. Other problem is not enough officials. Need more recruitment. In the process of preparing some trial on-line certification processes for one or more sports.

Goal is to create a path that is state wide and not group specific to recruit officials. Each group/organization completes a different type of certification to certify officials. Softball/baseball in Section VI has (5) different groups each recruiting differently. Possibly an on-line process without a deadline. Certification for Boys/Girls volleyball is a (12) week course attending meetings at Erie1Boces. Developing a shorter easier process to be ranked at a lower level and then be observed to move up is the goal of the certification for volleyball.

Completion for coaching is through the NFHS pathway on line.

- **Modified Fall alignments--Any issues:** Modified girls' soccer--move Frontier #2 from Division II up to Division I. Based on beds numbers Frontier #2 (1013) should be in Division I. Discussion to be had regarding schools that have more than (1) team due to the shortage of officials, especially at modified level. Frontier #2 beds numbers were not followed. Frontier #2 was moved to Division II instead of Division I considering that Frontier only has 7<sup>th</sup> grade athletes. Justification with taking consideration for Sweet Home but not Frontier. Put schools with (2) teams belonging in the division based upon beds numbers. Frontier #2 should be Division I based on beds numbers. Make Division IV all 7/8/9 and realign every other school.
