Opening Remarks:

Rich Gray

- **ECIC Basketball “Showcase” Specifics:** Date, teams playing against each other, organization, schools hosting.
- **Official issue/modified:** would there be any interest in lowering the number of contests on modified games to help with the lack of officials. Example: baseball/softball 12-14 games. How to handle additional non-league games and lack of officials. Lowering number of games on modified games to 12 or 10 games. Not having modified officials does not look good to others and parents at modified level. Schedule and play more games as scrimmages. Suggestion to move schedule. Having less games hurts more than not having an official on a game.

- **Division Breakouts:**

Division 1:

Officials/Modified: Start season later for modified or reducing the number of contests. Concern regarding going into June for games. Not liking limiting the number of games.

Basketball Showcase: Not much enthusiasm regarding running a basketball show case.

Reason 1: Use a date at conclusion of season. Snow cancellations as well as date would have to fit in before playoffs.

Reason 2: 7 sites needed to host 14 games for Varsity and 7 additional sites for JV games.

Division II:

Officials/Modified: Later start may be appropriate not less games. Umpire schedule at all games for safety reasons and quality of game vs. losing games during the season.

Basketball Show Case: One game match-up suggestion without losing as many non-leagues' games. Some sort of deadline and take less teams based on deadline of teams playing match-up games. One division plays top 4 teams in other division. Concern with hosting schools and line up. Neutral site or site based upon match-up.

Division III:

Officials/Modified: Later start date other than less games. Giving up games takes pressure off of the officials' organization to continue to seek more officials and try to alleviate the problem.

Basketball Show Case: Many on a different page. Division III not in agreement with holding show case. Next year the first normal year in 2 ½ years. Might be better to wait until next year instead of this year. Compile a list of teams wishing to participate, schedule match-up, play 2 sites, play 4 games on a Saturday at 2 different sites. Varsity only with 8 teams/4 games like center court classic. Not scheduled for February 18 date. Schedule for MLK day. Pre-season tournaments already scheduled. No play on last Saturday.

Division IV:

Officials/Modified: Not to reduce number of games played.

Basketball Show Case: Need for a full year when starting back full strength after COVID. Movement within alignment. Revenue standpoint cost high for all schools to host 4 games on one day. How much revenue will be recognized?
