4.1 WNYSO Contract

- 4.3 Wrestling Litigation

The Section is in receipt of legal documentation providing notification of an Akron student-athlete seeking a notice of claim regarding the 2011 Biondo case. However, the claimant has failed to file the notice of claim within the deadline period of 1 year from the date of the incident. T. Slade has contacted the Section's insurance carrier who, in turn, assigned an attorney to handle this potential lawsuit. Committee members will be updated as more information becomes available.

4.4 Friends and Neighbors Expirations

6.10.1 Sportsmanship Standard Proposal

The following proposal will be a discussion item at the May 1st, 2015 NYSPHSAA Executive Committee meeting and an action item at the July 2015 NYSPHSAA Central Committee meeting: To add the following language to Sportsmanship Standard # 27 in the NYSPHSAA Handbook under both coach and player. "#4.The Section Athletic Council will have the authority to extend the period of ineligibility in those cases where the actions of the individual that was disqualified from a contest or scrimmage are warranted. The period of ineligibility cannot exceed one year from the date of the disqualification."

Currently, there is no language in the Sportsmanship Standard that allows sections to impose further penalty for a disqualified player and/or coach other than the one or two game suspension or the rest of the season for a third disqualification. The sportsmanship standard does allow a section athletic council to impose a penalty for a player or coach who makes physical contact with an official.
