3.0 EXECUTIVE DIRECTOR'S REPORT (Mark DiFilippo)

3.1 AC ACTION ITEM: Approval of Mark Kruzynski, Superintendent from Medina, as the NYSPHSAA Foundation representative for Section VI

3.2 WNYSO Contract MOA

Section VI and the Western New York Sports Officials (WNYSO) current contract expires August 31, 2021. A one-year extension, September 1, 2021 through August 31, 2022, including all terms and conditions as listed as well as continuing to follow the sports officials' 2020-2021 rates was sought by Section VI. Agreement by the WNYSO is pending.

3.3 School Health Examinations

On December 15, 2020 the NYSED released an update regarding school health examinations in light of the COVID-19 pandemic. NYSED is extending the requirements for a health exam for school attendance and participation in interscholastic athletics through April 2021 (tentative), which includes permitting the use of 2018-2019 or 2019-2020 health exams for participation in the 2020-2021 sports seasons. In addition, the requirement to document physical examinations on the NYS Required Heath Examination Form beginning January 31, 2021 was emphasized as well as the fact that this will affect 2021 Fall Season 2 and 2021 Spring Season student-athletes. The NYSED document can be found within the appendices of this document (Appendix I).

3.4 Winter and Fall 2 Coaches Meetings

Chairpersons of sports that fall within the high-risk category (basketball, ice hockey, cheerleading, and wrestling) were asked to be prepared to schedule their coaches' meetings in the event clearance to play is issued. Fall Season 2 sports' (football and volleyball) chairpersons were also asked to convene their coaches in preparation for their revised seasons.

3.5 NCCS Update

Section VI received Northern Chautauqua Catholic School's 2021-2022 NYSPHSAA membership application on Wednesday, December 2, 2020. On Friday, January 8, 2021, the results of the Chautauqua-Cattaraugus Athletic Association (CCAA) post card ballot were released indicating the Northern Chautauqua Catholic School (NCCS) application did not meet the 2/3 CCAA membership majority for league acceptance. Part 520.1a under Section 520, Membership for Non-Public Schools, of the Section VI, NYSPHSAA, Inc. Policy Manual states "An application* must be received by the Executive Director by September 1 of the preceding year in which participation is expected. Please note: Agreement to accept the applicant school or league into league membership is a prerequisite for membership into Section VI." Therefore, Section VI sent a letter to Andrew Ludwig, NCCS Principal, indicating the NCCS application for 2021-2022 NYSPHSAA membership application is void based upon the failure to obtain league membership.

3.6 Reminder - Independent Schedules

Section 170 Independent Status of the Section VI Policy Manual states "A school must request approval of a team's independent status from the Athletic Council on an annual basis." Athletic Council members will be asked to remind their respective leagues of this policy.

3.7 Health Sciences Charter School Boys Basketball 2020-2021 Classification Update On September 16, 2020, the Section VI Athletic Council voted and approved the Class AA placement of Health Sciences Charter School Boys Basketball team for the 2020-2021 winter season. Health Sciences Charter School appealed the decision to the Section VI Executive Committee. On November 18, 2020, the Executive Committee decided to uphold the decision of the Athletic Council. Health Sciences Charter School appealed the Executive Committee's decision to the NYSPHSAA. On December 21, 2020, the NYSPHSAA decided to uphold the decision of the Section VI Executive Committee. As of December 21, 2020 and if inclined to do so, Health Sciences Charter School had 30 days to submit an appeal to NYSED. At present and to the Section's knowledge, an appeal has not been submitted.

- 5.3.5 TPG Sponsorship Update

TPG, a national sponsorship company, has contracted with the NYSPHSAA for sponsorship rights for a ten-year period. In return for the NYSPHSAA sponsorship rights, TPG will provide NYSPHSAA with a guaranteed rights fee which will exceed the current revenue of NYSPHSAA sponsorships. TPG is now proposing a 1-year contract to Section VI for the remainder of this 2020-2021 school year. TPG would keep 50% of the sponsorship funds acquired on behalf of Section VI. If Section VI is inclined to move forward with the partnership after this school year, TPG would review the Section's financial reports to develop a marketing plan. A contract would then be negotiated. The Finance Committee directed D. Scholla and M. DiFilippo to investigate the TPG sponsorship proposal to Section VI for this 2020-2021 school year. If secured, D. Scholla and M. DiFilippo will provide an evaluation of the partnership to be reviewed by the Finance Committee after the conclusion of this school year.

Winter and fall season 2 sectionals were discussed. Highlights are bulleted below.

- Girls and Boys Bowling Sectional meets are scheduled for March 10 and 11, respectively. Sectionals will be held at Airport Lanes. This year, only schools with a 500 or better record will be allowed to participate. Under yellow and orange zone restrictions, Airport Lanes is allowed a maximum capacity of 546 persons. Without spectators, all 66 lanes will be available for use. Also, with approximately 25 teams participating, attendance will be well within the capacity requirement.
- Boys Swimming This year, the co-chairpersons constructed a bracketed team
 championship wherein each team will be ranked within their classification. Sectionals are
 scheduled for March 2, 5, 9; culminating with the finals on Friday, March 12. The sectional
 format was constructed with consideration of the current circumstances surrounding
 COVID-19. Thus, matches will be able to be conducted in person or virtual, depending on
 zone restrictions.
- Due to concerns of football and volleyball playoffs overlapping, football will take the top 4
 for the first round of playoffs (week of April 19) and seeds 5 and 6 will participate in the
 Funke Bowl. Any team seeded 6 or lower has the option to participate this week with a
 match-up scheduled by the football chairs. The week of April 26, approximately 10 football
 teams will continue on in the playoffs.
- The Executive Committee decided to move forward with the top 8 teams in each classification for volleyball sectional playoffs. These sports chairpersons will be asked for their input regarding tiebreakers. All 3 rounds of playoffs will be conducted the week of April 19th.

APPENDIX B

Draft

Prohibition of Retaliatory Behavior (Commonly Known as "Whistle-Blower" Protection)

Section VI prohibits any retaliatory behavior directed against complainants, victims, witnesses, and/or any other individuals who participated in the investigation of a complaint of discrimination and/or harassment. Complaints of retaliation may be directed to the Executive Director. In the event the Executive Director is the alleged offender, the report will be directed to the acting Section VI President.

Where appropriate, follow-up inquiries will be made to ensure that discrimination and/or harassment has not resumed and that those involved in the investigation have not suffered retaliation.

This has negatively impacted some schools from qualifying for both awards.

- The Appeals Committee shall be the NYSWOA President, NYSWOA Past President and the NYS Rules Interpreter. The NYSPHSAA Wrestling State Coordinator will oversee the process and participate in the discussion but will not be a voting member.
- If an appeal is filed at the end of a match, only the offended wrestler must remain on the mat, but the mat official shall instruct the other wrestler to remain in the mat area.
- The coach will have two minutes to state his/her case however the Appeals Committee may have additional questions for the coach.
- Waive NFHS rule 3-1-9 to allow the Appeals Committee, at their request only, to review video replay that is supplied only by a NYSPHSAA approved broadcast partner. This would apply only to state semifinals and finals matches only.

I. NYSPHSAA Office Reports

Dr. Robert Zayas - Updated on COVID impact

- Robert stated that Cheerleading had been determined to be a high-risk sport by the NYSDOH. Dr. Zayas did not select the risk category, and the NYSPHSAA staff did not have the opportunity to weigh in.
- Cheerleading does not have the authorization to begin just as basketball, ice hockey, and wrestling.
 NYSPHSAA has been advocating the State Officials about when and if they will authorize high-risk sports.
 Unfortunately, over the last month, as we see an increase in infection rates and hospital rates increase, the likely hood of getting to authorize for January 4th does not look very realistic.
- NYSPHSAA is receiving concerns from school members about the feasibility of high-risk sports being played during this COVID crisis.
- Joanne, Section 5, asked, "If the January 4th date does not start, but we have the March date for the fall sports, if they push the January date back, is it possible to merge the two seasons?". Dr. Zayas stated once we receive authorization, it will be more exact on what options we have.
- Robert has attended calls with Directors across the state. Again, examination and metrics of risk are different per state.

Non- NYSPHSAA Awards during NYSPHSAA Awards Ceremonies

- Robert provided an overview that the executive committee approved only NYSPHSAA Awards would be given during NYSPHSAA Ceremonies.
- For example, awards such as coach's MVP award, all-state award, etc. However, these awards would delay the event, and the committee or state association has nothing to do with it.

Joe Altieri – State Tournament Update/Venue & Hotel Communication

- Current State Tournament bid will complete this year, 2021; we are looking at new proposals 2022-2024 and Game Day 2021-2023.
- If the event is canceled, we will ask the venue if they want a year extension to host the championships. RIT would still be interested in hosting the event.
- The Radisson did close, which was 100 rooms. However, the Hilton Garden Inn and RIT can accommodate the overflow.
- Hall of Fame deadline is January 29, 2020. Class of 2020 will be recognized this summer.

Kirsten Jadin -no updates.

Chris Joyce – Teall Properties Group

- The GM is Joe deGuzman
- Cheersounds will still be affiliated with our state championship.

Chris Watson - no updates -available when needed

II. Tournament Bids: Competitive Cheer/Game Day

Four bids were received for the State Competitive Championship and one bid was submitted for Game Day Regional West. There were no bids submitted for the East Regional. The bid application for the East Game Day Regional is extended to December 31st. *Arlington High School and Section 8 offered to host the East Regional Game Day.

- Joe reviewed the bid process; the staffing committee will recommend the most suitable venue for the State Cheerleading Championship and West Regional. The recommendation will be reviewed by Championship Advisor Committee, which will meet on January 14th. The Executive Committee will meet on February 3rd for the final approval. The cheer committee will cast a vote, and that will be the recommendation. Jen will facilitate the discussion and then call a motion for a specific site. One vote per section.
- Coordinators are asked to objectively state information about their facility, to have an uninfluenced bid and bid that is most suitable for the event.
- After the submissions are reviewed, Joe will send information about the sections and facilities who submitted. They will also be posted on the NYSPHSAA website.
- Dr. Zayas added bids should not be based on cost alone. We should look at if the facilities are a quality site and best suited to hold the event to give the athletes an environment to recognize their accomplishments.

Concerns about facilities

- Jen Simmons discussed with Chris Joyce our concerns and critical points such as accessibility the day before the event, mats are on-site before avoiding delays, practice area, staging place for where the teams go, the closeness of hotels, and space for judges.
- Jen Keane reiterated the importance of the practice area being separate from competition floor. Alice echoed the same concern but also expressed we are still challenged by seating, and enough room for the cheerleaders to store their belongings.

Section Coordinators overview of bids

Section 8 - Nassau Coliseum

- Jen, Section 8 Coordinator, provided an overview of the spacing at Nassau Coliseum. The venue has more than enough seating, and for warm-up, the Nassau Coliseum will provide a separate warm-up area.
 60,000 square foot exhibition hall, which would house the practice area and a place for the cheerleaders to leave their belongings.
- Jen Simmons asked about ticketing percentage from Nassau Coliseum, Jen Keane said it is due to Ticket Master, but Nassau Coliseum said they would be willing to work with us. Joe added the amount per ticket sold which Nassau Coliseum is asking for is concerning, which would be \$6 per ticket.

Section 5 - RIT

- Joanne, Section 5 Coordinator, provided an overview of the spacing at RIT. Joanne stated that RIT is willing to work with us. Over the years, we have made the spacing better. The warm-up space and main floor will still be in the same area. RIT has offered the gym. However, it is not in the bid.
- Joanne suggested possible holding more sessions to allow for more space during each session. When Sectionals are held at RIT, they have over 100 teams and hold four sessions
- Scott brought up to Jen Simmons that we must monitor the warm-up area better.

Section 4 – VFC Memorial Arena

- Andrea, Section 4 Coordinator, provided an overview of the spacing at the Arena. Andrea explained that just as RIT and OCC in the past, the warm-up area will be held on the same floor as the main competition floor; however, three full sets of mats can fit.
- There is a large storage area where the teams can place their items. There are hotels within walking distance from the Arena.

Section 2 – Times Union Center

- Stephanie, Section 2 Coordinator, provided an overview of the spacing at Times Union Center. The setup would be the same as RIT. Stephanie is not sure where the teams would be held, she said there are a few locker rooms available, but she is unsure if they will be used. Stephanie is unsure if two sets of warm-up mats would fit on the floor.
- There are hotels in walking distance to the venue.

Committee Discussion

- Joe summarized that Nassau has the most space for warm-up. RIT, VFC Arena, and Times Union Center all have a similar warm-up area. Nassau is a high cost to the association, and we have quality venues within the other three bids and need to consider moving forward with those. **The committee agreed.**
- Joanne asked, "Who would be directing the event at Times Union Center in Albany? Is it the cheer coordinator or the facility?". Stephanie explained Doug put in the bid who runs TC would be in charge, but she would help.
- Jen Simmons had additional questions about the Times Union Center, including hotels and rates. Joe said hotels are within walking distance, and rates are similar. Joe stated the Times Union Center is a 33,000 cost with a 2 dollar per ticket fee, a 40,000 venue, but they are offering a \$1 rebate for online ticket sales. Again, the remaining three venues are similar, Time Unions Center is higher than the other locations. Committee members agreed Albany would not be the best venue and discuss RIT and VFC Arena further.
- Alice, Section 1, stated that her section does not want to return to RIT; Binghamton is the middle of the road. She said Andrea and Joanne have been running competitions for a long time, and we would be in good shape either way but would like to try something new. Justice, Section 6 also agreed it would be nice to try something new.
- Stephanie brought up seating. Joe stated seating at RIT is under 2,558 and seating at VFC Arena is 4,000. Todd wanted to make sure the set up would be similar to RIT, and two warm-up mats would fit.
- Jen Keane motioned to move forward with the VFC Arena in Binghamton for the next three years for the State Cheerleading Championships. Stephanie seconded the motion. The committee voted 9 to 1.

 Binghamton would be the committee's recommendation, and the staff also favors Binghamton as a recommendation.

Game Day West Regional Bid - Section 4, VFC Memorial Arena- there were no concerns, committee voted to recommend the event to be held there.

- Alice reminded the committee that we would have to discuss game day warm area closer to the event.

 Game Day East- was discussed no real bid at this time. Section I met with group to ask questions, and were interested. Joe informed group of the re-bid of the Game Day East and all were welcomed to bid.
 We would meet right after the New Year to review any bids that come in.

III. Participation numbers – updates

- Jen states the numbers for competitive cheer may not be accurate. Jen would like section reps to check numbers and send them back to her in January
- For Game Day, Jen would like the number of teams who currently have competed in Game Day.
- Section 8 & 11 did not have any Game Day teams in the fall.
- Section 5 has the most competing teams in the state.

IV. Game Day format and Structure

- Jen and Andrea met with Josh and Bill to review the training materials and discuss updates/changes.
- Bill and Josh will provide the training again this year. The training will be the same for both coaches and judges.
- Todd discussed we could determine Game Day Divisions in the Fall after we know who is competing
- We agreed that during this time (COVID) and for streamlining events- format would be to have teams follow structure used in Section I, teams perform all three sections of the competition once they enter mat.

V. Training

The power points for this year's Competitive Cheer trainings are almost complete. Andrea and Jen talked to Josh and Bill about the rolling out of the trainings. Andrea has used the format they use for conferences. The trainings would be released for Judges and Coaches to watch. There will be a link to submit questions for a period of time. All questions will be answered and posted. Once the question period is over, the power points will still be available on the State Cheer site to review when wanted.

NYSPHSAA Staff: Dr. Robert Zayas, Joe Altieri, Todd Nelson, Chris Joyce, Chris Watson, Lisa Hand

Dr. Robert Zayas welcomed the committee. He talked about winter high risk sports being delayed. He also talked about guidance from the Department of Health. The Department of Health has placed indoor track as a low risk sport. Facilities can have no more than 50 % capacity. His goal is to have participation of athletes in a regular season first, then hopefully a culminating event during weekend of State Tournament. He also stated how important indoor track is to athletes. Even if practices need to be modified, it is far better for athletes to have something than to go home and play video days or use Tik Tok. He cited according to the Department of Health, face coverings must be worn unless the student is unable to tolerate it. Robert also announced the Central Committee approved no non-NYSPHSAA awards at State Tournament ceremonies. This does not impact Indoor Track States.

Joe Altieri welcomed everyone and asked to go around the horn to share the status of each section:

Section 1 – a few meets at Armory, taking a survey to determine how many schools are doing ind. track

Section 2 – Attempting outdoor meets

Section 3 – Postponed indefinitely

Section 4 - Postponed to January 4

Section 5 – Postponed to January 4, has indoor sites

Section 6 – Has three dates at Houghton College

Section 7 – Using Plattsburgh College who will allow contests, but no more than 30 people at one time

Section 8 – Attempting outdoor meets – having trouble with indoor sites

Section 9 – Attempting outdoor meets – may have state qualifier at the Armory

Section 10 – Cancelled – St. Lawrence will not allow them to have any meets

Section 11 – Attempting outdoor meets

PSAL – No report

CHSAA – Will have some form of a season

AIS – Will have some form of a season

Joe Altieri continued his report indicating the committee should plan to meet in January or February if/when new information is available on track and we know who may be able to participate in States. A that meeting, we will discuss format of States, etc. He reported the host hotels are contracted and ready for us for States. He reported a call with Lou and Lauren from OBAC in October to discuss our event and that NJ canceled their State met so the Sunday after ours is available. He said everything is on the table at this point to run a State meet or culminating event. Joe also asked the group for information on virtual meets and if anyone has run them. Section 9 indicated they had some experience with them. Joe was going to work with the NYSPHSAA Staff to develop guidelines for virtual meets and send to committee for feedback. These virtual guidelines will be included in the Return to Interscholastic Athletics document with the current Indoor Track guidelines. Joe reminded us that NYSPHSAA Hall of Fame nominations are due by January 29.

Kristin Frazer asked about # of meets needed to qualify for State meet. **Dr. Zayas** clarified there can be a reduction in the number of meets needed for championship competition. It needs to be requested to your section. He also said if there are fewer than six sections competing in the State meet, the meet will be a Regional. Robert also noted officials statewide will be reminded that having masks on an athlete's arm is not jewelry. They will also be reminded that their job is not to enforce social distancing.

Kristin Frazer asked about using times from an outdoor track this winter season. Rules states you can only use indoor tracks, not oversized track. **Dr. Zayas** said it would be considered this year with COVID. With regards to who decides on when track starts, State Officials decide if low risk sports are authorized and sections/NYSPHSAA decide on start dates. He also noted distance events were considered low risk.

Todd Nelson announced the State meet program will be digital (online) this year. Oscar reminded him that this is the 50th anniversary of the boys' championship.

Chris Joyce spoke briefly on sponsorship. He noted Joe deGuzman will start working in the NYSPHSAA office on behalf of TPG selling sponsorship.

Chris Watson reminded people that anything going out from NYSPHSAA should come from him, then goes the membership, then the media.

Lou Vasquez and Lauren Primerano shared an update on Ocean Breeze Athletic Complex (OBAC). Their goal is to have something at the end of the season, an event that is safe for everybody. OBAC is now open for practices. They have special air filters, one direction athlete movement, and special sprayers to sanitize quickly after every meet/practice. **Todd Nelson,** on listening to the Section V meeting earlier in the day, asked Lou and Lauren what was the capacity of OBAC. The reply, following state guidelines, New York City Park guidelines, and New York City Lawyers, was 50%. Lou and Lauren confirmed NJ is cancelled and we can use OBAC on Sunday if we need to make States two days.

Dave Hennessey discussed new standards provided via email before the meeting. It was unanimously agreed to keep old standards for the 2020-21 season and discuss after the season. **Joe Altieri** reminded the group if you want a change for 2021-22 season you must present a proposal to Executive Committee by July for discussion, then again to that committee in October for a vote.

The pregame/postgame handshake was eliminated. The officials met at the center circle with 1 coach and 1 captain from each team. ALL Players/Coaches as well as spectators were required to wear a facial mask during the contest and non participants and fans were asked to social distance. There was a mask/water break 20 min into the game as well as 20 min into the 2nd half.

Problems encountered/concerns

- 1. If a point of emphasis on the sport of soccer is sportsmanship then there should be a system in place to track Yellow cards. Officials are only expected to report Red cards and coaches are expected to report the yellows/reds on the boys soccer website sectionalsports.com but this is only done on a honesty system.
- 2. Supervision was critical this year as schools provided this at all home games. Most schools adopted the 2 pass per player rules to maintain NYS guidelines or large group gatherings. This

- policy carried through sectional play as well. Item #3 Tie Breaker was not supported
- 3. Would like to propose an additional tie breaker before the flip of the coin. Add in a goal differential between the 2 teams that are tied for the coin flip. Never heard if this was discussed or approved. This rule was proposed 2 years and once again I was never notified if it was approved or denied.
- 4. To qualify for sectional play teams had to have a .500 record or better in league play. ALL sectional games were played at the higher seed and MOST games were played at a set time and day. Tues 11/10 = Quarters 5:00 PM Thurs 11/12 = Semi's 5:00 PM Sat = Finals 1:30 PM. This worked out well as 6 classes were celebrated with a sectional champion and very little issues.

Recommendations for next season & proposed dates

The same format will be used in regards to neutral sites for semis and finals. The dates/sites/times will be similar to 2 years ago with the input of Mark Difilippo and Chris Durr.

Team Sectionals

Day 1 - Saturday September 25th: (21 Teams for Division 1 and 19 Teams for Division 2) Consists of 7 pods of 3 teams each (Division 2 will have 2 pods with only 2 teams in it).

The 3 team pod will be determined by the Section VI committee based on; team record up until Sept. 18th, BEDS, perceived strength according to chairpersons, and may consist of UTR, past performances, or other information available at that time. The goal is to have a fair and equitable tournament for all teams.

Once a site is determined (Division 1 must be at a site with 8 courts), a schedule of time will be made available. The 3 teams in the pod will play an 8 game pro set against each other in a round robin format to determine the 1 team from that pod that will advance to the quarter finals. Division 1 will play 3 singles/4 doubles, and Division 2 will use 3 singles/2 doubles. The team that advances will have beaten

both other teams head to head. Should there happen to be a tie, we will follow the USTA 2020 league tiebreak rules. The tiebreaker will be:

- 1. Most total individual match wins
- 2. Fewest number of games lost
- 3. Winner of head-to-head matches
- 4. Coin toss

Day 2 - Tuesday September 28th: *Quarterfinals* (7 Teams for both Division 1 and Division 2) The top seeded team (committee decides based on above criteria) will earn a bye for the quarterfinal round. The other 3 matches will play head to head at the higher seeded team on Tuesday, September 28th. This will be a regular scoring, best 2 out of 3 set match using the format listed above.

Day 3 - Saturday October 2nd: <u>Semi and Finals</u> (4 Teams for both leading to 1 champion for each division).

A neutral site will be determined for both Division 1 and Division 2. A location with 8 courts is a must. Once a site is determined, a schedule of time will be made available. Both semifinals matches will be played followed by the Section Championship match. Format will be 2 out of 3 sets, regular scoring. Division 1 will use 3 singles/4 doubles and Division 2 will use 3 singles/2 doubles. The winners of both divisions will advance to the Regional Finals on October 23rd.

In case of rain, we will use the next available day to get the matches in. In some cases, we may need to use a Sunday, or more sites/multiple days.

SECTION VI POST- SEASON REPORT Girls Swim 2020

Chairperson: Doug Cassidy
December 2020

Due to Covid protocols adopted by the Section 6 Council and the NYSPHSAA, there were no Class, Sectional or State Championships held for girls swimming this fall.

Report on changes in Policy or Practice that were implemented

The Fall 2020 Season was, to say the least, a challenging one for us all. While waiting for guidance from the State, our Section 6 Girls swim committee met virtually to develop A, B, C, etc. plans for running the season and possible championships. As mentioned above, the decisions made by the Governor, NYSPHSAA and the Section 6 Council, determined the guidelines and protocols through which we would navigate these strange sets of circumstances:

- 1. The Niagara Frontier League (NFL) opted out of the fall season in lieu "Fall 2" in the spring.
- 2. The Erie County Interscholastic Conference (ECIC) competed both in person and virtually throughout the season and held a hybrid in-person/virtual championship successfully.
- 3. The Chautauqua Cattaraugus Athletic Conference (CCAA) held in-person and virtual dual meets and held a successful in-person series of championships at Olean Middle School.
- 4. The National Federation established a framework for virtual meets which the NYSPHSAA modified and approved for use throughout the State for managing dual meets without travel or in person competition.
- 5. Webex on-line meetings were held in late August with coaches from each League, to discuss the limitations and possibilities for the season. Subsequently, the NFL directors decided to opt out of the fall season for girls' swim.
- 6. The League chairs for the ECIC and CCAA did a phenomenal job under the most difficult of circumstances of provided assistance and guidance for their member schools. Additionally, both Timm Slade and Mark DiFilippo were instrumental in providing guidance to me and the leagues. The two Officiating Associations for the CCAA and the ECIC did a commendable job of adapting to both the in-person and virtual environments for competition.
- 7. Within the ECIC and CCAA, there were several schools that opted for all-virtual competition, or out of the fall season altogether.
- 8. The Section 6 coaches decided through our Webex meetings to move our on-line reporting service from Section6swim.com to Swim Cloud. Our Committee's tech specialist, Paul Cary from Clarence, served as liaison with Swim Cloud and was our most critical resource in maintaining rosters, meet results and the virtual Championship.

Problems encountered/ concerns

"Virtually" all of our problems came from managing Covid protocols. The patience however of our directors, coaches, athletes, parents and officials helped us work through the many challenges faced throughout the shortened season. Many of the schools were able to stream competition on-line in lieu of allowing spectators which were prohibited by the ECIC and severely limited by the CCAA.

Recommendations for next season & proposed dates/sites

In hopes that by the late summer/early fall of 2021 that a more normalized plan for Interscholastic competition can be resumed, our Swim Committee is highlighting some recommendations made for 2020 before the pandemic upset the applecart:

We recommend that we continue the 2019 format for championships- a prelim/final format for Class Championships and a timed final format for the Sectional/State Qualifier *with modifications*. The Swim Committee will meet in the spring to discuss operational changes based upon our experiences and feedback from 2019.

All teams should continue be required to register and utilize the Swim Cloud website which garnered high praise for efficiency and usefulness. It is also recommended that as our liaison Paul Cary receive a stipend as our technical resource for both girls and boys swimming.

At the State Swim Committee meeting in the spring, bids will be reviewed for the State Championship venue for the next three years. (2022-2024). Section 5 (Rochester) has submitted a bid which I believe Section 6 should support. In addition to the confidence I have in the ability of Section 5 to run a superb meet, the travel, lodging and incidental costs to Section 6 would be lower than either an Ithaca or Long Island venue.





The Section VI Working Group

Working Group made steps towards obtaining the 4 sites to be deemed "girls wrestling" sites with host schools and coaches. Established "back-up/alternate" sites, pending Superintendent and BOE approval at each site.

Each of our 4 sites are planning to run an "All Girls" practice 2 times each week.

Other school districts and coaches have been in touch with our committee and have shown interest in helping to build the WNY Women's Wrestling base but we have not had the opportunity to speak with, and move forward administratively, for anything to be more finite or concrete.

4 host school districts (Pre-Covid)

<u>Chautauqua County area</u> - Chautauqua Lake School District - Contact - Superintendent Josh Liddell and Coach Brad Rowe (Falconer w/Coach Drew Wilcox and Fredonia have offered to be alternate sites)

<u>Cattaraugus County area</u> - Salamanca School District - Contact - Athletic Director Rich Morton and Coach Keith Wilson (Gowanda w/ Coach Ray Logan has offered to be an alternate site)

<u>Erie County area</u> - Cheektowaga Central School - Contact - Athletic Director Brian Hickson and Coach Matt Haberl (Athletic Director from Williamsville North, Julie Arnold has been contacted and is a "possible" option for a alternate Erie County site)

Niagara County and Orleans County areas - Contacts Niagara Wheatfield Coach Bill Ploetz and Lewiston-Porter Coach Bill Edwards

Pre-Covid (Post-Covid) Plan

Tri-meets on a rotating basis at host schools to take place Monday throughout the season.

- -Monday was picked so that the girls could still compete in their home school's line-up and not have to make a decision to separate themselves from their home school.
- Allows coaches and teammates from home schools to be in attendance to support their fellow wrestlers.
- Competition would be set up so each wrestler would get a minimum of one match, and maximum of two each event night.
 - Important to note that the point limit in accordance NYSPHSAA must be followed

As per NYSPHSAA Assistant Director Todd Nelson: School Districts would either have to place the names of the designated "Girls Coaches" in charge of running practices on to the list sent to their respective BOE for approval OR they would have to supply a State Certified and Board approved coach from their school to accompany any girl attending any of these practices.

Tournaments

2019 First ever "Sanctioned" Sectional tournament, hosted by Section 6. Made possible because of Executive Director Timm Slade and tournament host, Niagara County Community College.

2020 tournament was hosted by Section 5 thanks to Executive Director Kathy Hoyt and Tournament Director Chris Bourne.

- Tournament ran at the SERC Center at SUNY Brockport alongside the Section V Boys State Qualifier. This was a great opportunity for girls to wrestle in front of a large crowd, thanks to the efforts of Section 6 Wrestling Women's Wrestling Director Alex Conti and Section 5 Boys Wrestling Director Bill Hadsell.

Tournament Strategy (Post-Covid)

Add girls divisions at existing tournaments and create a few all girls opportunities

Three definite All Girls Tournaments had been set for the 20-21 season.

- Two were an extension of existing wrestling tournaments: the Linda Knuutila Memorial tournament run by NCCC in Sanborn and the Patrick Morales Memorial Tournament run by Falconer HS.

Chautauqua Lake Central School and Superintendent Josh Liddell committed to hosting a "stand alone" girls tournament for ALL girls not only in WNY, but including all eligible girls around the state and adjoining states.

Planning had started for interested sections to designate girls for a team to compete at the Boys NYSPHSAA Dual Meet Championships. This would be very similar to crowning a "Sectional" State Championship Golf team and "Sectional" State Championship Cross Country team

Subject: School Health Examinations in Light of COVID-19 Pandemic

In the May 21, 2020 New York State Education Department memo School Health Examinations in Light of COVID-19 Pandemic, the Department asked schools to continue to accept any physical examination form from students for physicals conducted on or before January 30, 2021, regardless of the form used; allowed parents/guardians additional time to obtain a health exam for school attendance, and allowed students to participate in fall interscholastic athletics if they met the requirements in the memo. In light of the current status of the COVID-19 pandemic, the Department is again extending the requirements for a health exam for school attendance and participation in interscholastic athletics. Schools should:

- Allow additional time for parents/guardians to obtain a health examination from a private healthcare provider before scheduling an appraisal with the director of school health services (medical director) if private healthcare providers are unavailable due to the COVID crisis. We encourage schools not to schedule grade level health appraisals with their medical director until April 2021, although that may change depending on the status of the COVID-19 pandemic in the spring; and
- Permit student athletes to participate in the 2020-2021 sports seasons if they have previously had a health examination for school attendance in the 2018-2019 or 2019-2020 school years and provide a current health history completed and signed by their parent/guardian within 30 days of the start of the season, unless a current health examination is deemed necessary by the school district's director of school health services (medical director). Schools should use the revised Interval Health History for Athletics form which includes questions on COVID-19. The Department will provide updated information as needed.

Please note - Beginning January 31, 2021 physical examinations for school are to be documented on the NYS Required Health Examination Form or an electronic health record equivalent form. The Instructions for Completion of New York State School Health Examination Form provides direction to healthcare providers on the details of the required components and the required presentation order of those components for an electronic health record form to be an equivalent form. Both of these documents are available on NYSED's School Health Services Webpage.
