- 5.1 NYSPHSAA offered to present L.Mott's Hazing Awareness and Prevention Program to help guide districts through the process of developing a hazing policy. Districts interested should contact L.Mott at 866-598-2816. It was noted that anyone who has received the NYSPHSAA CTA training is qualified to present the workshop. ECIC will conduct this workshop on October 6.
- 5.2 NYSPHSAA has recently approved the development of a Task Force to study and make recommendations for a competitive adapted athletic program.
