Action taken since the last Executive Committee meeting June 17, 2009:

- The request for an early start date (August 18) for girls golf due to competition with Section 5 on August 27 was approved by email 7/9/09.
- Mike Venditti, Williamsville East, was appointed interim Girls Tennis Chairperson by President Wendt on 7/20/09.
- The request for an early start date for Allegany-Limestone Girls Varsity soccer (August 21) to participate in a tournament at Cohocton on September 3 (instead of the 4th) was approved by email 8/11/09.
- The request for Hinsdale to combine with Ellicottville for football was approved by email 8/20/09

- 1.1 Timm Slade was present for an informal conversation with the Executive Committee. Members had the opportunity to question Mr. Slade regarding his thoughts on a variety of issues. Diane Munro and her Hiring Committee were thanked for their efforts and hard work. The committee did an excellent job.
- 1.2 <u>Recommendation for the Athletic Council</u>: Motion to recommend to the Athletic Council that Timm Slade be hired as the Section VI Executive Director at a salary of \$90,000 per year plus benefits and that upon approval by the Athletic Council, Mr. Slade's appointment will be recommended to the BOCES Board of Education CARRIED Rabey/Bullis
- 1.3 <u>Timeline</u>: Because the BOCES BOE meets September 10, it was agreed that an emergency meeting of the Athletic Council be held on <u>September 9 at Erie 1 BOCES at 11:30 am</u>. Athletic Council members will be asked to RSVP regarding attendance at the emergency meeting to guarantee a quorum. If the BOCES BOE approves Mr. Slade for the position on Sept. 10, a starting date will be determined.
- 1.4 <u>Transition plan for the Section office</u>: B.Dinse and D.Munro will work with the new Executive Director on the transition plan:
 - a) Financial L.Ratajczak: The Executive Director and Account Clerk positions were budgeted from July 1 but this money was not expended. The net balance in the budget on October 1 will be approximately \$20,000, sufficient to pay the current Executive Secretary, Treasurer and Officials Coordinator through a transition period. President Wendt charged R.Dinse with the task of preparing a written transition plan for the Athletic Council on Sept. 16 detailing the following for each position (Executive Secretary, Treasurer, Officials Coordinator) where applicable:
 - Start and end dates
 - > An hourly rate and maximum number of hours that the net balance will allow for each position
 - > A tentative schedule indicating how the transition hours will be utilized.
 - b) Logistics B.Dinse:
 - The tasks and responsibilities of the office personnel who are leaving will be reviewed by B.Dinse with the new Executive Director, including what needs to be accomplished in the fall (transition) season, and recommendations to ensure that all tasks are accomplished
 - The tasks and responsibilities of remaining staff (Asst. Exec. Sect., Admin. Clerk), will also be reviewed by B.Dinse with the new Executive Director, including the hiring details of an Account Clerk (i.e.: FT or PT, start date, additional tasks, etc.)
