Re: 3-man officiating in Sectional Semi-Finals and Finals

The Girls Soccer Committee would like to propose using **a 3-man officiating system for Sectional Semi-Finals and Finals. APPROVED Athletic Council meeting January 16, 2008 item 9.10.2** Benefits include:

- Better overall coverage of the game.
- Better angles for seeing fouls and off sides.
- No need for an alternate official.

The increase in costs would certainly be absorbed into the increased revenue that we have generated over the last two years

Note: The Boys have been using this system for the past 5 years on their Semis and Finals, and it has been well received by both coaches and officials.

There are currently 3 sections in the state using this system, and 4 more are exploring the option for next year. The State Soccer Committee will be discussing the 3-man system at our January meeting. There is a strong possibility that the 3-man system would be used for Regionals and States in the near future.
