Central Committee Report - Items For Section Discussion continued:

3) Extending the proposal of game reductions for the 2011-2012 school year. (Possible vote at the December NYSPHSAA Exec. Committee Meeting). The following were noted:

- The reduction of contests has helped prevent cuts in modified programs
- Under the current economic crisis in NYS, reduction of state revenues to districts will continue. Superintendent reps are asked to communicate concerns to their constituents regarding the 2% tax cap as a serious threat to athletics. Feedback is requested.
- The method of reducing costs should be more equitable across all sports. A pro-active alternative to better serve athletes (presented by G.Kaszubski and M.DiFilippo previously) will be distributed to the leagues and Section 5 for review and recommendation. The final proposal will be shared with N. Van Erk at the NYSPHSAA.
- Leagues are asked to collect data from districts on savings realized with the current reduction.
- November AC meeting → District savings will be reviewed and league opinions on the pro-active alternative will be discussed. League reps should be prepared to vote to give direction to our Central Committee reps at the Dec. State Executive Committee meeting.

4) 5th year of athletic eligibility for students with disabilities: On 7/27/10, the Board of Regents passed as an emergency amendment a rule that allows students with disabilities to have a 5th year of eligibility and eliminate the Age 19 rule when meeting certain participation requirements. NYSPHSAA does not support this change. The Board of Regents will be meeting in October at which time there will be an opportunity to voice opinions. Letters have been sent to Regent Bennett. A meeting is being planned by T. Slade with Regent Bennett.


