The transactions 9/17/10-10/14/10 and the financial report were reviewed. All bills received have been paid. District checks for participation in Indoor Track, Boys Ice Hockey and Girls Hockey are being received. It was noted that MJR continues to make their \$50/month payment to Section VI through our attorney Hodgson-Russ. Their balance is \$2183.

- 7.0 Old Business updates:
  - 7.1 Football- Loss of Class D programs and disparity within the class T.Slade will meet with the Football Chairs and the ADs, coaches and District representatives of the Class D football schools following the 2010 season to discuss the matter for 2011. He requested direction from the Executive Committee for this proactive meeting.

- 7.2 BOCES Communications Services Proposal for the Section VI website: T.Slade met with the manager of the Section 5 website. Brackets, standings, etc. are posted for a number of sports but much of the work is done by volunteers. Section 6 girls soccer uses this service at a cost of \$20 per team. T.Slade will investigate the possibility of obtaining the service for multiple sports at a reduced cost.
- 7.3 5<sup>th</sup> year of athletic eligibility for students with disabilities: T.Slade will inform all when a meeting with Regent Bennett has been confirmed.
- 7.4 Extending the proposal of game reductions for the 2011-2012 school year (action item at the November meeting):
  - a. Pro-active alternative (G.Kaszubski and M.DiFilippo)- A draft of this proposal has been received. When the final version is ready it will be forwarded to the Executive Committee. If the committee approves, it will be sent to N. Van Erk and the Executive Directors of the other sections. It was recommended that the Boys and Girls Reps from each of the Sections also receive it for their review and suggestions
  - b. Leagues were asked to collect data from districts on savings realized with the current reduction
- 7.5 The Boys Ice Hockey Federation bylaws will be voted on by the Federation in January for implementation in the 2010-11 school year. When approved they will be forwarded to the Section for review.
- 7.6 Girls Ice Hockey Federation bylaws: T. Slade will contact J. Rusin regarding the status.
- 7.7 Evaluation and Incentive Program for the Executive Director position: There has been much discussion on the draft of this program that was presented at the September AC meeting. It was agreed that Section VI will not pursue an incentive program. The President will notify the Athletic Council members of the new direction with regards to goals and evaluation.
- 8.0 New Business:
  - 8.1 Linespeople: It was noted that the Southern Tier assigner was unaware of the AC approval of the use of certified officials as linespeople for all levels of <u>sectional</u> boys and girls volleyball contests. Timm Slade will contact T.Shields
