1.0/2.0 Call to order/Introductions: The meeting was called to order at 12:15 by President Munro. There were no guests present. dmunro@alli.wnyric.org

- 3.0 The minutes of the Executive Committee meeting on November 17, 2010 were approved.
- 4.0 Executive Director's Report T.Slade <u>tslade@e1b.org</u>
 - 4.1 Officials Coordination
 - a) Ejection Appeal: Concern was expressed regarding two instances where the officials organization overturned the call of an ejection of an athlete from a contest. It was recommended that for consistency a policy and procedure be developed that involves the Section in the process of overturning an ejection. The Executive Director should make the final decision. There must be compelling evidence to support overturning the ejection. This issue will be on the Jan. 6 agenda for discussion by the Sectional Intersectional Committee.
 - b) Central Management/Assigning of Officials:
 - lce hockey officials assigned contests up to 12/15/10 have set up their RefPay accounts, a requirement for payment by the Section. The first payment, anticipated for 12/15/10, will be made when the financial reports are received from the Federation Treasurer and verification of the officials who worked is completed. Officials assigned to non-league games are paid by the home schools and will need to be handled differently in arbitersports to avoid double payment.
 - Assignment of officials for fall sectional contests was completed successfully in arbitersports. The same is planned for winter and spring sports.
 - 4.2 Motion to approve participation for Robert Snyder, a Depew resident, in sports at the shared services school district where he attends (Cheektowaga) CARRIED Wendt/Bullis. The request for participation at Cheektowaga Central was included in his IEP. In addition, it was noted that the student never attended school in Depew.
 - 4.3 2009-10 Violations of NYSPHSAA rules:
 - a) Grover Cleveland: Buffalo has self-reported that 2 ineligible students participated on the 2009 Grover boys soccer team. The district took appropriate action against the coach and will relinquish the titles won. T.Slade will retrieve the sectional and regional plaques. The regional plaque will be given to Section 5.
 - b) Clarence: The boys swim coach conducted an Iron Man contest in which his athletes competed in more than the maximum number of events. The team's title was forfeited.

T.Slade and D.Munro met with Athletic Directors regarding an alternative plan to the current reduction of contests for cost reduction. Although several good ideas were discussed, an alternative proposal was not developed for presentation at the State meeting. It was noted that Section 4 brought forth an alternative plan at the State Executive Committee Dec. 5-6, but it did not get to the floor for discussion. In summary, the following two action items will be on the Central Committee agenda for the conference call meeting on December 21, 2010:

- Fiscal Concerns: Extend the Fiscal Concerns Items (numbers 1-7) for a period of one year (2011-2012) with one exception. Item 6 will be changed to reinstate the original Executive Committee meeting schedule to October, January and May. The January meeting will be held by conference call.
- > State Dues 2011-2012: A dues increase of \$30.00 per district and \$.03 per student for the 2011-2012 school year.

The voting members of the Athletic Council were emailed with a request to secure league input and submit their votes by email to the Executive Director T.Slade on both items no later than Friday December 17 at 4pm. The votes will be tallied. Section VI Central Committee representatives will be charged to vote as indicated by the results when the NYSPHSAA Central Committee convenes via teleconference on December 21. Section VI AC members will be notified of the results of the Central Committee vote by December 22.

7.1 Football- Loss of Class D programs and disparity within the class: T.Slade tslade@e1b.org
Football Chairman K.Stoldt has developed a proposal that may resolve the concerns. It will be discussed with the Class D schools at a future meeting and by the Sectional Intersectional committee on Jan. 6. The 2011 football alignment will be submitted for approval at the Athletic Council meeting in January.
