- 4.1 Officials Coordination:

  a) Approve the requirement that 18 schools are needed to split a division. Sportchairs will be
  - reminded that they can appeal to the Athletic Council for a split division if they feel it is justified.
    b) Approve the policy to not allow changes to the seeds after the conclusion of the seeding meeting.
  - c) Approve the following change to the Constitution: Item 13.3 Schools must compete within their sectional classification numbers for all sports except Ice Hockey. In the sport of Ice Hockey, teams may move up from the small school division to the large school division for the 2010-11 and/or the 2011-12 schools years. After these two years, the Ice Hockey exemption will be reevaluated.
  - d) Approve the Wrestling proposal for a new format with 5 sectionals tournaments: Class AA, Class A and 3 small school tournaments. Sites will be carefully reviewed. It was noted that all teams in the Federation must abide by Section VI rules regarding maximum number of contests (20) and no team practices before the start of the season (Nov.1).
  - b) Approve the Boys Swimming proposal for 3 class championships and a separate state qualifier meet. Venues will be carefully reviewed for costs.
  - c) Approve the elimination of linespeople for both boys and girls volleyball during the regular season for 2010-11. This request must be approved annually.
