## 1.0 Sports concerns:

1.1 Bowling: Dan Kaplan, John Seeley

The proposed changes for sectional competition were reviewed.

- 1.2 Girls Basketball: Leo Kaminsky
  - a) Section 5 has been contacted regarding a split-officials crew for Regionals. This will need approval at the Athletic Council if Section 5 agrees.
  - b) Approval is requested for16-minute halves in varsity non-league contests upon mutual agreement of both schools in 2009-10.
  - c) Inquiry: Can girls basketball elect not to subdivide a class if boys basketball has subdivided? It was agreed that subdividing Class A and B should remain as is for girls basketball.
  - d) It was agreed that Depew HS was not appropriate for the A finals. Lockport HS was recommended. This will be pursued by the Girls Basketball Chairman.

- 1.3 Boys Soccer: The chairman and committee would like to have all leagues nominate a player of the year, coach of the year and referee of the year. A committee will decide/vote on a Section VI POY, ROY and COY. It was agreed that although the Section supports the concept, the Section cannot fund it and should not be involved. These awards should be handled at the league level.
- 1.4 Boys Lacrosse: North Tonawanda and Jamestown have requested to play in a different classification. More information is needed. This item was tabled until the next meeting in January. The Sportchair will be asked to attend for clarification.

- 2.1 Seeding: Should there be a cut-off date for allowing changes to the seeding? The option of a sign-off on the forms used to submit power points at the seeding meeting was discussed. This was referred for consideration and review by the new Executive Director.
