- 1.0 Splitting classes for sectional competition
 - 1.1 A policy is needed for consistency in making the decision to split classes. Concerns discussed:
 - a) Past practice has been to allow a split in a class if there are 30 teams or more. Is 30 no longer appropriate? Should the # be sport specific?
 - b) Philosophy: Do smaller classes "water down" the competition? Or is good for the sport with equitable distribution of competition across the classes?
 - c) With costs to run additional tournaments, is the revenue sufficient to make a net profit?

Recommendation: Approve the requirement that 18 schools are needed to split a division.

- 1.2 Current requests awaiting decision: Field Hockey-Judy Otto: Splitting B into B1 & B2 and Boys Soccer-Todd Marquardt: Splitting A into A1 & A2 and splitting B into B1 & B2
- 2.0 Seeding: Should there be a cut-off date for allowing changes to the seeding? Possible option of a sign-off on the forms used to submit power points at the seeding meeting?
 Leagues are responsible for supplying the Section with a representative/chairperson to all sport committees. It is the representative's responsibility to bring accurate power rating sheets for all teams in his/her league with two signatures (Coach/Athletic Director) to the seeding meeting.

Recommendation: Approve the policy to not allow changes to the seeds after the conclusion of the seeding meeting. Approved Athletic Council May 19, 2010.

- 3.0 <u>Classification</u>: Schools can move up to a higher classification for sectional competition but must remain at that classification through states (Section VI Constitution 13.3).Concerns addressed:
 - Should we have a section wide policy for all sports?
 - Should it be sport specific?
 - Should there be a process to apply to move up?

A Constitutional change is required for the recommendation below:

Recommendation: Approve a post card ballot for the following change to the Constitution: Item 13.3 "Schools must compete within their sectional classification numbers for all sports except Ice Hockey. In the sport of Ice Hockey, teams may move up from the small school division to the large school division for the 2010-11 and/or the 2011-12 schools years. After those two years, the Ice Hockey exemption will be re-evaluated. Approved Athletic Council May 19, 2010.
