The representative members on each sport committee will be appointed by each league and have only one vote per league. Other non-voting members may be selected by the Sport Chairperson.

Federated sport representative members that are appointed by their division, league or school will have only one vote. The Sport Chairs of Federated Sports that have divisions will verify that among division representatives each participating league is represented.

The Sport Chair may only vote when the vote is tied. A Sport Chair who also represents a league can serve in both capacities but will have only one vote.

5. Article 9 – Central Committee Representatives (p.14)

9.1 Elected members must be from two of the three regions and ideally in sequential rotation. Additionally, rotation between leagues should be on an alternating term basis. <u>Discussion</u>: What happens if an incumbent wants to run for a second term?

After those two years, the Ice Hockey exemption will be re-evaluated.

Policies

620 Subsequent Arrest of Sports Officials - Policy and Procedures Summary of the changes (which are noted in red in the Policy Manual):

- a) The arrest will be processed only if the official is active in the assigning program arbitersports.
- b) The arrested official is required to present a copy of the arrest/police report regarding the arrest to the Executive Director.
- c) The Executive Director can determine if the charge affects the official's duties or forward the information on to the Section attorney to make that determination.
- 950.3 The Fund Balance will be divided into a 3 separate Reserve Accounts designated specifically for:
 - a) Sports (65% of the projected expenses for Sports)
 - b) Office expenditures (an amount capped at \$50,000)
 - c) Special Use: This account will include funds for one-time special expenditures approved by the Athletic Council.

The balance remaining after designated reserves have been set aside will be placed into a *Benefits to District Athletics Account* for items such as reimbursement for state travel, sports programs enhancements, or other uses as recommended by the Finance Committee and approved by the Athletic Council. The Benefits Account, when used as a reimbursement, will be distributed to districts at a rate of 1/3 per year.
