SUBJECT: Lackawanna Boys Soccer 2008 Final Report

I have reviewed all of the game reports filed by the three person Sportsmanship Council charged with evaluating the 2008 Lackawanna Boys Soccer program. I am very pleased to report that the team, under the leadership of Mr. Jacob Minniefield, Athletic Director and Tom Kacalski, Head Coach has made exceptional progress in developing a credible sportsmanship improvement program during 2008 Season.

I have enclosed* a blank copy of the basic game report filed for each contest. Several comments / observations posted by the council include:

- o During the eleven game season the team was issued two yellow cards. Observers felt both to be very minor in nature.
- The requirement to provide administrative support at every contest was fulfilled. In many cases security support was also afforded.
- The newly appointed coaching staff was supportive of the council's efforts and often reflected many of the positive characteristics deemed to be goals for this program.
- General comments found on game report:
 - > "Enthusiastic home spectators, no problems"
 - > "Plenty of supervision present, potentially rowdy spectators well controlled."
 - > (9/15/08) "Game was very competitive with both teams demonstrating good sportsmanship."
 - > "Student athletes' behavior and conduct was exemplary."
 - > "I felt the coach did a good job, the players responded well to his leadership."

A special "thank you" will be forwarded to the members of the sportsmanship review council for their diligence in this matter: Reports were thorough and timely. As a result I have authorized payment to each council member for services rendered. As chairperson of the council I would also recommend that
