#### 2012-2013 Classification Numbers. Assistant Director Todd Nelson

A motion to approve the 2012-2013 classification numbers as presented carried.

Harrica/McGuire

- Todd reported the cut-off numbers will remain the same for the 2012-2013 school year.
- He reviewed the cut-off numbers for the 5 class, 3 class and 2 division sports and found
  a slight discrepancy between Class AA and A and Class C and D. Class AA represented
  17.4% of our member schools, Class A represented 17.9% of our member schools and
  Class C & D represented 22% of our member schools. Class B was right on target with
  20.5%. Compared to last year's numbers, there is a trend towards a widening gap
  between the top and bottom of our classes.
- He will make a recommendation for a change in the cut-off numbers for the 2013-2014 school year at the May Executive Committee which will balance the classes to be in the 20% range.
- He will review the variation cut-off numbers with the Sport Coordinators. Any recommendations for changes for the 2013-2014 school year will be brought to the May Executive Committee meeting.
