- Budget & Finance Committee: The committee is recommending the elimination of Championship Entry Fees for all NYSPHSAA individual state tournaments.
 APPROVED. The committee recommends increasing NYSPHSAA dues for the 2009-2010 school year by \$50.00 per school and 5 cents per student over 300.
 APPROVED
- Championship Advisory Committee: Nina presented thoughts and concerns pertaining to the following:
 - (A) Basketball: the need to assign three officials for State Semi-finals and Finals, both Boys and Girls looking to bring this item to both State Committees.
 - (B) Wrestling: Regional proposal.
 - (C) Baseball The committee is considering requesting a two day tournament format.

Action Items

- Wrestling The committee is seeking approval for a wrestler to compete twice in a regular dual meet under specific situations pertaining to forfeits and exhibition matches. **Approved**
- Track & Field recommend approval for a two year experiment beginning in the 2009 season to adjust the qualifying standards in Division I and II. The divisions would have separate At large entries setting the qualifying standards higher in Division I and lower in Division II. The standards would be determined by the average of the 6th place finisher in each Division from the last three years. Approved by 1 vote!
- Boys Soccer the committee is requesting: Regular season overtime procedure will be two 10 minute sudden victory periods. In regular season tournaments when

teams need to advance there will be two 10 minute sudden victory periods and if still tied penalty kicks will be used to determine advancement. In Sectional and State Tournament games overtimes will consist of two 15 minute sudden victory periods and if still tied penalty kicks. However in the state final championship game Co-Champions will be declared at the end of the two 15 minute periods with no penalty kicks. **Approved by 1 vote!**

- Girls Soccer the committee is requesting: Regular season overtime procedure will be two 10 minute periods (played fully). If still tied, the game will end in a tie. In regular season tournaments when teams need to advance there will be two 10 minute periods (played fully) and if still tied penalty kicks will be used to determine advancement. In Sectional and State Tournament games overtimes will consist of two 10 minute periods (played fully) followed by two 5 minute sudden victory periods. If still tied, penalty kicks will be used to determine the winner. However in the state final championship game Co-Champions will be declared at the end of the two 5 minute periods with no penalty kicks. Approved by 1 vote!
- Girls Volleyball the committee is requesting to be able to begin the Championship Finals on Sunday at 10:00am at Glens Falls. **Approved**
- Boys Lacrosse a change in the classification numbers for the 2009 season to distribute the participating schools into three equal classes. Class A, 1,100+, Class B, 650-1,099, and Class C, 0-649. **Approved**
- Boys & Girls Swimming & Diving: For equity in qualifying for the State Meet, a one year trial is recommended with the 30th place time in the preliminary heat, from the times of last year's State Meet being used for individual events. For relays it would be the 15 place time in the preliminary heat with the average time over the last 4 years. For Diving it would be a score of 396.00. **Approved**
- All awards will be approved and purchased by the Association and have the Association logo. **Approved**
- The association staff will hold joint sport committee meetings in sports that have both Boys & Girls teams in order to address equity issues and report back to the CAC with recommendations/reports by October 2008. **Approved**
