Report on changes in Policy or Practice that were implemented

- 1. This year we fully used the Arbiter and a full time assignor. I believe everything worked very well. I did encounter some difficulties with Officials Board #39. That board has a policy that prohibits any member from working a second game in the same round even though it is a different classification. This issue was addressed by Mr. Slade, however, Board #39 did not heed his recommendations. As a result, officials from other boards were assigned to those games. We are charged with assigning the best available officials to each game and need help in having Board #39 change their policy.
- 2. Girls Basketball did not publish a program booklet for sectionals. The unanimous(5-0) vote at the seeding meeting confirmed that we would publish a simple program that included only rosters, etc. This situation will be addressed with Mr. Slade during the month of May.

Problems encountered/ concerns

- 1. I would recommend that the section adopt the state policy regarding admissions. That policy states, "For purposes of admissions 16 participants and five bench personnel(coaches, statisticians, athletic directors, other school administrators and any other persons associated with the team) will comprise the traveling squad and will be admitted to the tournament. All other participants or bench personnel will be charged admission."The number of extra free admissions has become out of hand.
- 2. A total of 17 teams did not participate in sectionals.

Recommendations for next season

As a committee we plan to meet earlier in the year to address venues. We will be hosting regionals next year and want to secure the best possible venues for our tournament.

Other pertinent data

- 1. A sincere thank you goes out to the following high schools for hosting: Williamsville East, Chautaugua Lake, Jamestown. Lockport, and West Seneca East.
- 2. Media coverage has increased this year.
- 3. I await the state's decision that would change girls basketball rules from the NCAA's to the Federations even though my committee voted (5-0) to maintain the present NCAA rules.

Net revenues increased by 43.9% compared to 2007-2008 when we did not hold regionals.

Report on changes in Policy or Practice that were implemented

- 1. More bowling teams were added to the Sectional Tournament for both the boys and girls based on lane availability.
- 2. Teams were seeded by division on alternating lanes. Division A and Division B teams competed against each other and Division C and Division D teams competed against each other in the morning round of play. Coaches felt this would allow for more competitive play with athletes from schools of similar size. In the afternoon portion of the tournament, teams were seeded by how they finished in the morning regardless of division. Consensus of the coaches at the end of the tournament was to continue with the format in 2011.
- 3. State Tournament directors sent a directive to all sectional chairpersons stating the lane oil pattern that would be used at the State Tournament. This was decided at the March, 2009 Chairpersons meeting in Rochester as a way to have the bowlers better prepared to bowl on conditions not used during the regular season and at sectional team tournaments.

Problems encountered/ concerns

- The bowling committee will evaluate the format used at the 2010 Sectional Tournament at its summer meeting in view of the responses of the coaches to the new format.
- The bowling committee will also discuss the new state ruling that Baker Format may be used only at the Sectional Tournament if the Section committee agrees. It was decided not to use it during the 2010 Sectional Tournament as there was not sufficient time for input from either the coaches or the committee.

Report on changes in Policy or Practice that were implemented:

We're looking into the possibility of hosting the Section VI State Qualifier Championships at RIT in Section V during the 2011 Indoor Season. Further Details will be given to Timm Slade down the road.

<u>Problems encountered/ concerns:</u>

- The Indoor Track & Field Conduct Expectations that all coaches get from the beginning of the season to read to all their athletes will now also be given to all of the Athletic Directors.
- We will need to notify Buffalo State and especially Fredonia State that their cleaning staff will need to empty the garbage cans more often.
- Sound System at Fredonia State wasn't working that well at the State Qualifier Championships. This cannot happen since this is our 'Biggest Meet' of the Year!! I will let Fredonia State know of this situation and have them make sure that they check their system on a regular basis.
- The Finishing Line Officials at the State Qualifier Championships unfortunately made a huge mistake in the Girls 3,000 Meter Run. They missed counted the number of laps, having all girls run one less lap.

Recommendations for next season:

- Jim Zubler from Frontier High School has decided to step down as one of the Indoor Track & Field Committee Members. There is too much on his plate between X-Country, Outdoor and his Summer Program. Hence, Brian Lombardo from Sweet Home was elected as the 'New' representative to take over Jim Zubler's responsibilities. Also, since Jim Zubler was a voting member for the ECIC, Kevin Carriero will now be the 'New' voting member for the ECIC.
- We're looking at adding the Distance Medley Relay & Sprint Medley Relay at Buffalo State
 College for the early part of the season only. This would replace the 4 x 800 and/or 4 x 400
 Meter Relay. We're just trying to make the early part of the season a little bit different.
- As of right now, we are having all girls going off the 8' board in the Long Jump. We have decided that any girl who meets the Sectional Standard in the Long Jump will be allowed to jump off either board (8' or 12' board). This is not an issue for the boys.
- Because of the official's mistake in the Girls 3,000 Meter Run at the State Qualifier
 Championships, we will now institute a Coaches Box on the floor for those teams that have an
 athlete involved in that event for both the 3,000 and 3,200 Meter runs. This will help the officials
 and vice-versa. Note: The Finishing Line Officials would have final say.
- Also, we are going to assign a committee member to help with the officials at the Team and State Qualifier Championships in all Field Events.
- Scoring at the Team Challenge and the Team Championships will now be scored in terms of Large/Small Schools.
